# Mayor Emanuel Starts Street Sweeping Early To Clean Up Chicago's Neighborhoods From Winter Debris

**More Than 40 Sweepers Will Work During Regular Early Morning Hours In Communities Across The City; Regular Sweeping Season To Begin April 1**

Mayor Rahm Emanuel announced to Chicago residents that the City is getting a jump start on street cleaning this year to address the litter and debris that have accumulated along curb lanes, center lanes and viaducts throughout the winter.

"As the snow melts, we are launching an aggressive citywide street sweeping plan to clean our streets of the debris that has accumulated over the winter season," said Mayor Emanuel. "As our residents begin their own spring cleaning at home, our fleet of City sweepers will be working during the early morning hours to clean main streets across the City in an effort to improve neighborhood quality of life for residents in our communities."

The Department of Streets and Sanitation (DSS) began morning street sweeping this week and is done between 4:00 a.m. to 7:00 a.m., Monday through Friday, until March 31. There will be no temporary parking restrictions related to this overnight operation.

DSS is leveraging the existing overnight parking ban, still in effect until April 1, to begin cleaning arterial streets during the early morning hours. On April 1, DSS will begin its regular street sweeping season when both residential and main streets will be regularly swept Citywide.

More than 40 overnight street sweeping crews will work in all 50 wards to address areas in need of immediate cleaning as identified by each ward superintendent.

"Street sweeping is an essential service provided by Streets and Sanitation to ensure all neighborhoods streets are clean," said DSS Commissioner Charles L. Williams. "Street sweepers will focus on arterial routes during the early morning hours for the remainder of March before street sweeping begins on residential and side streets on April 1, 2015."

Throughout the winter months, DSS continues to sweep arterial streets as weather conditions permit. Since December 2014, DSS swept over 5,100 lane miles.

The annual street sweeping season begins Wednesday, April 1, 2015. During this time, temporary parking restrictions are posted the day before a street is scheduled to be swept. Some streets have permanently posted signs that outline days when parking is prohibited for street sweeping. ## March Is Colorectal Cancer Awareness Month

Dr. Henry R. Govekar, colorectal and general surgeon at Community First Medical Center wants to raise awareness of colorectal cancer. This preventable disease is the fourth most common cancer in the USA, and the second leading cause of cancer death among men and women. Colorectal cancer will be diagnosed in approximately 140,000 people this year alone. It will claim up to 56,000 lives. This is a highly preventable disease with appropriate screening and early intervention (i.e. colonoscopy). There are often no symptoms of colorectal cancer. Some people may develop vague abdominal pain or rectal bleeding, but at that point it may be too late. The only way to prevent colorectal cancer is through early screening with a colonoscopy. In fact, a recently published paper in Annals of Internal Medicine on March 5, 2013 found that a colonoscopy can decrease the likelihood of a colorectal cancer diagnosis by 70% in adults.

Most colon cancers start as polyps, which are precursors to cancer. If they are found and removed early, a cancer can be prevented. This also can prevent patients from having to undergo a major surgery to remove part of the colon or rectum.

Colorectal surgeons are experts in the surgical and nonsurgical treatment of colon and rectal issues. They play a pivotal role in the screening, prevention and treatment of colon and rectal disease. Studies have shown that patients treated by colorectal surgeons are more likely to survive colorectal cancer because of their advanced training and the large number of colon and rectal disease surgeries they perform.

### ASCRS Screening Guidelines

The American Society of Colon and Rectal Surgeons (ASCRS), which is dedicated to advancing the treatment of patients with diseases affecting the colon, rectum and anus, supports the following colorectal cancer screening guidelines:

- For people at average risk of getting colorectal cancer, a digital rectal examination and fecal occult blood test, which screens for hidden blood in the stool, are recommended annually beginning at age 50.
- Flexible sigmoidoscopy (a test that allows the physician to look directly at the lining of the lower colon and rectum) is recommended every 5 years at age 50 or older.
- A colonoscopy (a test that allows the physician to look directly at the lining of the entire colon and rectum) every 10 years or a barium enema (x-ray of the colon) every 5 to 10 years are acceptable alternatives.
- People at increased risk for colorectal cancer include those with a personal or family history of colorectal polyps or cancer, those with a personal history of breast, uterine or ovarian cancer, and those with chronic ulcerative colitis or Crohn's disease.
- Increased risk patients may need earlier and more frequent screening depending upon the recommendations of their healthcare provider.

### Prevention Tips

- Dr. Govekar notes that in addition to timely and regular screening for colorectal cancer, people may be able to lower their risk of getting the disease by:
  - Eating plenty of fiber. The recommended amount is 25 to 35 grams of fiber a day. Most people do not obtain this amount from fruits, vegetables and cereal so it is recommended to start a fiber supplement.
  - Eating a low fat diet and including leafy green vegetables.
  - Exercising at least 20 minutes a day, three days a week. This can include climbing steps and walking outside.
  - Limiting excessive alcohol intake and stop smoking.
  - Lastly, screening with a colonoscopy.

# Social Security to Expand Field Office Hours Nationwide

## Budget for Fiscal Year 2015 Allows Agency to Restore Some Service Hours

Social Security announces as a result of Congress' approval of the fiscal year 2015 budget, the agency will expand its hours nationwide and offices will be open to the public for an additional hour on Mondays, Tuesdays, Thursdays and Fridays, effective March 16, 2015. A field office that is usually open from 9:00 a.m. to 3:00 p.m. will remain open until 4:00 p.m. Offices will continue to close to the public at noon every Wednesday so employees have time to complete current work and reduce backlogs.

"This expansion of office hours reaffirms our commitment to providing the people we serve the option of top-notch, face-to-face assistance in field offices even as we work to expand online services for those who prefer that flexibility," said Carolyn W. Colvin, Acting Commissioner of Social Security. "The public expects and deserves world-class customer service and thanks to approved funding, I am pleased we will continue our tradition of exceptional service."

In recent years, Social Security reduced public office hours due to congressional budget cuts, growing backlogs and staffing losses. The agency began recovery in fiscal year 2014 by replacing some field office staffing losses and providing overtime support to process critical work. With the commitment of resources in fiscal year 2015, the agency is able to restore some service hours to the public.

Most Social Security business does not require a visit to a local field office. ## Mayor Emanuel Announces Nearly 125 Additional Miles Of Repaving

### Part of Mayor's Commitment to Repave 300 Miles Annually;

### More than 1,000 Miles Repaved During Mayor Emanuel's First Term in Office

Mayor Rahm Emanuel announced today the City has identified nearly 125 additional miles of streets to be repaved in neighborhoods throughout the City in 2015. The announcement is the next step in the Mayor's new annual standard of repaving at least 300 miles of roads, a significant increase from previous years.

"Every resident in the City of Chicago deserves streets that are paved and passable to get to work, school, or just around their neighborhood, which is why we are setting a new standard of paving at least 300 miles a year going forward," said Mayor Emanuel. "Whether it's paving more miles of roads or upgrading the water and sewer mains beneath them, we are making the essential investments to give our 21st century city a 21st century infrastructure and ensure a good quality of life for every neighborhood in the City of Chicago."

The work announced today is part of a strategy to replace aging water lines, which are on average more than 100 years old, and repave Chicago's streets. The 125 miles includes 90 miles of repaving following the installation of new water mains and 22 miles of repaving following the installation of new sewer mains. The remainder of this por-

tion of repaving work will take place on arterial streets to be conducted by CDOT, or in conjunction with work being completed by People's Gas. In January, Mayor Emanuel announced the City had identified the first 60 miles of streets that would be resurfaced.

At Mayor Emanuel's direction city departments and private utilizes have greatly increased paving efforts. Since 2011 more than 1,000 miles of streets have been repaved - nearly a quarter of Chicago's streets. In 2014 alone, CDOT, the Department of Water Management (DWM), private contractors and utilities combined to repave a record 343 miles of roadway.

To ensure the City is not only increasing repaving, but increasing the effectiveness of that work, the City has improved coordination on infrastructure projects. Mayor Emanuel is demanding better coordination between City agencies and private utilities to ensure newly paved streets aren't being torn up for other work.

To that end, CDOT's Project Coordination Office, City infrastructure departments and utilities have worked together to reduce the amount of project conflicts that would open up a street more than once.

## 2015 Tax Law Changes You Should Know From AGT The Safe Money People

### 1) New Limitations on IRA Rollovers

Starting on January 1st, 2015 you are now limited to one IRA to IRA rollover. This is a limit on what is considered to be "indirect rollovers" or when the owner takes possession of the distribution and then moves it into another IRA. There is some good news though, there still is no limit on trustee to trustee transfers or on Roth IRA to traditional IRA conversions.

### 2) Changes in Health Care Expense Accounts

In 2015 you will no longer be able to carry over your balance in a FSA (Health Flexible Spending Account) and still be eligible to participate in a HSA (Health Savings Account). The annual contribution limit for FSA's & HSA's have also been increased by \$50.

### 3) Changes to Retirement Accounts

#### a) Increased Employer Plan (401k) Contribution Limits

You can contribute up to \$18,000 to your 401(k), 403(b), and most 457 plans. The catch up contribution rate for individuals over 50 has also increased to \$6,500.

### 4) Affordable Care Act penalties increasing

In 2015, under the Affordable Care Act, penalties for not having health insurance are increasing. The penalty in 2015 will increase to \$325 per adult (or 2% of income, whichever is greater).

The second large change is the introduction of the PTC (premium tax credit). This is a refund available to families who get their health coverage through the Health Insurance Marketplace. There are eligibility requirements so check with your tax professional to see if you qualify.

## Door-to-Door Commercial Solicitors in Skokie

The Village allows commercial organizations to apply for door-to-door solicitation permits in Skokie. Approved door-to-door commercial solicitors are generally seeking to obtain potential customers by offering services or goods.

Please note that all commercial solicitors must be registered with the Village of Skokie Police Department and all solicitors must wear the identification badges supplied by the Skokie Police Department at all times during the solicitation period.

Below are some suggestions on how to respond when a commercial solicitor rings your doorbell:

- Don't open the door if you're uncomfortable with a solicitor's visit.
- Don't provide billing or financial information unless you completely understand what the solicitor is offering and you are interested in the offer.
- Do ask for identification and proof of solicitor's permit from the Village of Skokie.
- Do call the Skokie Police Department non-emergency number, 847/982-5900 to confirm the permit or 9-1-1 to report suspicious activity.
- Do request a no-solicitors sticker from the Village Clerk's office to avoid door-to-door solicitor visits by calling 847/933-8203.
- Do call 9-1-1 if a solicitor won't leave after being requested to do so. Solicitors must refrain from soliciting or knocking on doors where "No Solicitors Invited" signs are displayed.

Commercial solicitors cannot visit door-to-door before 9 a.m. or after 7:30 p.m., Monday through Saturday. Solicitation is not allowed at any time on a Sunday or on a state or national holiday.

What is so amazing about the Resurrection of Jesus Christ? The fact that it has occurred! Throughout history both secular and religious scholars have written extensively about Jesus Christ; His life, His death and certainly His Resurrection from death. Interestingly enough, Flavius Josephus, who was a First Century Roman-Jewish Historian and scholar, wrote about Jesus Christ, including His widely testified life after death in the Antiquities of the Jews.

Dr. Thomas Arnold, a 19th Century historian and professor at Oxford University wrote the following in his book, *Christian Life, Its Hopes, Its Fears, and Its Close*, 6th ed. (London: T. Fellowes, 1859), pp. 15-16. "I have been used for many years to study the histories of other times, and to examine and weigh the evidence of those who have written about them, and I know of no one fact in the history of mankind

which is proved by better and fuller evidence of every sort, to the understanding of a fair inquirer, than the great sign which God hath given us that Christ died and rose again from the dead."

For Christians, then, the Resurrection of Jesus Christ is key and central to our faith. Easter Sunday is a reminder to us that the hope of something greater, something eternal is waiting for us. It is a reminder to us that Jesus has forged a path to the Father's house through His defeat over sin, death and the devil. Whoever believes in Him and trusts Him receives the gift of a never-ending inheritance. It is this reality that enables Christians to live in this Easter joy. It encourages us to serve others in our communities, and to reach out with the Love of God to everyone that touches our life.

St. Paul in writing to the Christians at Colossae expressed it this way: "So if you're serious about living this new resurrection life with Christ, act like it. Pursue the things over which Christ presides. Don't shuffle along, eyes to the ground, absorbed with the things right in front of you. Look up, and be alert to what is going on around Christ- that's where the action is. See things from His perspective." (Colossians 3:1-2 The Message Bible)

May the Resurrection of Jesus Christ offer you continued hope for this life and the life that is yet to come!

# Mayor Rahm Emanuel And Metropolitan Planning Council Launch "Great Rivers Chicago"

Mayor Rahm Emanuel and the Metropolitan Planning Council (MPC) today announced "Great Rivers Chicago," an unprecedented effort to create a coordinated long-term vision and plan for economic and community development along Chicago's riverfronts, building on the excitement around the ongoing Chicago Riverwalk expansion, as well as several new neighborhood amenities.

Over the next 15 months, the City of Chicago and MPC, in partnership with Friends of the Chicago River, topical experts and community stakeholders, will lead a plan for the future of Chicago's rivers and riverfronts through a series of rigorous community outreach efforts with residents and business owners. The process, entitled "Great Rivers Chicago," ([www.greatriverschicago.com](http://www.greatriverschicago.com)) will develop a long-term vision and action agenda, exploring all waterways within the city limits—the Calumet, Chicago and Des Plaines Rivers—and asking residents and businesses to think about what they would like to see their riverfronts become and strongly encouraging them to take part in the process.

"Much like Lake Michigan is Chicago's front yard, the Chicago River is our backyard, and should be an asset that people across the city enjoy," said Mayor Emanuel. "With the excitement seen around the Chicago Riverwalk expansion, now is the right time to ask residents how they want to interact with their rivers in all of Chicago's neighborhoods and today's partnership is the first of many steps that will lead to greater use of the river ways by Chicagoans."

Coupled with investment made throughout Chicago's neighborhoods along the river ways, the work will be funded by \$350,000 in grants from the Joyce Foundation, The Chicago Community Trust and ArcelorMittal.

Beyond riverfront appearance, Great Rivers Chicago also will lay out a pathway to improved water quality and balanced usage, from freight access to recreational options to invasive species management. Coupled with riverfront improvements, this vision has the potential to transform Chicago's rivers into a fully integrated network of economic, recreational and community amenities.

"With so many potentially vibrant riverfront neighborhoods, and efforts like Ping Tom Park in Chinatown and the development on Goose Island underway, it's essential to develop a clear vision for community development along our city's rivers," said Terry Mazany, president and CEO of The Chicago Community Trust. "New development along the rivers, as well as improvements to the river itself, are a key to the vibrancy of the city we live in."

MPC's unique regional perspective provides the depth and breadth of expertise to lead this multifaceted effort. The organization has provided hands-on technical assistance in Chicago neighborhoods and suburbs on retail, housing and community development, intermodal freight, stormwater and water supply issues.

"I love every one of Chicago's 28 miles of lakefront," said Josh Ellis, director at MPC and the lead for Great Rivers Chicago. "But we have more than 100 miles of riverfront. Our rivers link our economy, environment and communities, and they have incredible potential for so much more. We've made great progress. Great Rivers Chicago will determine what

comes next."

Mayor Emanuel has appointed a Leadership Commission to spearhead Great Rivers Chicago, in conjunction with MPC.

"As Chicago invests in its riverfront downtown and its many riverside neighborhoods, it's important to remember that our rivers are literally ecosystems that run through people's communities—and that people are part of those ecosystems," said Suzanne Malec-McKenna, executive director of Chicago Wilderness and a member of the Leadership Commission for Great Rivers Chicago. "Chicago Wilderness is excited to be involved in this effort to better connect all Chicago residents with the natural world."

Mayor Emanuel's goal of making the Chicago River the city's next recreational frontier launched in 2011 with the construction of three new boathouses throughout the city as well as a fourth in the Bridgeport neighborhood that is set to be completed by 2016. The City's commitment to investing in increased recreational usage of the river ways is also evident in the recent expansion of Ping Tom Memorial Park that opened along the Chicago River, north of 18th Street at the edge of the Chinatown and South Loop neighborhoods. The park reflects the City's pledge to river development with a \$6 million investment in new parkland, riverwalk, native plantings, topography, new vistas, boat landings and a "disappearing" staircase into the water.

## A Few Of The Pitfalls Of Planning Your Estate With Joint Tenancy

Our office finds a number of people feel that they have covered all their bases when they use joint tenancy as their main estate planning tool. They are aware that if a piece of property or bank account is held in joint tenancy, it avoids probate for the surviving individual after the death of the first individual. This is true, and for some individuals it works without any complications. However, when Joint Tenancy goes awry, it can cause a number of unanticipated problems.

Let's look at an example of a widowed mother, who puts her only asset, her home, into joint tenancy with her only child, a daughter. The daughter is an industrious and trustworthy individual who decided to start a business with a partner who was definitely not as trustworthy as she was. The business partner made a number of bad financial decisions for the business without telling the daughter. The end result was bankruptcy for both partners. To make matters even worse, the daughter's business partner quickly left town and

left her holding the bag. When the court searched the records for the daughter's assets, her mother's house was discovered with her owning one-half of the property in joint tenancy. The judge ordered the sale of the house to use the daughter's one-half share of the house to pay her creditors. What the mother did not realize was that joint tenancy conveyed one-half ownership of the residence, putting it at risk if her daughter had a judgment against her.

A similar scenario can take place when a parent puts bank accounts or property into a joint tenancy situation with a child who later is in a divorce situation. Even "amicable" divorces can get nasty when money is involved, and a soon-to-be-ex spouse claims that the property that is held in joint tenancy with a parent should be part of the settlement.

With more and more individuals living longer lives, the chance of a surviving spouse later having a new relationship increases. Let's say a widowed dad has put all three of his children on the deed to the family residence and feels this is the easiest way to pass on his home to his children when he dies. However, he is still in good health and meets a lovely woman with whom he would like to spend his remaining years. They seem to be a great couple and look forward to beating the ice and snow of a Chicago winter and moving down to Sarasota, Florida. All dad has to do is ask his three children to sign over their rights to the family home so he can sell it and use the money for his new home in warmer climes. What is their reaction to dad's request?? Wait! Not so fast! Maybe his children are truly concerned about his welfare, or maybe they are afraid of losing their share of the property to his new partner. Whatever the reason, they can essentially block any move to Florida by their father.

Why take a risk with joint tenancy when there are better ways to plan your estate?.

## Protect Yourself From Springtime Scams

As springtime blooms, so do new scams. Scammers will be going door-to-door with plans to rip-off the residents. The Better Business Bureau (BBB) advises consumers that now is the time to be on their guard.

"Most of the scams aren't new but because con artists know how to work them they appear year after year," says Steve J. Bernas, president and CEO of the Better Business Bureau serving Chicago and Northern Illinois. "What we want to do is educate consumers on what to look for so they can stay one step ahead."

#### Alarm System Scams

No one wants to have their home burglarized and many homeowners pay substantial sums to have their homes protected by security systems. These scam artists, who are often alarm company sales people, comb neighborhoods looking for signs posted in yards warning that the home has a security system. They knock on the door and tell you the system needs to be upgraded. Once inside they give you the bad news that the system cannot protect you against today's modern theft techniques and offer to "upgrade" your system. In reality, they are disconnecting your service provider and installing a system from their company. If you agree to the "upgrade" and sign their agreement you could be locked into a multi-year contract that can end with a costly penalty if you try to break it.

#### How to protect yourself:

Never allow anyone into your home who claims to be from your alarm company without contacting the company first.

Ask questions if they are reluctant to provide answers - that's a red flag

Don't be frightened by reports from them of an increase of burglaries in your area.

Never sign any agreement where you feel pressured to do so.

Do not sign anything that you have not read thoroughly.

#### Storm Chasers

Spring can bring severe weather leaving behind hail-damaged roofs. Following the storms are fraudsters known as "storm chasers". These scam artists sell themselves as roofing contractors. They go town-to-town, door-to door, taking money for work, under performing or not performing at all, and then

moving on to the next town before the homeowners can get their money back.

Homeowners can lose thousands of dollars in these scams.

The BBB offers these tips before choosing a roofing contractor:

If approached by a contractor, ask for proof of licensing, insurance and bonding.

Try to get at least 3-4 quotes from contractors and insist that payments be made to the company, not an individual.

Resist high-pressure sales tactics such as the "good deal" you'll get only if you hire the contractor on the spot.

Check out the company first with the BBB at [www.bbb.org/chicago](http://www.bbb.org/chicago) and deal only with reputable contractors.

Get a written contract that specifies the price and the work to be done and a time frame. In Illinois, state law requires a written contract with all costs enumerated for home repair or remodeling work over \$1,000.

Prices are often high in the immediate aftermath of a storm. Only buy the services that are necessary to make your home safe and habitable. Wait at least a few days to hire other contractors because the rates are likely to drop.

Pay by credit card, if possible; you may have additional protection if there's a problem. Otherwise, pay by check. Never pay in cash.

Be sure that all promises made are put in writing.

#### Magazine Sales Scams

You open your door to find someone selling subscriptions to magazines. They say it's a great deal but often the prices are as much as three times the regular price. You pay with a check or credit card and then you receive nothing in return.

What to do to avoid being scammed:

Many municipalities require door-to-door solicitors to have a permit. Ask to see it.

Before paying, check out the businesses at [bbb.org](http://bbb.org).

If the cost of the subscriptions is \$25 or more, you must be informed of your 3-day right to cancel. If they do not, assume it is a scam.

The design contest entries will be judged based on four criteria: wearability, reliability, cost and innovation. "Wearability" relates to the level of comfort. "Reliability" will take into account the chances for potential failure, while "cost" will look at the affordability of the design. "Innovation" will take into account originality or the utilization of new technologies.

The best entries will be posted on the BoatUS Foundation website and Facebook page for voting by the public in June and those votes will assist a panel of experts who will ultimately pick the winner to be announced at the September 2015 International Boat Builders Exhibition and Conference in Louisville, Kentucky. Additional cash prizes are offered for second and third place.

## Mayor Emanuel Announces City Crews Equipped With Additional Resources For Spring Pothole Season

As temperatures warm up, City crews are staffed with reinforcements to tackle the challenges of pothole season this year thanks to additional resources Mayor Rahm Emanuel directed to the City budget for street repairs.

"Whether it's plowing our roads, patching potholes, or repaving streets, we're making sure Chicago residents can keep moving in all seasons," said Mayor Emanuel. "City workers have been doing a great job, and as we get closer to the peak of pothole season we will all be doing everything we can to ensure our streets are patched, paved and passable."

Mayor Emanuel added \$10 million to his 2015 budget so additional street repair crews would be available full time to patch potholes through the winter months. The Mayor's additional funding doubled the Department's budget for pothole and pavement maintenance, allowing CDOT to enter pothole season at peak staffing strength. Today the City has 32 pothole crews deployed in neighborhoods throughout Chicago, with the ability to ramp up pothole crews further as needed. Crews are even assigned to fill potholes on the weekends, giving the City coverage seven days a week.

The increased resources for the City's street patching operations will help reduce CDOT's turnaround time compared to last year, and on average it currently takes less than two-and-a-half days to

respond to pothole repair requests. As of today, there are 465 pending street pothole requests, though the City will remain vigilant heading into peak pothole season.

As a result of last year's harsh winter, the city filled a record 920,172 potholes in streets and alleys in 2014. At the same time, Mayor Emanuel believes you can't just patch your way to passable streets. At Mayor Emanuel's direction city departments and private utilities have greatly increased paving efforts and since 2011 more than 1,000 miles of streets have been repaved - nearly a quarter of Chicago's streets. In 2014, CDOT, the Department of Water Management (DWM), private contractors and utilities combined to repave a record 343 miles of roadway.

## Arbor Day Foundation Selects Tahoe National Forest For 2015 Trees In Memory And Trees In Celebration Commemorative Tree Planting

The Arbor Day Foundation announced today that they will work with on-the-ground partners to plant 608,000 trees in California's Tahoe National Forest through the Trees in Memory and Trees in Celebration commemorative tree planting programs in an effort to accelerate the development of mature forest habitat in areas that experienced moderate to very high burn severity during the 2013 American Fire.

Trees in Memory/Trees in Celebration is a commemorative program that honors friends and loved ones by planting a tree in their name. This year, each dollar donated through the program plants a tree in the Tahoe National Forest.

Located in the north central region of the Sierra Nevada Range in northeastern California, Tahoe National Forest encompasses more than 850,000 acres of public land. In 2013, the American Fire burned roughly 27,440 acres, including 22,500 acres of National Forest System lands. The reforestation strategy includes the establishment of small (approximately 1 acre) "founder stands" intermixed in large seedless landscapes. The new tree stands would be strategically located for seed dispersal and efficient management.

Replanting efforts will begin in April and include ponderosa pine, Jeffrey pine, Douglasfir, sugar pine, and incense cedar tree varieties.

"The Tahoe National Forest is very excited to partner with the Arbor Day Foundation to work together in restoring areas of the Forest affected by the 2013 American Fire," said Tom Quinn, Forest Supervisor. "Partners are the key to accomplishing ecological restoration in the Sierra Nevada national forests."

The newly planted trees will help accelerate the development of mature forest habitat, which will benefit species such as California spotted owl and American marten. Many other species will benefit from the additional cover and forage as the newly planted trees mature to replace the stands that were lost during the American Fire. Tahoe National Forest provides habitat for nearly 400 species of wildlife that make their homes in the various forest ecosystems.
