## 15<sup>th</sup> Annual Greater Chicago Epilepsy 5K

Over 3,000 people from across the Chicagoland area are expected to take part in the Fifteenth Annual Greater Chicago Epilepsy 5K (3.1 miles). Two events will be held in Chicago and the surrounding suburbs. The first event will take place at Wheaton's Cantigny Park on Saturday, April 25, 2015, followed with the largest event at Montrose Harbor in Chicago on Saturday, May 9, 2015. The Montrose Harbor 5K will include a timed run option.



Both events will begin at 10:00 am, with participant check-in starting at 8:00 am. The advanced registration fee is \$25 for adult and teen walkers aged 13 and older, \$15 for children ages 5-12 and FREE to children under the age of 5. ## Skokie Synagogue Presents Two-Part Program On Remembering The Holocaust - “Spotlight: Europe”

A two-part program to remember the Holocaust, entitled “Spotlight: Europe,” will be presented by Ezra-Habonim, the Niles Township Jewish Congregation on Wednesday night, April 15 and Thursday morning, April 16. Both events honoring “Yom Ha Shoah (The Day of the Holocaust)” will be at the synagogue, 4500 W. Dempster, Skokie.

Both programs are free and open to the public.

Wednesday night, at 7:30 p.m., the Men’s Club will offer “Exit Berlin,” a program based on the book “Exit Berlin: How One Woman Saved Her Family from Nazi Germany.” Featured speaker Charlotte Bonelli is the author of the book, as well as the Director of the American Jewish Committee Archives and Library, Greater New York City Area.

“Exit Berlin” is based on the AJC’s Luzie Hatch Collection, which contains more than 300 WWII-era letters. Ms. Bonelli has traveled widely to complete her research, including two investigative trips to Baden-Baden, Germany. She was recently interviewed by BBC Radio for its program Dear Adolf – Letters to the Fuhrer, which focused on American Jewish radio broadcasts during World War II.

On Thursday morning, at 11:00 a.m., a program entitled “The Resurgence of European Anti-Semitism” will be presented by special guest speaker Eric Fusfield. He is the Deputy Director of B’nai B’rith International Center for Human Rights and Public Policy and Director of Legislative Affairs for B’nai B’rith International.

Fusfield has testified before the U.S. Congress, the European Parliament, the Organizations for Security and Cooperation in Europe (OSCE), and the Organization of American States (OAS). He has met with numerous heads of government, foreign ministers, and ambassadors; has frequently been interviewed by television and radio programs and print publications; has spoken at many conferences and other public events. Before joining B’nai B’rith International, Mr. Fusfield worked on international relations for the American Jewish Committee. He received a BA from Columbia University and a JD from the American University’s Washington College of Law.

# Mayor Emanuel Announces \$5 Million In Funding Available To Chicago Small Businesses

## Expanded Small Business Opportunity Centers Program Will Allow More Neighborhood Small Business Owners Access Capital

Mayor Rahm Emanuel today announced new partnerships that will help small business owners in neighborhoods throughout Chicago access needed capital. Following a successful pilot, the Small Business Opportunity Center Program (formerly Capital Access Centers), which helps small business owners prepare for loans, will expand from three to eight centers across Chicago and \$5 million in funding is available for Chicago small businesses.

New partners Somercor 504, Inc., Goldman Sachs, and the Chicago Business Opportunity Fund have more than \$5 million available to lend to qualified small businesses. Both centers provide loans between \$50,000 and \$250,000 to small businesses – a loan size that more small businesses are having trouble securing. They will join the Latin American Chamber, Sunshine Gospel Ministries, and the Women's Business Development Center, along with the three pilot partners, Greater Englewood CDC, the Resurrection Project, and Chatham Business Association in counseling small businesses through the lending process and matching them to available sources of capital.

The announcement coincides with the Chicago Microlending Institute (CMI), recently awarding its 200th microloan. In 2012, Mayor Emanuel launched the Chicago Microlending Institute with \$1 million to help businesses access loans up to \$25,000. In 2014, the Mayor and the City Treasurer invested an additional \$1 million to provide critical loans that would help support roughly 300 new businesses by 2016 and ensure that the CMI program can be self-funding through 2016.

The CMI revolving loan fund now has loans totaling approximately \$2 million, which has supported close to 200 businesses and has helped create or save 817 jobs across the City of Chicago. The announcement was made at one of the new Centers with Sunshine Gospel Ministries in Woodlawn at Greenline Coffee. Twelve Chicago families invested \$150,000 to start the coffee shop that employs 10 staff, all of whom live in Woodlawn. This is an example of the type of

neighborhood-focused small business supported by microloans and with community investment.

Since Mayor Emanuel announced the Capital Access Center pilot program (now the Small Business Opportunity Center Program) in October 2014 to help prepare and connect small businesses to capital, over 60 businesses have been served, 15 of which were steered toward entrepreneurship programs or credit repair specialists. The partners also helped 13 businesses apply for loans - three have been approved and ten are currently pending approval.

Since 2011, Mayor Emanuel has instituted a number of reforms to help support small business growth and entrepreneurship in the City of Chicago. In April 2013, Mayor Emanuel launched the Department of Business Affairs and Consumer Protection's Small Business Center (SBC), to provide a one-stop-shop for small businesses. The SBC has reduced overall wait times by fifty

percent and 25 percent of all customers are in and out of the Center within 15 minutes. Interested businesses can visit the City's Small Business Center online at [www.cityofchicago.org/sbc](http://www.cityofchicago.org/sbc).

And earlier this month, Mayor Emanuel announced an expansion of the Chicago Anchors for a Strong Economy (CASE) program to encourage Chicago's leading institutions to support local small businesses growth in their neighborhoods. Over the last year, the small businesses that participated in the CASE program saw an average increase in revenue of \$804,000. CASE has the potential to drive up to \$80 million in additional revenue to neighborhood small businesses and create nearly 250 full-time and 125 part-time jobs annually. The expansion will increase the number of committed institutions from 11 to at least 20 and double the number of small businesses helped.

## ICYMI: The Bond Buyer

### Local government consolidation could improve state's credit rating

The following article appeared in The Bond Buyer:

Moody's Investors Service said it considers Illinois Gov. Bruce Rauner's appointment of a task force to look at local government consolidation and overhauling unfunded mandates to be a positive credit step.

Moody's in its weekly credit outlook March 26 noted that Illinois has the most local units of governments -- 6,963 - of any state.

"Any reduction in the number of distinct local governments that provide similar services would lower the overall costs supported by Illinois taxpayers," Moody's analysts wrote. "Further, the governor tasked the commission with reducing unfunded state mandates on local governments, potentially resulting in greater fiscal flexibility for the sector."

The existence of numerous local governments puts a significant burden on taxpayers who sometimes fund redundant core and administrative functions. Consolidation could reduce the number of administrators and support staff necessary to run the separate school districts.

In identifying ways to reduce unfunded state mandates, the task force could provide

governments with more expenditure and revenue-raising flexibility. However, as part of his fiscal 2016 budget, the governor is also proposing to reduce state aid to certain units of government with local government income distribution cut in half to about \$600 million.

While Moody's considers the proposal a positive step, it does not impact the state's A1 rating or its negative outlook.

Rauner pitched the idea earlier this year in announcing his "turnaround" agenda and in mid-March announced members of the task force. The group is being chaired by Lt. Governor Evelyn Sanguinetti.

"Illinois has an excessive number of local government units and the state severely limits local governments' ability to control their own costs," Rauner said in a statement announcing the group. "Consolidating local government and reducing the burden of unfunded mandates imposed by the state will reduce costs, increase efficiency and improve delivery of services."

Members include a mix of state lawmakers, representatives of local governments, local government advocacy groups, and education officials.

# Mayor Emanuel Announces Spring Clean And Green Day Of Service To Beautify Neighborhoods Across Chicago

## Residents Can Help To Clean Their Communities On April 18

Mayor Rahm Emanuel, the Chicago Department of Streets and Sanitation (DSS) and the Chicago Department of Transportation (CDOT) today announced the spring Clean and Green day of service will be held on Saturday, April 18 in neighborhoods throughout Chicago. This day of service allows residents to come together with City agencies in every neighborhood to help clean and beautify areas throughout their community.

"Chicagoans have a long history of service in their communities to revitalize and beautify their

neighborhoods, and clean neighborhoods are an essential component of a high quality of life for residents," said Mayor Emanuel. "While we work year-round to keep Chicago clean, we are also asking residents to amplify this work by pitching in to help with our spring cleaning efforts."

Through the day of service, the City will provide the necessary tools to enable community groups and neighbors to further improve their neighborhoods. This year, the day of service will include an emphasis on cleaning viaducts, which

are important neighborhood infrastructures. DSS and CDOT to work regularly to address sanitation issues, lighting issues and other structural concerns in viaducts all year long, and the City recently announced that 80 viaducts in neighborhoods across the city will receive much needed infrastructure improvements that will also benefit public safety for residents in those communities.

"Every year, the Department looks forward to continuing the over two decade long tradition of Clean and Green. The day of service a great opportunity for residents to come together for just a few hours to clean their communities and make an immediate difference in the vibrancy of their neighborhood," said DSS Commissioner Charles Williams.

On top of cleaning and improving viaducts, residents are encouraged to clean curb lanes, vacant lots, parkways and any other community areas that need a good cleaning.

Last week, DSS launched an early overnight street sweeping program to address litter and other debris that accumulated along curb lanes, center lanes and viaducts throughout the winter. The fleet of sweepers will work during the early morning hours to clean arterial streets citywide.

"CDOT is proud to partner with the Department of Streets and Sanitation and residents in neighborhoods across Chicago on the Clean and Green day of service," said CDOT Commissioner Rebekah Scheinfeld. "This is a great opportunity for the dedicated public servants at CDOT and DSS to work alongside the Chicagoans we serve every day to make our City a cleaner and more beautiful place."

To participate in the citywide Clean and Green, call 3-1-1 to register your community group or find a community group to team up with. The City will provide your community organization with brooms, rakes, shovels and bags to get the job done. For groups cleaning viaducts only, the City will provide white paint and painting tools. Community cleaning supplies can be picked up at your local Streets and Sanitation Refuse Division Office. All community groups must register their Clean and Green with 3-1-1 by Friday, April 10, 2015.

## Evanston Beach Tokens Available for Purchase Beginning April 1

Beginning Wednesday, April 1, Evanston season beach tokens will be available for purchase at the Morton Civic Center, located at 2100 Ridge Ave., and local recreation community centers: Robert Crown, Chandler-Newberger, Fleetwood-Jourdain, Levy Senior Center and Evanston Ecology Center. Tokens may be purchased on weekdays, 8:30 a.m. to 5 p.m., at the Morton Civic Center and during office hours at the community centers. Cash, personal checks and credit cards are accepted.

Evanston's five public swimming beaches open for the season on Saturday, May 23, 2015.

On Saturday, June 6, the price for a beach token will increase to \$34 for Evanston or Skokie residents and \$58 for nonresidents.

Community members interested in a daily pass can purchase at a beach entrance. A daily pass is \$6 for children age 1-11 years and \$8 for those 12 years and older. Admission for children under age 1 is free.

To ensure that everyone has access to Evanston's beautiful beaches, the Mayor's Super Summer Recreation Program includes free beach admission through a 10-punch pass for Evanston teens, age 13-18 years old. Beginning Tuesday, June 2, teens may pick up their pass at any of the community centers and the main Evanston Public Library, 1703 Orrington Ave.

Additionally, Evanston residents that meet the income requirement are eligible to participate in beach token fee assistance and the free beach token program. 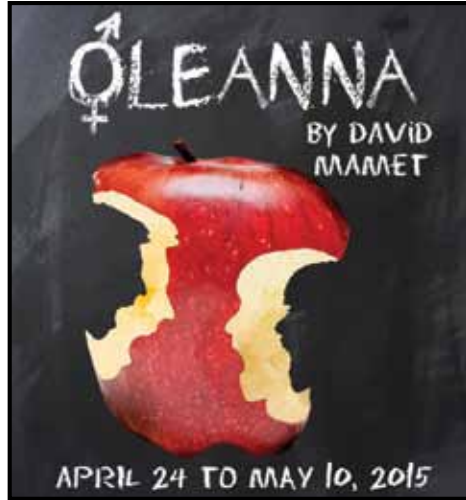
Which of these is the plot of David Mamet's Oleanna? That's for you to decide. You see this scene played out for you, and then witness the results as these two lives spiral out-of-control due to allegations of sexual harassment. Was he exploitative and abusive? Was she manipulative? Or is it all an innocent misunderstanding. In this play, we are confronted with both the effects of carelessness and the dangers of oversensitivity and being too politically correct. And in the end, you decide what really happened.

As part of the Urban Sugar Bush Maple Tapping Project, a partnership between Northwestern University and the American Indian Center of Chicago, the City of Evanston issued permits to install taps on three Evanston parkway maple trees on the 1300 and 1400 blocks of Dobson St. The taps were installed on March 23 and since then more than two gallons of fresh sap has been collected, resulting in two cups of fresh, Evanston-grown maple syrup.

NU Associate Professor Susan Hesos and American Indian Center of Chicago Urban Ecology Coordinator Eli Suzukovich reached out to 8th Ward Evanston Ald. Ann Rainey for help with the project, as maple trees are few and far between on Northwestern University's campus. After putting them in contact with the City's Assistant Director of Forestry, Parks and Greenways Paul D'Agostino, three healthy maple trees were chosen for the process. The trees are expected to continue producing sap for another week or more as they begin to bloom.

Chicago Public Schools (CPS) CEO Barbara Byrd-Bennett joined First Lady Amy Rule, Dr. Jose Lopez, President of the Puerto Rican Cultural Center, Alderman Roberto Maldonado and CPS officials today to launch the Parent University program, which will provide parents and guardians of CPS students with facilities and resources to learn in the same schools attended by their children. The Parent University program is another effort by the Emanuel Administration to engage and support parents, building upon the 31 Parent Engagement Centers established since the Mayor took office. By 2019, CPS will double the number of these centers.

"Two of the most important doors that any child walks through for their education are the front door of their school and but also the front door of their home and so with this new effort we will help more parents support the success of their children," said Mayor Rahm Emanuel. "Parent Universities are another example of how we can work together to invest in the success of our children, while also making sure that their parents and the entire community have the resources necessary for a brighter future as well."

"We are inviting parents and community members to engage in the learning process while also providing students in Chicago Public Schools to have real-life exposure to what it means to be a life-long learner," said CPS CEO Barbara Byrd-Bennett. "The Parent Universities will allow the entire family, students and parents, to reap the benefits of CPS resources."

Each Parent University will be equipped with a computer lab, a parent resource room, an office area and an activity room and will begin with programs The Art of Digital Video, Tasteful Manners and Holy Goat Percussion from the Office of Family and Community Engagement.

The Office of Teaching and Learning has developed "parent friendly" presentations and resources to support core content areas. City Colleges is partnering with the Austin-Westside and Humboldt Park sites to provide GED and College Bridge programming.

Members of the Chicago Public Schools Parent University will receive digital badges for completing tasks such as attending a report card pick up, participating in a workshop, or volunteering at a school function. These badges have the potential to unlock additional opportunities for participants. The first badge participants can receive is the Parent Scholar badge. Participants receive this badge when they sign up for CPS Parent University. A parent or guardian can sign up at <https://chicagocityoflearning.org/parentuniversity>.

Parent Universities fulfill the five principals of Parent and Community Engagement. Principle one is to provide opportunities for parents and community to engage in the learning process. Principle two is to provide opportunities for parents and community to be active participants in the education of our students. Principle three is to design programs that encourage parents and community to pursue extended growth opportunities. Principle four is to create an environment for parents and community that provides access to needed services and resources. And the last principle develops systems for parents and community to have clear communication with the school district, providing access to system-wide initiatives and current practices.

The Spencer location is currently operating, and the Miles Davis location will open in April 2015.

The concept for the Parent Universities was born out of Strategic Pillar Three, Engaged and Empowered Families and Community. Their creation is based on the understanding that parents and community are an essential component in educating our children. The intent is to provide parents and community members with experiences that will provide them a new outlook on education and the learning process that will transfer into positive outcomes for CPS students.

CPS' partnerships with Comcast, Chicago City of Learning, DePaul University's Digital Youth Network, Microsoft and United Way will allow CPS to complete the task of 16 Parent Engagement Center refreshes by the end of the 2015 calendar year.

All virtual and in-person learning opportunities are absolutely free to all CPS parents and guardians.

## Surge in Canine Flu Cases Demands Extra Precautions by Pet Owners

Cook County Department of Animal and Rabies Control (CCDARC) is cautioning dog owners that a recent increase in reported cases of canine infectious respiratory disease (CIRD) could last for several weeks before it subsides.

Dr. Donna Alexander, CCDARC administrator, said voluntary reporting to the Department of disease surveillance conducted by veterinarians has identified more than 1,000 cases of CIRD, or canine flu, unrelated to "kennel cough", as well as five fatalities. CIRD is distinguished from kennel cough by its severity, possible consequences and diagnostic confirmation.

The age of the animals presenting with CIRD symptoms vary, but more severe forms are being seen in dogs under 1 year of age and greater than 7, she said.

Symptoms include persistent and lingering cough, lethargic behavior, a poor appetite and a fever. If you observe or suspect your dog may be suffering from any or all of these symptoms, the animal should be seen by a veterinarian, Dr. Alexander said.

Additionally, she recommended that until incidents of the disease diminish, dog owners should avoid pet friendly areas such as dog parks, not allow their dogs to play with other dogs, avoid group dog training activities, and, if possible, not board their pets. Dogs can be contagious even if they are not showing any of the CIRD symptoms, Dr. Alexander said.

While CIRD is highly contagious for dogs, it is not contagious for humans or other household pets such as cats. However, the virus that causes CIRD can live on fabrics and hard surfaces and can be transmitted from person to dog if the person has come into contact with a dog carrying the virus. To avoid such transmission, Dr. Alexander recommends thorough hand-washing after touching or petting a dog.

A vaccine that counters CIRD is available and can be administered by a veterinarian. This vaccine is separate from the kennel cough vaccine.

## Passover Greeting 2015

Dear Friends,

As our family settles around our intimate Seder table with our guests, our goal is not just to eat the traditional foods and say the Hebrew word as dictated in the Haggadah but to incorporate them and their lessons into our lives.

Here are some of our favorite lessons we've learned over the years:

**Matzah.** It's flat. It's humble. It's solid. White bread is puffy and looks really nice, but it can blow away in the wind, and wouldn't last more than a day if it wasn't packed with preservatives. As big as it is, it has no substance. Sometimes we all need to act like a matzah, humbly doing what it takes and being a rock of support for our friends when they need us. And do you know something else? Matzah lasts, like the good friendships we all seek to create. So be a matzah friend.

**Maror.** Bitter herbs. We eat them to remember the suffering of our ancestors in Egypt. Most of us were never slaves, but the fact that someone else was or is enslaved is enough for us to taste bitterness. When you see someone in need, empathize and feel their pain.

**Four cups of wine.** We drink them to commemorate the four words G-d used to describe to Moses how he would soon redeem the Hebrews. Drinking these cups is our way of thanking Him for the miracles that he did—and continues to do.

The lesson I take from this is that we need to be profusive with our thanks. Don't just say "thank you" once. Do it again and again and make sure that your appreciation really shows.

**The Four Questions.** There was a time when people said, "children should be seen and not heard." Apparently this was not the case at Jewish tables. In fact the Bible itself builds the Seder proceedings around the children asked by the children. Curiosity is a good thing, and we need to foster it in our children. When a child asks a question, we need to listen attentively and try to answer it. And if we don't know the answer, look for it.

**Timing is everything.** Did you know that the Seder needs to start after nightfall? This is the time when our ancestors would eat the Paschal lamb, and this is the time when we hold our seders. Yes it's late and the kids be getting a bit droopy, but a good thing is worth waiting for!

Last but not least I want to wish each and every one of you a very happy Passover. By the time you will be reading this, the Seder will be the stuff of memories (and perhaps a stack of dirty dishes), but hopefully the moments shared, the lessons learned, the bonds formed and strengthened will keep you until next year when we get to re-experience the Seder magic all over again.

## Three Boating Tips Just For Springtime

Across America at boat launch ramps, the familiar growl of boat motors waking up from their long winter nap heralds the start of the boating season. But what makes boating, fishing or sailing this time of year different from all others? When it comes to safety, Boat Owners Association of The United States (BoatUS) has three tips to answer that question:

1. The water is still cold. Darn cold. Even though the white stuff is gone and you're in a T-shirt and can feel the sun's warmth on your face, lurking beneath your boat's keel is water that could make breathing difficult or disable you in minutes after an accidental fall overboard. It's a good idea to wear a comfortable life jacket, and if solo, rig a self-boarding ladder that can be deployed while in the water.
2. Have backup plans. For a routine breakdown while underway, having an on water towing plan from BoatUS can help. However, most important is to leave a note, or "float plan," for friends or family members advising them of your expected return. That's because early in the season there are way-too-few boaters out there who could provide aid if something unexpected happened, and if no one knows where you are, you could be in a heap of trouble. 3. The number one reason why boats sink in the springtime is being in a hurry to get in the water. Check every engine hose and clamp. Remove leaves in scuppers and clear clogged cockpit drains. ## "Vision Zero" Plan Recommended For Reducing Traffic Injuries, Fatalities Advocates Call For Independent Task Force To Assess Photo Enforcement And Other Safety Strategies

Saying that the victims of traffic crashes are being forgotten in the debate over traffic safety and red light cameras, transportation advocates today called on Chicago's elected leaders and candidates for elected office to support a comprehensive "Vision Zero" strategy to consistently reduce traffic injuries and eventually eliminate traffic fatalities.

In addition, they recommended creating an independent taskforce to assess progress toward the Vision Zero goal and examine which safety strategies work best to reduce traffic injuries and deaths, including evaluating the safety impact of individual red light camera locations.

"The real victims in this debate are being forgotten," said Ron Burke, executive director of the Active Transportation Alliance. "The real victims are the nearly 21,000 people significantly injured or killed in traffic crashes each year in Chicago."

One of those victims was 24-year-old Amanda "Mandy" Annis, who was killed in a traffic crash in Logan Square in 2008. Annis was riding her bicycle west on Armitage Avenue when she was hit and killed by a motorist who ran a red light.

Her boyfriend James Bausch, 27 at the time, was riding a bike to visit Annis and rode past the police activity before returning to the scene to learn his girlfriend was the victim. The same hour she was killed, he was picking up an engagement ring and had plans to propose to Annis. Annis was a teacher at Humboldt Community Christian School.

"Nobody should have to go through what Mandy's family and I went through in losing someone we loved to a preventable traffic crash," said Bausch. "We need to be doing more to enforce traffic laws and hold violators accountable to prevent tragedies like this from happening on our streets."

Vision Zero is an international traffic safety movement guided by the principle that no loss of life on our streets is acceptable. Traffic crashes are not mere "accidents," but preventable incidents that can be reduced and eliminated with systemic changes. Photo enforcement is one tool that's been used internationally and across the U.S. to advance Vision Zero goals, along with public awareness and education programs, policy changes, and improvements to traffic engineering and street design.

The findings of Chicago's Vision Zero task force could serve as the foundation for a detailed action plan on how Chicago will achieve progress towards Vision Zero over the next two years. In the past year, the cities of New York, San Francisco and Seattle have all committed to Vision Zero and published detailed action plans that aim to reduce and ultimately eliminate traffic deaths and serious injuries, and several other cities are already working on similar plans. The Chicago Department of Transportation has adopted a goal of reaching zero traffic fatalities by 2022. In pursuit of that goal, CDOT has been implementing various strategies that would contribute to a comprehensive plan.

"Vision Zero is the right thing to do for kids and all of Chicago's pedestrians," said Dr. Kyran Quinlan, who specializes in pediatrics at Rush University Medical Center. "It is far easier and wiser to protect child pedestrians by making our streets safer. Once kids are hit and severely injured, the best medicine may not be enough to save their lives or make them whole again."

According to IDOT data, in 2012 there were more than 77,000 reported traffic crashes in

Chicago that caused significant injuries for nearly 21,000 people and killed 145 people. Because crashes and injuries are often unreported or misreported, the actual numbers are likely higher.

People riding bikes accounted for seven percent of traffic fatalities, people walking 34 percent, and people in cars 59 percent. For non-fatal injuries, about 80 percent were people in cars with the remaining 20 percent that were people biking and people walking. Many more people suffer minor injuries and life disruption.

Chicago advocates said they are worried the debate about red light cameras could lead to the loss of an important traffic safety tool. They said dangerous driving is rampant, and there aren't enough police officers to combat the problem and enforce traffic safety laws. Photo enforcement can bridge the gap, effectively multiplying the power of the police to enforce the law.

"Some of the criticism is justified and some is off base, but enforcing traffic laws, whether with cameras or police officers, prevents injuries and save lives when done properly," said Burke. "Rather than throw the baby out with the bath water, the city should convene an independent group to determine how to improve the program and which cameras should stay or go."

The Federal Highway Administration and other traffic safety experts support the use of red light cameras.

"Red light violations may seem trivial to violators, but the safety consequences are real," said traffic safety expert Richard Retting, who has led studies at the Insurance Institute for Highway Safety (IIHS) that documented reductions in red light running that ranged from 40 to 96 percent after adding red light cameras. "The research is conclusive: red light cameras are effective at reducing crashes that result in serious injuries and fatalities."

"As a pediatric emergency medical physician, I've seen the devastating impact that traffic crashes have on children and their families," said Dr. Karen Sheehan, who serves as medical director of the Lurie Children's Injury Prevention and Research Center. "Research has shown that red light cameras decrease the more serious right angle crashes."

In 2013, more than 1,100 crashes caused by red light violations killed six people and caused significant injuries for more than 700 people.

Another one of those victims was James Longfield, who was riding his bike north on Elston Avenue in Chicago when he was struck by a cab driver running a red light. The driver approached the intersection from the east on Courtland, turning right on red without stopping and hit Longfield. Longfield suffered injuries and ultimately settled with the cab company to cover his medical expenses and bike damages, as well as additional compensation.

"We need increased enforcement of traffic laws on our streets to save lives and prevent serious injuries like mine, and traffic safety cameras are a big part of that," said Longfield.

Active Trans supports better enforcement of all traffic laws for all modes of travel. Whether driving, biking, or walking, everyone needs to be safe and respectful. Dangerous behaviors are unlikely to change without a comprehensive strategy that includes ticketing, public awareness and education programs, policy changes, and improvements to street design.


