National Wildlife Federation The Real Reason for Groundhog Day

Punxsutawney Phil, America's most famous weather forecaster, will have love, not weather, on his mind when he emerges from his hole on February 2. Researchers tracked 32 groundhogs for more than four years and concluded that the real reason for the early February appearance is a version of the dating game, groundhog style.

Male groundhogs wake up after three months of hibernation to check out the available pool of ladies within their territory. They select a female with whom they spend the night, and this sleepover acts as a first date, allowing the groundhogs time to get to know each other before the official start of mating season the following month. During these meet and greet sessions, contact is confined to rubbing noses - there's no going "all the way."

After scoping out two or three females, the male groundhog returns to his burrow to sleep again until March, dreaming of the hotties he has just met. When he awakes and revisits each of the females, the earlier slumber parties allow the woodchucks to skip the small talk and get right down to the business of breeding.

To donate blood, individuals must be at least 17-years-old, weigh at least 110 pounds, and be in good health. Those wishing to donate should eat a balanced meal within four hours of donating blood. Evanston Senior Citizen Property Tax Reduction Applications Due February 8

Evanston residents age 65 years or older should have recently received 2016 Senior and Senior Freeze Property Tax Exemption renewal applications in the mail, and must file them by Wednesday, February 8, 2017. Illinois law requires seniors to reapply annually. Local seniors are encouraged to call Evanston's Property Tax Assessment Review office at 847-448-8168 for help completing the forms.

The recently mailed senior applications are for 2016 property taxes, which are paid in calendar year 2017. The savings from these exemptions will appear on the 2017 Second Installment Property Tax Bills that will be mailed in late June and will be due on August

There are two Senior Tax Exemptions:

- 1. The Senior Exemption is available to property owners born in 1951 or prior, with no income restrictions. This is available to property owners or renters responsible for paying the real estate taxes, if they used the property as their primary residence in 2016.
- 2. The Senior Freeze Exemption is available to property owners born in 1951 or prior, with a total household income of \$55,000 or less during income tax year 2015. The applicant must have owned and lived in the property as of January 1, 2015 and January 1, 2016, and have been liable for the property tax bill payments for 2015 and 2016.

"If you don't qualify for the Senior Freeze Exemption because you exceed the income level, this does not mean you will not be eligible for the Senior Exemption," said Cook County Assessor Joseph Berrios. "The Senior Exemption has no income restrictions and I'm concerned that seniors might discard the entire booklet and not receive the Senior Exemption savings to which they are entitled."

Seniors receiving the Senior Citizen Exemption automatically receive the Homeowner Exemption. Seniors receiving the Senior Freeze Exemption automatically receive both the Homeowner and Senior Citizen Exemp-

Information for Seniors Who Did Not Receive Mailings or First-time Applicants

Homeowners who were born in 1951 turned age 65 in 2016, and thus are likely to be eligible for one of the senior exemptions for the first time. Taxpayers who recently turned 65 may not have received applications when the senior renewal forms were mailed. Such individuals are encouraged to go to the Cook County Assessor's website, cookcountyassessor.com, to download Homeowner, Senior and Senior Freeze Exemption applications, or call the Property Tax Assessment Review Office at 847-448-8168 to obtain the forms and information necessary to complete the applications.

Mayor Emanuel, City Of Chicago Announce Riverwalk Concession Program Opportunities Rfp Issued After Riverwalk Vendors Earned More Than \$8.5 Million In Gross Revenues During 2016 Season

After a record breaking 2016 season for Riverwalk vendors, Mayor Rahm Emanuel and the City of Chicago announced that they are advertising a Request for Proposals (RFP) today for concession operations for the Chicago Riverwalk. For the first time, the RFP will provide the opportunity for vendors to submit proposals for longer term contracts and to build permanent year round restaurants or amenities.

The RFP seeks proposals from vendors to operate anywhere between Lake Shore Drive to Franklin, which includes the recently completed section from LaSalle to Franklin, for 2017 and beyond, although it is likely that vendors will not be operational in the most recently completed section until the 2018 season. Vendors may propose three or 10 year proposals.

Proposals are due by 4:00 p.m. on Thursday, March 9, 2017 and will be reviewed by an Evaluation Committee. The Evaluation Committee is comprised of city personnel familiar with the Riverwalk and specialize in areas of finance, cultural affairs, construction and operations.

Contracts for the overwhelming majority of vendors who operated along the Riverwalk from Lake Shore Drive to LaSalle during the 2016 season has been extended for the 2017 season.

The City envisions a mix of recreational, cultural, entertainment, food and beverage and retail facilities on the Riverwalk, creating a vibrant area to be enjoyed by residents, tourists and visitors alike. Based upon the positive reaction by Chicago's residents and visitors throughout the summer, the City expects to receive a large number of highly competitive proposals.

The City is now seeking vendors to provide a variety of activities, events, and services in 2018.

Examples of possible concessions include, but are not limited to: facilities for paddling, recreational or charter boat; sports rentals; food and beverage; retail, particularly of a cultural or environmental nature; educational facilities; entertainment venues; commercial boats docked along the seawall with food and beverage or associated with a food and beverage provider operating in the land adjacent; or any other type of family-friendly concessions. The Department encourages Respondents to propose other ideas to enhance the use and enjoyment of the Riverwalk and the Chicago River.

Throughout the summer, huge crowds visited the Riverwalk. Visitors were able to enjoy a tiki bar, wine bar, French bistro, specialty cocktails and BBQ and recreational options included bike rentals to kayak tours.

Vendors interested in participating in the 2018 Season on the Chicago Riverwalk are invited to attend a Pre-Proposal Meeting on Thursday, January 26 at 10:00 a.m. in Room 1103 in City Hall, 121 North LaSalle Street. City representatives will describe the program and answer questions during the pre-proposal meeting. Illinois House Passes Administration's Permanent Property Tax Freeze Proposal

Governor Rauner issued the following statement today after the House of Representatives passed the Administration's proposal, HB 6630 sponsored by Rep. Mark Batinick, to permanently freeze property taxes in Illinois:

"This morning the Illinois House of Representatives took a step in the right direction and passed our permanent property tax freeze. We have the highest property taxes in America, and a property tax freeze where you control whether your property taxes go up or not, will help change the system in Illinois, create jobs and keep families from fleeing the state."

ICYMI: Legislation Refiled To Sell Thompson Center Selling Building Could Net State Taxpayers \$220 Million; Generate \$45 Million In Property Taxes For The City Of Chicago

Gov. Bruce Rauner and other Republican lawmakers are making a second run at selling and demolishing James R. Thompson Center in the Loop, which they say could add hundreds of millions of dollars to state and local coffers. [...]

This time around, the state's Department of Central Management Services is providing specific estimates of how much a sale of Thompson Center would boost the state's finances. A sale would generate potential net proceeds of \$220 million and would prevent the state from addressing \$326 million in deferred maintenance on the building, according to CMS. [...]

A sale and redevelopment of Thompson Center also would generate transfer taxes and future property taxes for local government, (House Minority Leader Jim) Durkin said.

Governor Discusses Importance of Apprenticeships

Governor Bruce Rauner met with members of Illinois Workforce Innovation Board Apprenticeship Committee today to discuss the importance of bringing opportunity to every neighborhood in Illinois through apprenticeships. The committee's efforts are focused on providing the same training and education services to all students across Illinois as part of a comprehensive cradle-to-career education.

"Improving the quality of education is why I ran for office," said Governor Rauner. "Apprenticeship programs are so critical to students because they deliver a pathway to good paying jobs and stable careers, especially for those who may not want to go or have access to college. Our Apprenticeship Plus initiative is one of three priority projects, and this committee will help lead the state's efforts to expand apprenticeships in Illinois."

In June 2016, the Illinois Workforce Innovation Board created a standing Apprenticeship Committee to design and oversee implementation of a comprehensive and integrated apprenticeship system for Illinois. The committee's goal is to lead the State's efforts in expanding and transforming apprenticeship in Illinois by building capacity, infrastructure and expert support. Members of the committee include leaders in business industry as well as training providers, local workforce innovation boards, labor, philanthropies, community colleges, college-based organizations, rehabilitation services and employment exchange services.

Mayor Emanuel Reminds Residents That Free Income Tax Preparation Help Is Available Across 19 Sites

The City of Chicago, with The Center for Economic Progress and Ladder Up, will today resume the annual Tax Prep Chicago program, a free citywide federal and state tax preparation service. In addition to standard assistance with tax preparation this year, Tax Prep Chicago sites will provide residents with assistance on renewing their Individual Taxpayer Identification Number (ITIN)—used to file taxes in lieu of Social Security Number—per changes to federal law this year.

To spread the word on the changes to tax filing this season, the Mayor's Office of New Americans will convene dozens of offices to enlist their support with engaging residents across the city in renewing their ITIN and to comply with recent changes to federal law—which is required before a person's 2016 tax refunds will be released by the IRS.

It is estimated that tax credits and refunds direct tens of millions of dollars into immigrant communities each year, and also that thousands of ITINs belonging to immigrants in the city are expired as of January 1, 2017. The ITIN is a tax processing number issued by the IRS to individuals who are not eligible for a Social Security Number, and is issued regardless of immigration status.

In addition to the ITIN renewals, recent federal changes are also expected to delay refunds for Chicagoans in 2017. Last year, it was announced that new federal laws would result in delayed tax refunds for taxpayers claiming the Earned Income Tax Credit (EITC) or the Additional Child Tax Credit (ACTC) to be delayed. To inform residents of the changes and to help them prepare, the City partnered with CEP and Ladder Up on an outreach campaign in 2016, ahead of the holiday season.

Preparation of returns using ITINs is one of many services offered each year by Tax Prep Chicago for families earning up to \$55,000 and individuals earning up to \$30,000 annually. To support residents in claiming all of the money available to them, the city is encouraging residents to seek trusted support through any one of the 19 sites. A full list of sites and corresponding hours is below:

Each year, thousands of eligible households in the City do not claim the EITC and other key credits, leaving as much as \$200 million in unclaimed dollars that could help individuals and families meet basic needs. Last year, Tax Prep Chicago services assisted 20,000 residents and families in securing \$31 million in tax refunds and credits.

President Preckwinkle, County Department of Transportation and Highways Issue First-Ever Call for Projects

The Cook County Department of Transportation and Highways (DoTH) is seeking applications for transportation-related projects throughout Cook County as part of the President Toni Preckwinkle's initiative to build and maintain a comprehensive regional transportation network.

For the first time, Cook County is launching an \$8.5 million program to help cover the cost of planning, engineering, right-of-way acquisition and construction associated with transportation improvements sponsored by local governments and private partners. This new program seeks projects that broaden the County's traditional focus on County roads to include pedestrian, bicycle, transit and freight-related improvements.

The call for projects, dubbed "Invest in Cook," is an initiative of Connecting Cook County, the County's first long-range transportation plan in 75 years. Connecting Cook County lays the groundwork for how the County invests in transportation to attract and retain businesses, people, capital and talent.

DoTH is seeking applications from local governments and transit agencies. Private for-profit or non-profit organizations can submit project proposals, but must have a public sponsor. The deadline to apply is 5:00 PM CST on March 17, 2017.

Invest in Cook seeks projects consistent with the priorities detailed in Connecting Cook County:

- Prioritize transit and other transportation alternatives
- Support the region's role as North America's freight capital
- Promote equal access to opportunitiesMaintain and modernize what already exists
- Maintain and modernize what already exists
 Increase investments in transportation

Cook County transportation staff will evaluate and score the proposals using publicly available, performance-based criteria and a qualitative assessment to determine which projects will be absent this year.

Roadside History of Illinois

This is a first in a series of monthly short articles about places in Chicago and nearby suburbs that can be visited by those who seek to learn more about local history. The articles are partial excerpts from the book, Roadside History of Illinois, by Chicago author and Illinois native Stan Ban-

DuSable (Michigan Avenue) Bridge and Pioneer Court Plaza

For nearly a hundred years, Chicago residents crossed the Chicago River by canoe or rowboat. An iron and wooden swing bridge was built at Rush Street in 1857 and rebuilt several times. Other small bridges appeared on the river over the years, but it was not until Daniel H. Burnham and Edward H. Bennett published their Plan of Chicago in 1909 that an elaborate permanent bridge was designed. Construction on the Michigan Avenue Bridge (officially DuSable Bridge in 2010) began in 1917 and was completed three years later. Prominently featured on the four corner bridge houses are striking bas-relief panels sculpted by James Earle Fraser and Henry Hering, each depicting a theme from the city's early history. Now a designated Chicago Landmark, the bridge received a makeover in 2009, when the railings were replaced with a near-replica of the original 1920s design. Visitors to the McCormick Tribune Bridgehouse and Chicago River Museum, on the bridge's southwest corner, can get a closer look at the structure's history, mechanics and significance.

Nearby Pioneer Court Plaza (located between the Chicago River and the Tribune Tower) anchors part of the south end of the Magnificent Mile. It was the site of the former home (cabin) and trading post of Jean Baptiste Point de Sable, the first non-native permanent resident of the future Chicago. Most likely, the name Point de Sable (French



for "sand point") was not his real surname but one he gave himself. While little is known about Point de Sable's early life, most historians agree that by 1788, he was firmly entrenched at Chicagoua (name that means bad smell, probably from the area's wild garlic or onion plants), and evidence suggests that Point de Sable's operation was not simply a trading post but an extensive farm, now covered

by Pioneer Court Plaza and other adjacent concrete surfaces and buildings. In 1800 Point de Sable sold his farm to Jean La Lime; three years later, John Kinzie purchased the property from La Lime and took over the trading post and the farm operations, going on to become a key player in the city's early development. The area also was the location of Chicago's first post office, established in 1831, and operated by fur trader Jonathan Bailey. The Jean Baptiste Point de Sable Home Site in Pioneer Court Plaza was named a National Historic Landmark in 1976, with a bronze plaque and porcelain placard added in 1977. A metal bust of Point de Sable rests atop a pedestal near the southwest corner of

Visitors to Pioneer Court Plaza are encouraged to walk through the open space to the river, imagine the cabin and out buildings that once occupied the site, view the river that once was less than half its current width, and glance toward the intersection of Wacker Drive and Michigan Avenue, the approximate location of Fort Dearborn. You may even feel the spirit of those who made their mark on early Chicago.

Greek Orthodox Church Hosted 1st Annual Blessing Of Des Plaines River Service Celebrates Christ's **Baptism In The River Jordan**

On Sunday, January 22 along the Des Plaines River Trail in Des Plaines, St. John the Baptist Greek Orthodox Church of Des Plaines held their 1st ever service blessing the Des Plaines River. Over 180 clergy and parishioners attended this highly successful event, including several Alderman of the City of Des Plaines and Illinois State Representative Marty Moylan. The service ended with local priest Father John Rallis of St John the Baptist tossing into, and retrieving from, the Des Plaines River a blessed cross, symbolic of Christ's baptism in the River Jordan.

Each January 6, Eastern Orthodox Christians throughout the world celebrate Theophany, which in Greek means "manifestation of God." The day commemorates the Baptism of Christ and the Divine revelation of the Holy Trinity. On the historic Julian Calendar, or "Old Style Calendar", which some Eastern Orthodox Churches still use for liturgical services, January 6th is this

Part of Theophany in many locations with a major waterway includes the outdoor Blessing of the Waters service. As a sign of blessing as Christ blessed the Jordan, holy water is poured into the body of water. An associated tradition has been the tossing of a cross into the water to be retrieved, in warmer climates by divers. Holy water is also given to the faithful to consume and to use in blessing their homes. In the weeks



following the service, clergy visit the homes of parishioners and conduct a service of blessing using the holy water that was blessed in church on the holiday.

Eastern Orthodox Christians are the second largest Christian denomination worldwide. The Metropolis of Chicago oversees all Greek Orthodox Parishes within Illinois, Iowa, Wisconsin, and Minnesota, as well as large portions of Missouri and Indiana. While all parishes hold an in-church Blessing of the Water Service, this outdoor Blessing of the Water service along a major waterway is rare in this part of the United States.


"Loud Mountains" Plays Loud & Soft

They've been called "an international band of international brothers" and the famous Americana label "Clubhouse Records UK" has signed them. Psycologists use the term "The Seven Year Itch" to describe a feeling that occurs after a long, monogamous relationship where someone starts to fantasize about life outside the relationship. George Axelrod took this concept and turned it into a play, which many credit as launching the American romantic farce genre. And what better way is there to spend the cold February nights that with a romantic farce at Skokie Theatre.

They play concerns Richard Sherman, a man in his late thirties, who has stayed in New York City while his wife and child take a summer-long vacation at the seashore. Alone and twitchy, he makes the acquaintance of a new neighbor, a sexy, free-spirited young woman who lives upstairs. Throughout the play he fantasizes about seducing her, and his fantasies contrast with reality in a comic way. Ultimately, Richard proves an incompetent seducer and more jealous of his wife than she has reason to be jealous of him.

Although the film version of The Seven Year Itch starring Marilyn Monroe is more famous today, the play was a Broadway smash, opening in 1952 and running over one thousand performances before closing.

Comedian David Dristas has the challenge of managing Richard Sherman's mid-life crisis. He started doing sketch comedy 15 years ago in his home town of Philidelphia. Since moving to Chicago, he has appeared with The Second City Theatricls and is an ensemble member downtown at ComedySportz. He also appears frequently with the Annoyance Theatre.

Megan Gill has the daunting task of taking on the role made famous by Marilyn Monroe. Megan first appeared at Skokie Theatre as Janet in our annual Rocky Horror themed cabaret, but she will also be familiar to our audiences from her appearances in Mame at Light Opera Works and Nice Work If You Can Get It at Theatre in the Center.

The Seven Year Itch runs from February 3 through February 19: Friday and Saturday nights at 7:30 pm, Sundays at 2:00 pm, with a one-time Wednesday afternoon matinee at 1:30 pm on February 8. Mayor Emanuel And Northwestern University President Attend Grand Opening Of New Northwestern Academy For CPS Students

Mayor Rahm Emanuel and Northwestern University President Morton Schapiro today attended the grand opening of a new state-of-the-art center to house the Northwestern Academy--a program to support Chicago Public School students in preparing for success at competitive colleges and universities. They were joined by students enrolled in the Northwestern Academy and their parents. The Academy will graduate its inaugural cohort of seniors this spring.

Located on Northwestern's Chicago campus in Streeterville, the new high-tech center makes the Academy's programming and support services more easily accessible to CPS students. The center was previously located on Northwestern's Evanston campus.

Launched in 2013, the Northwestern Academy for Chicago Public Schools is a multi-year college preparation and enrichment program for diverse, academically motivated students from Chicago Public Schools. Approximately 200 students from 40 CPS high schools are enrolled in the Academy this school year.

Of the 58 high school seniors in the class, the majority of students have already been accepted by at least one college or university for next fall, and a greater majority—86 percent—will be the first in their families to go to college.

The Northwestern Academy for Chicago Public Schools accepted its first class of students in 2014. Students apply for the Academy during the winter of their freshman year in high school and are accepted into the Academy in June as they complete their freshman year.

The newly rehabbed center provides classrooms designed to foster collaboration between students, Northwestern teachers and staff, as well as families. Each classroom is equipped with 21st century wireless and high-res technology capabilities to facilitate conference calls with prospective college and universities, as well as virtual tours of college campuses. Additionally, Academy Advisors provide student participants with on-site college counseling and advising and assistance on applying for financial aid.

Northwestern Academy is a program of Northwestern's School of Education and Social Policy. The program provides students with personal enrichment, leadership development, college advising and cultural and civic engagement. The Academy is supported by Northwestern as an extension of its Good Neighbor, Great University initiative to expand college access. The Academy is offered at no cost to students.


Northwestern's investment in the Northwestern Academy is one of many longstanding partnerships the university has with CPS to provide Chicago's students additional academic and enrichment opportunities. Just last week, Northwestern announced a newly formed partnership with Lake View High School where they will support students and teachers with tailored programs. This includes a new summer laboratory opportunity that will provide students the research-based skills of scientific discovery.


To support the record number of students graduating from CPS today, the Mayor and the District are working to ensure that students have access to the tools and resources needed to promote college readiness. In addition to partnerships with colleges and universities, this includes strategic investments in college-level coursework and dual-credit/dual-enrollment opportunities in schools throughout the city to improve college access and affordability for students citywide.

CPS students with a strong academic performance, determination and motivation to engage in rigorous academics, and a desire to explore college possibilities beyond those in Chicago are encouraged to apply for the Northwestern Academy. To apply, students must be a freshman in high school, and submit an application, recommendation and writing samples. Northwestern Academy will invite finalists to interview and meet with advisors.

During World War II on the high seas of the Atlantic Ocean, the SS Dorchester, a troop ship carrying a thousand U.S. soldiers and crew bound for Greenland, was torpedoed and sunk on Feb. 3, 1943. Before the ship went under, four U.S. Army chaplains of different faiths gave their life jackets to others, sacrificing themselves. Their deed did not go unnoticed. The Four Chaplains, often known as the "Immortal Chaplains" or the "Dorchester Chaplains," have been immortalized on a U.S. postage stamp and recognized by their fellow veterans for their unselfish action.

Not a U.S. Citizen? - What You Need to Know about U.S. Gift and Estate Taxes

In the United States, any federal gift and estate tax due from an estate must be paid during the probate of the estate and prior to assets being distributed to beneficiaries and/or heirs of the estate. The gift and estate tax rules are complex enough for a U.S. citizen; however, when the decedent and/or the surviving spouse is NOT a U.S. citizen, the rules become considerably more difficult to understand and follow.

However, this is even more reason to have at least a basic understanding of some of the major differences between how U.S. citizens, non-citizen residents, and nonresident non-citizens are treated with regard to federal gift and estate taxation.

Who's Who?

In the U.S., your citizenship and/or residency status decides your tax treatment. Therefore, it is important to understand where you fit. Most taxpayers are U.S. citizens, either by birth or by naturalization.

Others are not citizens but are legal residents of the United States.

For taxation purposes, a non-citizen who lives in the United States is treated the same way as a citizen. A non-citizen, nonresident is someone who is not a citizen and does not live here. For tax purposes, non-citizen, nonresidents are often referred to as "nonresident aliens", or "NRAs." NRAs are not treated the same as citizens and residents when it comes to federal gift and estate taxation.

How Are U.S Citizens and Residents Taxed?

After death, the assets of the decedent's estate are identified and valued. The taxable estate consists of everything owned by the decedent, regardless of where those assets are located. The value of those assets, combined with the value of gifts made during the decedent's lifetime, is potentially subject to federal gift and estate tax at a rate of 40 percent. Fortunately, each taxpayer is entitled to exclude up to the lifetime limit which was set at \$5 million but adjusted annually for inflation. For 2016, the lifetime exclusion limit is \$5.45 million.

How are Nonresident Aliens (NRAs) Taxed?

A nonresident alien is taxed only on property situated in the United States; however, a NRA is not entitled to the typical lifetime exclusion – this exclusion is only \$60,000. How Is Someone with Dual Citizenship Taxed?

Dual citizenship means you are a citizen of two countries, for example Argentina and the United States. As a general rule, citizenship in another country does not change your tax obligation in the U.S., meaning you will be taxed as a U.S. citizen.

How Does the Marital Deduction Work?

For a U.S. citizen or resident, the marital deduction allows you to leave an unlimited amount of assets to a spouse upon your death tax-free. The unlimited marital deduction is not available if the surviving spouse is a non-citizen unless the assets are left in a Qualified Domestic Trust, or QDOT. The reason for this is simple.

If a citizen inherits a large estate that estate, will eventually be taxed when the assets are passed down either as gifts or at the time of the survivor's death. If, however, that same large estate is left to a non-citizen there is no guarantee that those assets will be taxed down the road, making it necessary to tax them at the time they are transferred. A QDOT alleviates these concerns by ensuring that the property does not escape the country without taxation. A QDOT must have a U.S. citizen or financial institution as a Trustee who must have the legal authority to withhold taxes. The QDOT can periodically pay the trust's income to the surviving spouse; however, any other distributions must have estate tax withheld unless hardship can be shown. Only if the surviving spouse becomes a U.S. citizen can the assets be removed from the QDOT.

As the world becomes smaller, it is becoming more and more common for people to marry someone from another country given the ease with which we now travel across borders. For a non-citizen, or the spouse of a non-citizen, estate planning takes on a heightened importance. If you are a NRA, or you plan to leave part, or all, of your estate to a non-citizen spouse, it is imperative that you consult with an experienced estate planning attorney early on to ensure that you, your spouse, and your assets are protected.



Village Cooking Corner

How To Set Up A Party Buffet

Arrange your seats in advance. Avoid the haphazard run for dining room seats seconds before the game begins by bringing your extra seats into the TV room before your guests arrive. This way you can arrange the chairs to ensure that everyone will not only have a great view of the game, but will also have avenues of escape for bathroom breaks, drink refills or a secondround of dinner.

Put together a buffet table. Rather than plopping everything on the coffee table for easy access, display the food and drinks along the kitchen or dining room table. (Or, relocate whatever table is most convenient to your living room to bring the snacks closer.) No one will be reaching over one another for food, which means fewer spills and a faster serving time so no one misses any part of the big game.

HERE ARE SOME EASY, BUT VERY TASTY, IDEAS FOR YOUR SUPER BOWL GATHERINGS.

(Any of the serving sizes mentioned may be increased by doubling, tripling, etc. to accommodate your guest list).

Stuffed Eggs (4 servings)

4 eggs 1 t prepared mustard 2 T margarine wine vinegar

2 anchovy fillets salt and pepper 4 tomatoes tarragon chives

pinch of sugar black olives

anchovy fillets for garnishing

Hard-boil eggs, peel and cut in half lengthwise. Scoop out yolks and mix with the finely chopped anchovy fillets, prepared mustard, salt, pepper and soft margarine and fill this mixture into egg halves. Cut tomatoes in half and season with wine vinegar, tarragon, salt, pepper and a pinch of sugar. Place eggs on tomato halves and garnish with chopped chives. Serve on plate decorated with olives that have anchovy fillets wrapped around them.

Cheese Mini-Sandwiches (8 servings)

Alternate 8 buttered slices of square pumpernickel with 7 slices sharp cheddar cheese; wrap in wax paper and place in refrigerator for some time, weighing the package down to make slices stick together. Unwrap, cut in cubes and garnish with olives, grapes or anything suitable. Note: You can use a variety of cheeses to fit your taste and garnish with anything from anchovies to pickles to nuts.

Kraut Salad (8 servings)

1 small head of cabbage vinegar 1 clove garlic

salt and pepper 1 onion, chopped 4 strips smoked bacon

chopped herbs (any combination to suit your taste)

Cut cabbage in fine strips, season with salt, pepper and vinegar and place in a large, shallow container; weigh down with a water-filled dish for 2 to 3 hours. Then combine cabbage, chopped onion, garlic, herbs and the bacon which has been cut in thin strips and crisped. Mix the crisp bacon and its drippings into the cabage salad; toss and serve lukewarm.

Ultimate 7-Layer Dip

1 can (18 oz.) Refried Beans 1 cup Breakstone's sour cream

1 Tbsp. Taco Seasoning Mix. 1 cup Thick 'n Chunky Salsa

1 cup shredded lettuce

1 cup Mexican Style Shredded cheese 2 Tbsp. sliced pitted ripe olives

1/2 cup green onion slices

Ritz Chips original or Wheat Thins baked snack crackers

Mix: beans and taco seasoning mix. Spread onto bottom of 9-inch pie plate or quiche dish.

Layer: Remaining ingredients over bean mixture, cover and refrigerate several hours or until chilled.

Serve with chips or crackers.

Makes 48 servings, 2 Tbsp. dip and 14 chips or 16 crackers each. Make Ahead: Prepare as directed, cover, refrigerate up to 2 hours.

Piquant Meat Balls

2 pounds ground beef 2 tablespoons bread crumbs pepper, to taste 6 ounces grape jelly

1 egg

1 teaspoon salt

12-ounce bottle of chili sauce

juice of 1 lemon

Combine meat, egg, bread crumbs, and seasonings. Shape into balls the size of a walnut. Heat chili sauce, jelly, and lemon juice in a heavy skillet or Dutch oven until blended. Add the meat balls, cover, and simmer for 30 minutes. Uncover and cook 15 minutes longer, stirring frequently to prevent sticking.

Serves 8 to 10.

Boursin Cheese

8 oz. cream cheese

1 clove crushed garlic

3 tsp. fresh minced parsley

1 tsp. basil leaves

2 T chopped chives

1 T dry white vermouth

lemon pepper

Blend cream cheese and garlic and add everything else. Serve with crackers or in celery.
