If you do not have a renewal notice or a current registration card, please call the Public Inquiry Division at 800-252-8980 to obtain your Registration ID and PIN number.

Businesses Are Responsible For Removing Snow & Ice From Sidewalks

Many people rely on walking and transit as their primary mode of transportation. Without a wide, clear path through snow and ice, travel is especially difficult for people with disabilities, seniors, and children to walk safely.

According to the Municipal Code of Chicago (4-4-310 & 10-8-180), property owners and occupants are responsible for keeping sidewalks clear of snow and ice.

There is an old African proverb that said, "It takes a village to raise a child." It also takes a village to help community members in need make ends meet and enjoy holidays like Thanksgiving in a dignified fashion.

Over the past few weeks, dozens of volunteers, staff, and elected officials at Niles Township in Skokie Illinois have been quietly working to provide food support to residents that may not have enough means to celebrate a traditional Thanksgiving dinner. Most people in America don't think twice about meals. We live in a country of plenty, and the grocery store is a mind-boggling array of choices. But even here in the twenty first century, we see many people, particularly our elderly constituents that must choose between food and medicine. We also witness single parents and the working poor trying hard to feed their families from month-to-month.

Township government is often a well-kept secret, but is in fact a vital lifeline to fundamental human services that help at-risk people get along. Better Business Bureau Warning: Beware Of Fraudulent Dear Santa Websites

More than 60 domain names are registered in the name of Santa Claus, offering children a wide range of opportunities to email St. Nick. Sadly, some of the websites aren’t always so trustworthy and can potentially be a dangerous way to share personal information. The Better Business Bureau (BBB) is advising parents to do their homework before letting their child write to Santa this holiday season.

Letters to Santa may seem innocent and fun, but it is very important for adults to carefully review websites to determine who is seeking information, how it will be used and whether it will be shared with third parties.

“Writing Santa is a favorite tradition for many families,” said Steve J. Bernas, president & CEO of the Better Business Bureau serving Chicago and northern Illinois. “Unfortunately, some of these Santa sites do not have the best intentions, and will misuse information handed over by children.”

All websites directed to children - or websites designed with a special children’s section - should have a privacy policy that explains the site’s information collection practices. The privacy policy should include the name of the company and the company’s complete contact information.

It should also state whether the company shares information with third parties, including advertisers, and whether the company publicly discloses the information or retains the information for any future purpose.

The BBB offers the following ‘Dear Santa’ site review tips: Check to see what they are seeking. Websites directed at children should not ask a child to disclose more information than is reasonably necessary to participate in the activity.

Limit the personal information children share online and omit physical addresses. In many cases, there really shouldn’t be a need to share this information. Instead, provide just a first name and email address.

Check websites for unwelcome content. Some sites are geared toward adults and may contain language or advertising adults may not want children to see. Check the links. Since hyperlinks can allow children to move seamlessly from one site to another, investigate the hyperlinks to assure children don’t access inappropriate content.

Chicago Park District Seeks Made-In-Chicago Films for Free Local Screenings

The Chicago Park District invites local filmmakers to submit Chicago-focused films for the third installment of the Chicago Onscreen Local Film Showcase in 2016. Filmmakers of all ages and skill levels are encouraged to submit short and feature-length narrative films, documentaries and animated works for consideration. All submissions will be reviewed and evaluated by a selection panel comprised of Chicago Park District programming staff and members of the Chicago filmmaking community. Selected filmmakers will be awarded an honorarium of up to \$500 to support their continued work in Chicago.

The Chicago Onscreen Local Film Showcase brings local films to local parks as part of the Chicago Park District’s popular Movies in the Parks program. Selected films are shown, free of charge, in outdoor screenings in the city and neighborhoods that inspired them. These local film screenings enhance and diversify the offerings of the Movies in the Parks program and offer patrons a chance to experience the work of some of Chicago’s talented creative professionals living and working right here in the city.

In its first two years, the Chicago Onscreen Local Film Showcase brought 32 films to almost 1,000 Chicagoans in 13 screening events. Waiting Or Preparing For Christmas

Catholics – and most Christians – begin the season of Advent (four weeks before Christmas). At the same time most people are WAITING for Christmas from Black Friday: see the great number of newspaper pages filled with pre-Christmas sales – sales for anything and everything. Some stores were opened from midnight or 3 a.m. ... and people were WAITING.

This followed with cyber Monday sales.

Is this the season to SHOP for CHRISTMAS?

Some wait to see the Nativity scene erected in the church or at its front lawn ... the Christ in the stable ... in the straw ... in a feeding trough. But this is a reminder of that first Christmas Day ... yet Christ is present with us today!

How did Christmas Day become a day to exchange presents? Perhaps the custom of St. Nicholas (Santa Claus ... December 6th) and his generosity brought about the hanging of a “Christmas” sock and the children WAITING with joy for a sock full of candies and other “goodies.” (Some might remember that some parents jokingly threatened: “If you didn’t behave your sock might be filled with coal.”)

But to PREPARE for Christmas is not the purchase of presents ... but rather a realization of how we as individuals COMPROMISED this Christ in us! How we have HALF-HEARTEDLY seen Christ in the “least of our brothers and sisters.”

Remember the words of Sacred Scripture: “I was hungry ... thirsty ... naked ... homeless ... sick ... in prison ... and you cared for me.” “What you did to the least of my brothers and sisters you did to me.”

Advent – PREPARING for Christ’s coming – is a time to remove the obstacles that keep us from being ENTHUSIASTIC in our faith, from being SELF-CENTERED ... omitting our love for others of family and neighbors.

Advent is a good time to consider how MATERIALISTIC we are – tying ourselves to possessions (more and bigger).

While we might “give up” candy, movies and the Internet, smoking, alcohol, not eating to loss weight, vulgarity, we might add St. Paul’s admonition regarding immorality ... impurity ... enmity ... jealousy ... hostility ... greed ... laziness ... thoughtlessness ... compromise faith and love.

And perhaps for many of us ... the life of being “TOO BUSY.”

But that leaves us empty – unless we consider the positive Pauline words: generosity ... zeal ... courage ... gentleness ... support to the suffering ... the sick ... the poor ... the lonely ... the rejected ... even the confused ... and the proud.

Simply the courage to burn and be thoroughly spent in love as we consider God’s gift to us: He touched you and me that we might touch others ... even when it hurts ... to enter the place of another’s pains ... to share in others’ brokenness ... confusion ... fear ... anguish.

Gods’ gift to each of us is to Heal ... TO BRING peace ... AND IN humility TO ACCEPT God’s gift of our lives and talents, as we can reach out to others.

We bring HOPE through our talents ... time ... treasure. And so we are not better when someone is not grateful ... not jealous that someone is better off ... not to revenge a wrong ... not to feel undue disappointment.

Our gift of welcome: not only to our own relatives ... but to consider the needy ... the loveless ... the marginalized.

Our gift of availability ... to the elderly ... to the young ... to walk with someone who physically, mentally, or spiritually needs you.

Our gift of listening ... with compassion ... respect ... in a sense to suffer with another.

Our gift of fidelity ... understanding ... tolerance ... forgiveness.

Advent is a fresh turning to Christ ... not waiting to see the nativity crib ... but to see Christ in the downtrodden.

So to have a richer fullness of our Christian existence ... an exuberant joy in what we believe.

Let Christ be in you and me ... it will be a MERRIER Christmas.

Illuminate the World

The eight days of Chanukah begins Sunday night December 6 and ends Sunday night December 13.



Excerpt of a letter from the Lubavitcher Rebbe, Rabbi Menachem M. Schneerson

Chanukah, the Festival of Lights, recalls the victory – more than 2100 years ago – of a militarily weak but spiritually strong Jewish people over the mighty forces of a ruthless enemy that had overrun the Holy Land and threatened to engulf the land and its people in darkness.

The miraculous victory – culminating with the dedication of the Sanctuary in Jerusalem and the rekindling of the Menorah which had been desecrated and extinguished by the enemy – has been celebrated annually ever since during these eight days of Chanukah, especially by lighting the Chanukah menorah, also as a symbol and message of the triumph of freedom over oppression, of spirit over matter, of light over darkness.

It is a timely and reassuring message, for the forces of darkness are ever present. Moreover, the danger does not come exclusively from outside; it often lurks close to home, in the form of insidious erosion of time-honored values and principles that are at the foundation of any decent human society. Needless to say, darkness is not chased away by brooms and sticks, but by illumination. Our sages said, “A little light expels a lot of darkness.”

The Chanukah lights remind us in a most obvious way that illumination begins at home, within oneself and one’s family, by increasing and intensifying the light of Torah and Mitzvos in the everyday experience, even as the Chanukah lights are kindled in growing numbers from day to day. But though it begins at home, it does not stop there, such is the nature of light that when one kindles the Chanukah lights are expressly meant to illuminate the “outside,” symbolically alluding to the duty to bring light also to those who, for one reason or another, still walk in darkness.

What is true of the individual is true of a nation, especially this great United States, united under G-d, and generously blessed by G-d with material as well as spiritual riches. It is surely the duty and privilege of this Nation to promote all the forces of light both at home and abroad, and in a steadily growing measure.

Let us pray that the message of the Chanukah lights will illuminate the everyday life of everyone personally, and of the society at large, for a brighter life in every respect, both materially and spiritually.

Go to www.bbb.org to obtain free Business Reviews on any store you are planning to shop at this holiday season. The BBB also recommends shoppers bring the ads to the store on Black Friday and to also become familiar with the store's return policies.

"Finding exceptional bargains and deals drives many consumers to stores and online retailers – however, both have their own set of risks," said Steve J. Bernas, president & CEO of the Better Business Bureau serving Chicago and Northern Illinois. "Taking steps to avoid the fraud in both situations will result in a much happier holiday experience for everyone-except, of course, for scammers and hackers."

Following are the top 10 online shopping tips for holiday shoppers to help fight deceitful online retailers, scammers and hackers during the season:

1. Protect your computer - A computer should always have the most recent updates installed for spam filters, anti-virus and anti-spyware software and a secure firewall.

2. Shop on trustworthy websites - Shoppers should start with the BBB to check on the seller's reputation and record for customer satisfaction at www.bbb.org. Always look for

the BBB seal and other widely-recognized "trustmarks" on retailer websites and click on the seals to confirm that they are valid.

3. Protect your personal information - The BBB recommends taking the time to read the site's privacy policy and understand what personal information is being requested and how it will be used. If there isn't one posted, it should be taken as a red flag that personal information may be sold to others without permission.

4. Beware of deals that sound too good to be true - Offers on websites and in unsolicited e-mails can often sound too good to be true, especially extremely low prices on hard-to-get items. Consumers should always go with their instincts and not be afraid to pass up a "deal" that might cost them dearly in the end, and look up the company at www.bbb.org.

5. Beware of phishing - Legitimate businesses do not send e-mails claiming problems with an order or an account to lure the "buyer" into revealing financial information. If a consumer receives such an e-mail, the BBB recommends picking up the phone and calling the contact number on the website where the purchase was made to confirm that there really is a problem with the transaction.

6. Confirm your online purchase is secure - Shoppers should always look in the address box for the "s" in <https://> and in the lower-right corner for the "lock" symbol before paying. If there are any doubts about a site, the BBB recommends rightclicking anywhere on the page and select "Properties." This will let you see the real URL (website address) and the dialog box will reveal if the site is not encrypted.

7. Pay with a credit card - It's best to use a credit card, because under federal law, the shopper can dispute the charges if he or she doesn't receive the item. Shoppers also have dispute rights if there are unauthorized charges on their credit card, and many card issuers have "zero liability" policies under which the card holder pays nothing if someone steals the credit card number and uses it. Never wire money and shop locally.

8. Keep documentation of your order - After completing the online order process, there may be a final confirmation page or the shopper might receive confirmation by e-mail. The BBB recommends saving a copy of the Web page and any e-mails for future reference and as a record of the purchase.

9. Check your credit card statements often - Don't wait for paper statements; the BBB recommends consumers check their credit card statements for suspicious activity by either calling credit card companies or by checking statements online.

10. Know your rights - Federal law requires that orders made by mail, phone or online be shipped by the date promised or, if no delivery time was stated, within 30 days. If the goods aren't shipped on time, the shopper can cancel and demand a refund. There is no general three-day cancellation right, but consumers do have the right to reject merchandise if it's defective or was misrepresented. Otherwise, it's the company's policies that determine if the shopper can cancel the purchase and receive a refund or credit.

Urban Wildlife Coalition:

Creating a Wildlife Winter Wonderland

Winter can be brutal for urban wildlife. Temperatures plummet and food and water sources become scarce. Attract them to your yard by providing them with creature comforts.

Leave the leaves – if you don't mind your yard a bit untidy, wildlife use the fallen leaves for food and shelter.

Create your own wildlife sanctuary – a small brush pile, set in a corner away from your home is refuge for many birds, chipmunks, rabbits, and other ground-dwelling animals. Set larger logs and branches at the bottom of the pile. Add twigs with leaves and other vegetation toward the top. Be sure to keep nooks and crannies open for easy entrance and exit.

Re-invent decorating the Christmas tree. Craft your own edible (for wildlife) ornaments to hang from your outdoor tree or shrub. Kids love this activity! Gather fallen pine cones. Snugly tie string or tall grasses around a pine cones so they can hang. Coat pinecones with peanut butter (syrup and honey work, too) and roll in a pile of bird seed, dried berries, or unsalted black sunflower seeds. Hang from a tree or shrub branch. Your wildlife friends will thank you!

Break the ice. During the winter, water is a hot commodity for wildlife. Make it a practice to regularly pour warm water in your bird bath to melt the ice... or better, add a birdbath heater to your holiday wish list.

Holiday Safety Tips Regarding Children and Food Safety

The holidays are an exciting time of year for children and families. To help ensure they have a safe holiday season, here are just a few tips from the Skokie Fire and Police Departments as published in the American Academy of Pediatrics (AAP) regarding toy, food and visiting safety:

Toy Safety

- Select toys to suit the age, abilities, skills and interest level of the intended child. Toys too advanced may pose safety hazards for younger children.
- Keep batteries and magnets away from young children and call your health care provider immediately if your child swallows one.
- Children under age eight can choke or suffocate on uninflated or broken balloons. Remove strings and ribbons from toys before giving them to young children.
- Watch for pull toys with strings that are more than 12 inches in length.
- Parents should store toys in a designated location, such as on a shelf or in a toy chest, and keep older kids' toys away from young children.

Food Safety

- Wash your hands frequently, and make sure your children do the same.
- Bacteria are often present in raw foods. Fully cook meats and poultry, and thoroughly wash raw vegetables and fruits.
- Be sure to keep hot liquids and foods away from the edges of counters and tables, where they can be easily knocked over by a young child's exploring hands.
- Never put a spoon used to taste food back into food without washing it.
- Always thaw meat in the refrigerator, never on the countertop.
- Foods that require refrigeration should never be left at room temperature for more than two hours.

- Remember that the homes you visit may not be childproofed. Keep an eye out for danger spots and clean up immediately after a holiday party.
 - Keep a list with all of the important phone numbers you or babysitters are likely to need in case of an emergency. Include the police and fire department, your pediatrician and the national Poison Help Line, 1-800-222-1222.
 - Maintaining your child's usual routines, including sleep schedules and timing of naps, can help you and your child enjoy the holidays and reduce stress.

Keeping Your Home Safe For Your Pets During The Holidays

The holidays are joyous and active times for people and their pets. Our pets partake in many of the seasonal festivities with us which makes the holidays that much more special. However, many of the decorations and objects we have around the household during the holidays may be dangerous to our pets. By taking a few precautions, we can make this wonderful time of year a safe one for our pets.

Holiday Food/Cooking

Food is a very important aspect of our holiday celebrations as many human waistlines can attest. Unfortunately, many of these foods can cause serious problems in our pets and as any veterinarian will tell you, this is the time of year that we see numerous gastrointestinal problems in pets.

Food Preparation -The preparation of food can be a problem, especially for pet birds. Birds have a very effective respiratory tract and coupled with their relatively small size are susceptible to toxic elements in the air. During cooking if food burns or smoke is produced, any birds nearby the kitchen could be at risk of fatal smoke inhalation. If non-stick cookware is used there is another risk for pet birds. Under normal cooking conditions, the cookware is safe but if polytetrafluoroethylene (PTFE) coated products (such as Teflon, Silverstone, and Supra) are overheated (over 530 degrees F), they can emit toxic fumes which are fatal to birds. PTFE coated drip pans achieve high temperatures under normal usage so they should not be used around birds at all. If your bird has been exposed to smoke or fumes get them to an area of good ventilation and seek veterinary care.

Holiday Food/Leftovers -Avoid the temptation to feed your pets leftovers from your holiday meals. Many of these foods are rich; especially those that are high in fat, and can often cause severe gastrointestinal disturbances in pets which could prove fatal. Inflammation of the pancreas (pancreatitis) is a very common disease of dogs and is frequently caused by the eating of table scraps.

The pancreas plays a role in digestion of food but when an animal eats a rich or fatty meal, the pancreas is 'overstimulated' and the organ oversecretes enzymes leading to inflammation of the pancreas and surrounding tissues. Signs of pancreatitis include vomiting and abdominal pain, sometimes quite severe. The condition is very uncomfortable for the pet and sometimes can be fatal. If you notice these type of symptoms seek veterinary care.

Walnut Cake "Karithopita"

1/2 cup butter	2 cups of sugar	1 tbs. lemon juice
1 tsp. soda	2 cups chopped walnuts	1 1/2 cups dry bread crumbs
1 cup sugar	1 cups of water	1 tbs. orange juice
2 tbs. cognac	1 tsp. cinnamon	1 1/2 cups flour
5 eggs	2 tbs. cognac	1 cinnamon stick
Syrup:	1/4 tsp. ground cloves	3 tsp. baking powder
1 cup milk		

Preheat the oven to 350°F. Butter and flour a 13 x 9 baking pan. In a bowl combine the walnuts, cinnamon, cloves, breadcrumbs, flour, and baking powder. In a small glass, dilute the soda with the cognac. In a large bowl of a mixer, cream the butter with the sugar and then add the eggs. Mix in the soda with cognac, and add the milk and the walnut mixture, beating until well combined. Spread into the prepared baking pan. Bake for 45-60 minutes, or until the center is firm. Prepare the syrup by mixing all the ingredients together in a medium sauce pan. Bring it to a boil and pour it over the baked cake. Let the cake cool completely before serving.

Apricot Bar Cookies

A number of years ago, our family received a big plate of these bar cookies from a good friend, Fran. I asked her if she would share the recipe with me, and she agreed. The Apricot Bar Cookies are absolutely yummy and easy to make. Add them to your "Cookies" file folder.

Ingredients: 1 cup butter, 2 cups sifted flour, 1 cup sugar, 1 cup chopped walnuts, 2 egg yolks and 1 – 12 oz. jar apricot preserves.

Method: Cream butter and sugar until light and fluffy. Add yolks, blend well. Then add the flour and nuts and mix until blended. Grease and flour a 9 x 13" pan. Spread half of the mixture with fingers into the pan (flour on your hands helps). Spread the preserves to 1/4" from the edges, then cover with the remaining flour mixture. Bake in a 350 degree oven for about 45 minutes. Cut into small squares while warm. Sprinkle with confectioner's sugar if desired.
