Special Olympics Illinois and Six Flags Great America Team Up for Brand New Fundraiser on September 28

Special Olympics Illinois will host a brand new fundraising initiative on September 28, 2014 at Six Flags Great America called The 2014 Coaster Challenge. Participants simply register, fundraise and ride the distance of a 5K, 10K or Marathon (26.2 miles) on Six Flags Great America's world-class roller coasters.



To be a RAGING BULL,

they'll need to raise \$100 and ride a total of a 5K (16,405 feet), or about six rides depending on which ones. If they have the heart of GOLIATH and want to do a little more they can raise \$250 and ride a total of a 10K (32,810 feet). For those that have the DEMON in them, they can go for the Marathon! Fundraising a minimum of \$1,000 and riding a full 26.2 miles!

Fall Bridge Lifts To Begin This Weekend

27 Bridges Lifted in Order from Lake Shore Drive to Ashland Avenue

The lifting of the movable bridges over the Chicago River for recreational boat traffic resumes this week, running on Wednesday and Saturday mornings through mid-November.

Each year in the spring and fall, the Chicago Department of Transportation (CDOT) raises the movable bridges along the Main and South Branches of the Chicago River to accommodate recreational boats traveling to and from their storage yards.

"The lifting of Chicago's iconic movable river bridges every fall marks the closing of the boating season," said CDOT Commissioner Rebekah Scheinfeld. "The City coordinates with local boat storage yards each year to create a schedule that ac-

commodates boats while creating the least amount of impact on downtown street traffic."

During these spring and fall "boat runs," the bridges are raised sequentially, typically one at a time. Each bridge lift takes an average of 8-12 minutes. This fall, 27 bridges will be lifted in order beginning in the morning at Lake Shore Drive to the Ashland Avenue Bridge on the South Branch.

Proof of Skokie residency is required.

If a resident has Medicare Part B, they are asked to bring their Medicare card so the Health Department can bill for reimbursement of the shot.

Influenza is a contagious respiratory illness caused by different influenza viruses. Older people, young children and people with certain chronic health conditions are at high risk for serious flu complications.

The best way to prevent influenza is by getting vaccinated each fall and following these sensible precautions:

- Clean your hands frequently.
- Cover your coughs and sneezes.
- Stay home from work or school if you are sick.

Mayor Rahm Emanuel Launches Online Community Forum To Engage With Chicago Residents

Mayor Rahm Emanuel today announced the launch of CHIdeas, an online community forum to engage Chicago residents and businesses in a discussion on how to improve services at City Hall, create programs and initiatives in our neighborhoods, and enhance quality of life across the city. Similar to portals used by the administration during the transition and budget processes, CHIdeas will provide a structured platform to seek ideas from the public and promote community dialogue around key issues.

The City will pose specific questions on the site and ask residents to respond with constructive ideas and solutions and comment on other ideas from fellow residents. In the past, resident ideas have helped cut the structural deficit and streamline City processes. More than 2,500 ideas and 7,000 comments were posted by 3,000 people on the budget portal, including ideas that were implemented, such as publicly posting City employee salaries to increase transparency and cracking down on free handicap parking abuse. Most recently, the Minimum

Wage Working Group developed their recommendations to implement a citywide minimum wage of \$13 per hour, following six weeks of research, analysis, and public engagement that included five public meetings across the City and more than 200 comments submitted online.

"Solutions don't just come from government — they come from our residents who live, work, and play in Chicago," said Mayor Emanuel. "CHIdeas is another way we can hear directly from the public and also provide an opportunity for residents to engage directly with each other to improve our great city."

CHIdeas will launch with the following four questions pertaining to minimum wage, early learning programs, library services, and public art installations:

Minimum Wage: The minimum wage in Illinois is \$8.25/hour. What do you think would be a sufficient minimum wage for Chicago, and why?

Early Learning: What programs and opportunities will provide support for our

youngest learners?

How Libraries Can Strengthen Communities: How can your local Chicago Public Library play a role in strengthening your community?

Public Art: How do you define public art, and how can it enrich our community?

"This is yet another example of Mayor Emanuel's innovative efforts to hear firsthand from residents across Chicago," said Craig Chico, Back of the Yards Neighborhood Council. "Members of my community welcome the opportunity to engage in a direct dialogue with their fellow residents

on ways to improve our neighborhood and the city."

Any visitor to the site will be able to view the questions, comments, and dialogue posted. In order to post on the site, residents will be required to register using their name and email address or can sign up directly via their Facebook, LinkedIn, or Google accounts. New questions will be added to the site regularly and residents are encouraged to check back often.

National Veterans Art Museum Reopened The Things They Carried

The National Veterans Art Museum (NVAM) has re-opened its exhibit The Things They Carried—the newest exploration of the Vietnam experience—as told by those who were there. The re-imagined The Things They Carried will be on display in a new gallery space to provide a more interactive, comprehensive virtual experience.

Inspired by Tim O'Brien's book of the same name, this exhibit serves as a visual companion that illustrates the narrative with fine art and photography from veterans that lived the stories in the novel. Much like the book, the exhibit explores the concept of storytelling and questions how one might share the story of the Vietnam experience. The exhibit takes as its central question "how to tell a true war story" and prompts viewers to consider their personal stories and contemplate how they might share their own narratives.

By literally incorporating the essential elements of storytelling: Who, Where, When, and What, The Things They Carried begins by chronicling the Vietnam conflict through first-hand visual accounts and descriptions. The exhibit culminates in the re-creation of an authentic Vietnam-era tented shelter to bring viewers into the intimate physical experience of sleeping, living and working in the field during that time.

With artworks and objects created and collected by over twenty Vietnam veteran artists, The Things They Carried also provides visual interpretations to viewers, illustrating the war by those who were there. This form of pictorial storytelling offers insights into the individual personalities of those who served, where they were in Vietnam both geographically and environmentally, and what the cultural climate of the time looked like. Representations and artifacts come together in The Things They Carried to offer an individualized and holistic presentation of the social and historical context of the Vietnam war.

With didactic guides and lesson plans that accompany the artwork and artifacts, visitors of all ages can gain a better understanding of "how to tell a true war story" as explored in Tim O'Brien's book, as well as explore possibilities and benefits of personal storytelling.

Featured artists include László Kondor, Dean Sharp, Charles Shobe, William Myles, James McJunkin, John Hosier, Michael Harac, and Arthur Jacobs.

The National Veterans Art Museum is partially supported by a grant from the Illinois Arts Council Agency.

Cole Porter and More

Of the great composers / songwriters that have come from the Broadway stage, none are as beloved as Cole Porter. He was unique in that he was one of the few composers to write his own lyrics. And what lyrics they were. Even if people don't recognize his name, they recognize his tunes such as "Night and Day," "You're the Tops," and "Anything Goes." And he's responsible for dozens of phrases in our culture including "Birds do it,

bees do it," and "I get no kick from Champagne."

October is going to be an exciting month at Skokie Theatre because it's filled with Cole Porter. So, fasten your seat belts ... (no, that one isn't from him.)

First up, our favorite theatre historian, Charles Troy, is presenting his multi-media program "Cole Porter's Top Ten Love Songs and Top Ten Lust Songs" Wednesday, October 1 at 1:30 pm. Cole certainly knew the difference between the two, and Mr. Troy's presentation will examine the secret life that led him to write some of the most romantic and passionate songs of all times. Not only has this program been invited to the annual Cole Porter festival in his hometown of Peru, Indiana, but Mr. Troy will be a guest presenter on October 12 in San Francisco, CA at the premier performance of a new portfolio of Porter's songs that was recently discovered in Paris.



Is Equal Always Fair in an Estate Plan?

When you were raising your family you probably heard, "It's not fair" many times. Your sixteen year-old got to stay out until midnight on weekends and didn't have to be home right after school. Your fourteen year-old had to be in by 10 p.m. and had to be home right after school. Because your sixteen year old was older and more mature and since she had more responsibilities—she was assistant editor of the student newspaper, she was ready for more privileges. Was this equal treatment? Your fourteen year-old would say, "No." But, it probably was fair.

It doesn't necessarily get easier to resolve the "fair versus equal" dilemma as your family matures. This has complicated many an estate plan. Let's say you have three children and Mitchell is a successful partner in an accounting firm, Marcia is a doctor, and Richard has worked with you for years to help make your business the thriving success that it is today. Richard is great at his work—actually better than you are and loves what he does. Here is your problem: how do you divide your estate? The common sense decision is to leave the business to Richard. But that would mean that the major portion of your estate would go to Richard and leave Mitchell and Marcia with what was left—and that is neither fair nor equal.

What if you gave an equal portion of the business to each child? Mitchell and Marcia have their own successful careers and have zero interest in running another business. And three equal owners could cause all sorts of pressure and conflict on the part of Richard, who would be saddled with the day to day business of keeping the business profitable. An unhappy outcome of this decision could mean destroying the family harmony you were so proud of when you were alive.

Here's another possibility: leave the business to Richard, and buy a life insurance policy on yourself for the benefit of Mitchell and Marcia. The life insurance policy would increase your net worth in an amount sufficient to fund Mitchell and Marcia's inheritances and ensure your children are treated fairly and meeting their individual needs.

Probably a more common situation is when one child devotes his or her life to taking care of ailing parents. In some cases they have given up most of their personal life, devoting themselves to the care of the parent or parents. A second child has no time for his parents, away at holidays and only grudgingly coming to visit on special occasions. Would it be fair to divide everything in your estate in half—forcing the sale of the home where your caretaker child has lived so that you would have 24/7 care? Leaving him or her to find another place to live after all the years spent taking care of you. A properly crafted Living Trust could leave the house to your caretaker child and divide the remainder of your estate as you wished. Your trust could stipulate that if anyone contests the terms of the trust, they receive nothing.

This is just one solution for your dilemma. An experienced estate planning attorney can help you explore all your estate planning options and settle on the plan that best meets your family's needs so you'll never again have to hear, "It's not fair!"

Saturday, September 27, 2014 is National Prescription Drug Take Back Day. The Drug Enforcement Agency (DEA) sponsors this effort at many locations throughout the metropolitan area, including two Village maintained drop-off locations in Skokie.

The Village of Skokie offers an expanded Drug Collection/Disposal program to prevent prescription drug abuse and help the environment. There is a white drop-off box in the lobby of the Skokie Police Department, 7300 Niles Center Road, for residents to dispose of unwanted, unused and expired medication at any time. This location offers 24-hour secure monitoring, collection and delivery to medical waste facilities in accordance with federal regulations.

Accepted drugs include prescription medications, controlled substances, all over-the-counter medications (i.e. pain relievers, cold medication, etc.), medication samples, pet medications, vitamins and supplements, medicated ointments, lotions, creams and oils, liquid medication in leak-proof containers and homeopathic remedies.

This program does not accept needles/sharps, syringes with needles, thermometers, IV bags, bloody or infectious waste, personal care products, empty containers and hydrogen peroxide.

Since May 2007, the Skokie Health Department, 5127 Oakton Street, has accepted medications and used syringes/needles in puncture-proof containers. The Skokie Health Department drop-off convenience is available from 8:30 a.m. to 5 p.m. Monday through Friday. The Skokie Health Department is unable to accept controlled substances and non-prescription liquids.

Reduce Your Risk for West Nile Virus

The Skokie Health Department is alerting residents that the risk of human infection with West Nile Virus (WNV) persists throughout the Community. Recently a dead bird found in Skokie tested positive for WNV.

Residents are urged to take precautions to prevent mosquito bites:

- Stay indoors at dawn, dusk or early evening.
- Wear long-sleeved shirts and long pants whenever you are outdoors.
- Spray clothes with repellants containing DEET and apply very sparingly on exposed skin.

Eliminate mosquito breeding areas in the following manner:

- Remove standing water where mosquitoes can breed.
- Change the water in birdbaths and plant pots at least once a week.
- Empty plastic pools at the end of each day.
- Keep grass and shrubbery cut short.
- Keep gutters clean and free-flowing.
- Don't let water stand on flat roofs.
- Clean and maintain any catch basins that may be on the property.

If you find a dead bird, it is important to contact the Skokie Health Department to collect the bird for testing to determine the extent of WNV activity. To report a dead bird, please call 847/933-8484.

For more information on WNV or to report potential mosquito breeding sites, please contact the Skokie Health Department at 847/933-8484 or the North Shore Mosquito Abatement District (NSMAD) at 847/446-9434. NSMAD will treat catch basins for mosquito larvae.

City Officials Cut Ribbon On Two New Playgrounds As Part Of 2014 Chicago Plays! Playground Program

Ribbons were cut at two rehabbed playgrounds in the city's 40th Ward: Green Briar Park, 2650 W. Peterson and Ronan Park, 3000 W. Argyle Street. These are two of 103 playgrounds to be built or rehabbed this year; 59 have already been completed.


"Mayor Emanuel's Chicago Plays! plan was established to provide vibrant, accessible playgrounds to children across the city," said Chicago Park District General Superintendent Kelly. "More than places to play, these facilities contribute to our children's social and cognitive development and serve as a gathering place for neighboring families. We are thrilled to have the opportunity to renovate more playgrounds and impact more communities than expected this year."

In March, 2013, Mayor Emanuel announced that over a five year period, the Chicago Park District will rebuild, repair and/or refurbish 325 playgrounds in communities across Chicago. Last year, 50 playgrounds were completely rehabilitated as part of Mayor Emanuel's Chicago Plays! playground renovation program. An additional 11 soft surface playgrounds were rehabbed by the Park District.

In order to prioritize equipment replacement, the Chicago Park District worked with the Friends of the Park organization to seek community input and determine those playgrounds in greatest need of repair.

Mayor Emanuel's Chicago Plays! program invests over \$125,000 in new playgrounds equipment at each park location for an estimate program cost of \$37,500,000, allowing to provide a broader investment in capital projects throughout the city. The program underscores major announcements the Mayor has previously made regarding parks, including a comprehensive plan to build and improve parks throughout the city so that every Chicagoan in within a ten minute walk of a park.
