GET READY, GET SET... FLY! 16TH ANNUAL CHICAGO KIDS AND KITES FESTIVAL RETURNS TO LINCOLN PARK ON MAY 3



Cook County, Ill. Cracks Down on Puppy Mills

County Council applauded for steps to increase adoptions of homeless animals

The Cook County Council passed an ordinance to restrict the retail sale of dogs, cats and rabbits obtained from large-scale commercial breeders. The ban will go into effect Oct. 1. Chicago also passed a similar ban in March. Kristen Strawbridge, Illinois state director of The Humane Society of the United States, issued the following statement:

"Cook County is taking a step forward for the humane economy and a stand against pet overpopulation and puppy mills. This rule will help end the euthanasia of thousands of animals every year in the state. This ban will help drive the market toward adoptions of homeless animals from shelters and rescue groups, and increased sales for small, responsible breeders who meet standards of animal care."

Boat Area Access Program Grants Totaling \$715,200 Awarded to Six Communities

Grants will help provide additional access for recreational boating

Illinois Department of Natural Resources Director Marc Miller today announced 2014 Boat Access Area Development grants totaling \$715,200 were awarded to six communities. The Natural Resources Advisory Board reviewed grant requests totaling \$1.22 million and recommended awarding nearly all of the \$725,000 appropriated for FY2014. The Boat Access Area Development Program provides financial assistance to local government agencies for the acquisition, construction, and expansion or rehabilitation of public boat and canoe access areas on Illinois' lakes and rivers. The program provides up to 100 percent of approved project construction costs and 90 percent of approved land acquisition costs. There is a limit of \$200,000 per project per year.

Applications must be received between July 1 and September 1 each calendar year.

Revenue for this program is derived from marine motor fuel tax and boat and canoe registration fees.

Communities receiving grants include:

- **Village of Machesney Park in Winnebago County:** \$200,000 to construct a boat ramp and dock. The project will improve access for the public and help local law enforcement respond more quickly to emergencies.
- **City of Evanston in Cook County:** \$200,000 to construct an extension for the Church Street Boat Ramp to upgrade the facility and improve safety. The ramp provides Lake Michigan access for powerboats, sailboats, personal watercraft.
- **City of Oglesby in LaSalle County:** \$152,225 to construct a safe and accessible launch along the Vermilion River. A parking lot will be constructed for cars and vehicles with trailers.
- **City of Galena in Jo Daviess County:** \$80,000 to construct canoe and kayak access to the Galena River. The project includes adjacent parking and loading/unloading area.
- **City of Freeport in Stephenson County:** \$64,600 to build an accessible floating dock and canoe/kayak launch along the Pecatonica River Water Trail.
- **Dixon Park District in Lee County:** \$18,375 to build a boat ramp extension to provide safe access to the Rock River during times of low water.

Mayor Emanuel Announces Additional 13 Miles Of Resurfacing Of City Arterial Streets To Counter Winter's Toll

Nearly 350 Miles of Chicago Streets and Alleys to be Resurfaced In 2014; \$15 Million Added for Additional Street Resurfacing and Repair

Mayor Rahm Emanuel today announced that the City would add \$15 million in funding to add 13 more miles to the 2014 arterial street repaving plan and bolster a program to perform patching work on hundreds of streets across Chicago.

"With this additional investment to improve our infrastructure, we are Building a New Chicago and improving the quality of life in every community," Mayor Emanuel said. "We are increasing our workload, once again, to further combat the pothole-filled condition of many of Chicago's arterial streets caused by the extremely harsh winter weather."

Last month, the mayor announced that City agencies and private utilities plan to resurface a total of 333 miles of arterial and neighborhood streets and alleys in 2014. The additional funds will add to the overall program and provide flexibility for CDOT to respond more quickly to deal with the effects one of the worst winters in history.

The \$15 million for paving is surplus funding from the past several years that was available from federal grants. Repaving projects are eligible to be funded by these grants.

CDOT is using \$2 million to implement an expanded program of heavy duty patching for streets that do not need a full resurfacing, but have shown deterioration from winter.

In Mayor Emanuel's first term in office, nearly a quarter of Chicago's 4,600 miles of streets will have been resurfaced.

Under the mayor's Building a New Chicago infrastructure investment program, CDOT, the Department of Water Management (DWM), private contractors and utilities will have resurfaced more than 1,000 miles of streets from 2011 through 2014 (155 miles in 2011; 269 miles in 2012; 290 miles in 2013; and 346 miles in 2014).

DWM plans to increase their workload in 2014, to installing 85 miles of new water mains, 21 miles of new sewer mains, relining 51 miles of sewer mains, and install 15,000 new water meters. DWM will also repave 133 miles of roadway.

In 2014, CDOT plans to repave nearly 100 miles of arterial streets, 90 miles of residential streets and five miles of alleys. Gas, electric and telecommunication utilities are expected to repave 20 miles of streets as part of their infrastructure work.

With better coordination on infrastructure improvement projects through CDOT's Project Management Office, both departments and the utilities worked together to reduce the amount of project conflicts that would open up a street more than once. By setting new standards for restoring the public way after construction, the various utilities resurfaced more miles of Chicago streets.

In 2013, the City realized a savings of approximately \$14 million through the coordination of projects with utilities and the requirements that they fully restore the roadways after their construction projects.

Chicago City of Learning Launches 1000s of Free Programs for Chicago Youth to Learn and Earn

This summer youth between 4 and 24 will have thousands of opportunities to gain skills and earn recognition while they engage in their favorite summer activities through Chicago City of Learning (CCOL). The initiative brings together more than 100 Chicago city agencies, youth serving and community organizations offering free summer programs to the city's youth and provides digital badges to those who participate and gain skills through them.

Chicago City of Learning is an outgrowth of the 2013 Chicago Summer of Learning, a collaboration of the John D. and Catherine T. MacArthur Foundation, the Mozilla Foundation, DePaul University's Digital Youth Network and the City of Chicago. Last year 200,000 youth participated and were awarded 100,000 digital badges. This year more than 100 museums, theatres, universities and youth serving public and community organizations are participating and offering more than 1,000 programs, workshops and online learning opportunities – ranging from the performing arts and story-telling to design and making and from sports and wellness to community action.

Announced this Wednesday as the centerpiece of Mayor Emanuel's 2014 "Summer of Learning and Earning" and through information provided to every Chicago student through their schools, Chicago City of Learning also has spring programs and activities that families can access immediately.

From April 12 through May 10 the city's libraries, park district and dozens of museums and community organizations will participate in Mayor Emanuel's Spring Adventure – offering activities for youth 4 – 24 both online and at sites throughout the city.

On May 10 Chicago City of Learning will hold its second Destination: Chicago event, a city-wide festival of making and doing, where youth can create everything from 3-d printed objects to videos and apps, sample hundreds of summer programs and sign up onsite for the summer activities in which they wish to participate. The event will run from 11am to 4pm at Jones College Prep, located at 700 South State Street.

All information for the spring and summer programs is online, as is an Exploration Ticket which allows youth to document their participation in spring activities. Those who fill out the ticket and turn it in on May 10 will be eligible to win everything from tickets to sporting events to an iPad Mini through raffles to be held at Destination: Chicago.

"City of Learning turns our City into a campus with robust learning opportunities that challenge our children and help them explore new interests," Mayor Emanuel said.

"The Chicago City of Learning initiative enables youth to take advantage of the rich learning opportunities that the city has to offer, creating new pathways both in and out of the classroom," said Nichole Pinkard, DYN Founder and associate professor in DePaul University's College of Computing and Digital Media. "The CCOL model helps young people build a deep set of skills and knowledge in their areas of interest, enabling them to unlock opportunities for further learning, internships, and jobs."



CHICAGO AUTHOR STAN "TEX" BANASH TO DISCUSS ROADSIDE HISTORY OF ILLINOIS AT NORWOOD PARK HISTORICAL SOCIETY, ON APRIL 23

The public is invited to hear Chicago author Stan "Tex" Banash discuss his third book, *Roadside History of Illinois*, at 7:00 p.m., on Apr. 23, at the Norwood Park Historical Society, 5624 N. Newark Ave., in Chicago.

Banash will describe some of his research, explain several trip segments in each of the book's seven regions, and provide information on a number of significant historical happenings that shaped Illinois. The book itself begins with the Ice Age and carries readers to the present along old U.S. highways, state roadways and county roads, leading to the people, places and events that contributed to the state's development. It is the first book on Illinois history in more than 30 years and has been praised by former U.S. Sen. Adlai E. Stevenson III and Wayne C. Temple, Chief Deputy Director of the Illinois State Archives. Copies of the book will be available for purchase and inscription following the talk.

Active in his local community, Banash served as president of the Edison Park Chamber of Commerce and also chaired a local zoning advisory board. He graduated from Northwestern University with a Bachelor of Arts degree in Political Science, obtained a Master of Arts degree in Urban Studies from Roosevelt University and operated his own home-based public relations firm for more than 30 years. His two earlier books were *Best of Dee Brown's West* and *Dee Brown's Civil War Anthology*. He also reviews books for a number of western publications, and is a member of Western Writers of America, the Society of Midland Authors, Western History Association, and the Westerners—Chicago Corral, where he served as its sheriff for five years.

Bike Share System Celebrates Two Million Miles Ridden and Readies for Spring; "Divvy Week" to offer \$5 24-Hour Passes, Membership Incentives

Divvy, Chicago's bike share system, is fully prepared for the upcoming busy spring and summer cycling seasons by releasing 700 bikes that were in winter storage back into the system at its 300 stations.

In just nine months of operations, Chicagoans and visitors to the city have taken more than 900,000 trips and have collectively ridden an estimated two million miles, passing the milestone yesterday.

"This spring and summer, we expect even more Chicagoans and visitors to start using bike sharing as a transit option for getting around the city," said Mayor Rahm Emanuel. "Divvy has already been a great success, and with the improved weather comes the chance for more of us to get outside and ride a bike."

In an effort to encourage more Chicagoans to try Divvy for the first time or purchase an annual membership, Mayor Emanuel declared that April 21-27 would be "Divvy Week" in Chicago. During that week, all 24-hour passes, regularly \$7, will be available for just \$5. Chicagoans who sign up for new annual memberships would receive Chipotle gift cards, and other prizes and promotional discounts would be made available to current Divvy members.

The system typically keeps at least 2,500 of its 3,000 bikes out at one time, but reduced that number to 1,800 over the winter during the slower season. Once a month, Divvy bike checkers and mechanics put each bike through a routine maintenance check to ensure it's safe for riding.

"We're excited for the season ahead. Divvy wasn't even a transit option last April, so this is our first spring," said Elliot Greenberger, general manager of Divvy. "We've already developed a devoted group of annual members, but we anticipate a lot more residents and visitors giving us a try now that they've had a chance to see the system at work and the weather improving."

The spring weather comes as Divvy celebrates an estimated two million miles ridden since it launched just over nine months ago on June 28, 2013. In that time, 907,883 trips have been taken by more than 15,000 annual members and 140,000 24-hour pass holders. In the first week of April alone, riders took more than 25,000 trips as temperatures rose above 40 degrees.

In a recently conducted survey, Divvy annual members said they were highly satisfied with Chicago's new bike share service, and claim to save an average of more than \$760 a year on commuting expenses by riding a bike rather than using cars, taxis or other forms of transit.



Your Ex-spouse May Get Most of Your Assets

Divorce is relatively commonplace nowadays. According to the National Center for Health Statistics, there were 957,200 divorces in the United States in 2000. That means that more than 1.9 million Americans get divorced each year. According to the United States Census Bureau, approximately one-half of all marriages now end in divorce.

Imagine you have divorced many years ago and remarried. Perhaps you have children with your new spouse and have been happily married for years. However, you have not changed any of the estate planning documents you had done before. Then, your family's world crumbles as you are stricken by an accident or illness. You are unable to make health care decisions and your physician calls your

Agent under your existing Health Care Power of Attorney, who happens to be your ex-spouse. In some states the appointment of a spouse as Agent is not be revoked by a subsequent divorce. As Agent, your ex-spouse could make decisions regarding your health care – not a situation most of us would want to be in. Of course, this would only exacerbate the emotional distress your family would be going through.

If you did not survive, your family would be devastated by the loss. They would be left with an emotional and financial void left by your absence. Your spouse knows you had sufficient assets saved in your 401(k) plan. However, upon investigation, your spouse discovers that you had not changed the beneficiary designation. Surely the law would automatically change that? No. If the beneficiary designation still lists the ex-spouse, the assets go to the ex-spouse. With other assets, the divorce might serve to terminate the designation or the bequest to the ex-spouse. However, with 401(k) and other qualified plan assets, it does not.

Next, your spouse is relieved to discover that in your state bequests to an ex-spouse are invalidated upon divorce. Under the terms of your estate planning documents, your spouse finds the assets go to your children. Finally some good news. However, your spouse finds that the ex-spouse is named as trustee and that, in your state, such a designation is not revoked upon divorce. Thus, the ex-spouse now controls those assets, too.

Of course, this nightmare scenario can be avoided. After divorce, you can change your estate planning documents to remove your ex-spouse as a beneficiary, trustee, agent, etc.

41st Annual Bach Week Festival Slated for Evanston April 25, Chicago May 2 & 4

The 41st annual edition of the Chicago area's Bach Week Festival will offer four different concerts of Johann Sebastian Bach's music in Evanston and Chicago, April 25 to May 4, 2014, featuring soloists of international stature and several Bach compositions that have never been performed at the venerable music series.

Richard Webster will conduct the Bach Week Festival Orchestra and Chorus. Webster, who performed at Evanston's inaugural Bach Week Festival in 1974, has been music director since 1975.

This year's festival continues a partnership forged last season between Bach Week and Chicago's North Park University School of Music.

Evanston Concerts April 25

The festival gets underway at 7:30 p.m. on Friday, April 25, at Nichols Concert Hall, 1490 Chicago Ave., Evanston, with a back-by-popular-demand appearance by pianist Sergei Babayan, an artist in residence at the Cleveland Institute of Music. At his festival debut in 2013, the charismatic Russian-trained Armenian-born pianist impressed audiences, critics, and fellow musicians with his bracing and sensitively nuanced playing. The pianist and the orchestra will perform three of Bach's keyboard concertos, the Concerto in A Major, BWV 1055; and two that are new to Bach Week: the Concerto in D Major, BWV 1054; and Concerto in G Minor, BWV 1058.

Tenor William Watson, an internationally noted Bach interpreter, will be soloist in Bach's Cantata "Ich armer Mensch, ich Sündenknecht," BWV 55.

Following the season-opener concert, award-winning young Boston-based guitarist and Naxos recording artist Adam Levin, who was raised in north suburban Lake Bluff, Ill., will present a solo Candlelight Concert titled "Bach, Variations, and Witches" in the Nichols Hall lobby at 10 p.m. Levin's program will include Renaissance composer Girolamo Frescobaldi's "Aria Con Variazioni detta la Frescobalda"; J. S. Bach's Chaconne from the Partita No. 2 in D Minor, BWV 1004; and two 21st-century works: Ricardo Llorca's Baroque-inspired "Handeliana," consisting of variations on a theme by G. F. Handel; and Eduardo Morales-Caso's Suite "Il Sogno Delle Streghe" (Witches Dream).

Chicago Concerts May 2 & 4

The festival will head to Chicago in early May for a two-concert series at North Park University's Anderson Chapel, 5149 N. Spaulding Ave.

At 7:30 p.m. on Friday, May 2, Christopher Martin, principal trumpet of the Chicago Symphony Orchestra, and North Park University organist Margaret Martin will play Bach's Concerto in D Major, BWV 972, which has never been heard at the festival. In this version, the orchestral score has been transcribed for organ. The Violin Sonata in E Minor, BWV 1023; Brandenburg Concerto No. 6 in B-flat Major, BWV 1051; and Cantata "Vergnügte Ruh, beliebte Seelenlust," BWV 170, will round out the program.

The series-finale concert at 2:30 p.m. on Sunday, May 4, at North Park will include yet another work new to the festival, Bach's Mass in G Major, BWV 236. Chicago Symphony cellist and festival stalwart Katinka Kleijn will play the unaccompanied Cello Suite No. 5 in C Minor, BWV 1011. Other Bach fare will include the Orchestral Suite No. 3, BWV 1068; and Cantata "Nun is das Heil und die Kraft," BWV 50. The North Park University Chamber Singers will join forces with the Festival Chorus for the G-Major Mass and Cantata, BWV 50. The cantata is scored for double chorus and orchestra.
