#### **Remembering the Meaning of Veteran's Day**

Red, white, and blue circulars announcing 50% off all mattresses. No school! The gas station's flag flying at half mast. For too many of us, these are our Veteran's Day associations. For those of us not directly impacted by the war in Iraq, for those without friends and family who have served, it is far too easy to forget the meaning of this important day.

Veteran's Day began as Armistice Day to commemorate the end of World War I – optimistically coined "the war to end all wars." President Woodrow Wilson declared, "To us in America, the reflections of Armistice Day will be filled with solemn pride in the heroism of those who died in the country's service and with gratitude for the victory, both because of the thing from which it has freed us and because of the opportunity it has given America to show her sympathy with peace and justice..."

Though the War did not officially end until June 28, 1919, an informal armistice was signed at the 11th hour on the 11th day of the 11th month of the preceding year. For this reason, Veteran's Day falls on November 11. This was not always the case. Attempts were made to change the date so it would fall on Monday, making for convenient three-day weekends. Recognizing that this was not a holiday about a get-away to the Dells or shopping sprees at the mattress store, and realizing the significance of this important historic commemoration, President Gerald Ford responded to the American people and returned the holiday to November 11.

Most of us do not like war. But, we must separate those feelings from the gratitude we owe to those who have served. It is important that we take pause from our busy lives and imagine a day in the life of those in service – sleepless nights, grueling work, physical hardship, separation from loved ones, fear, and loss. It is important that we take a moment to thank the men and women who have made supreme sacrifices for our country. Come Wednesday, November 11, bake cookies for your local VFW; ask a veteran to share his or her remembrances of service; send a care package to our troops; gaze at the gas station's flag at half mast and remember exactly what that means.

### SOCIAL SECURITY HELPS VETERANS (AND ACTIVE DUTY MILITARY) EVERY DAY

November 11 is more than just a national holiday; Veterans Day is a time to honor the men and women who risk their lives to protect our freedom. We at Social Security ask you to join us in saluting the men and women of the armed forces. Be sure to say "thank you" to a veteran on this important day.

For those who return home with injuries, it will be our turn to help them. If you know any wounded veterans, please let them know about Social Security's Wounded Warriors website. You can find it at www.socialsecurity.gov/woundedwarriors.

The Wounded Warriors website answers a number of commonly asked questions, and shares other useful information about disability benefits, including how veterans can receive expedited processing of disability claims. It is important to note that benefits available through Social Security are different than those from the Department of Veterans Affairs and require a separate application.

The expedited process is used for military service members who become disabled while on active military service on or after October 1, 2001, regardless of where the disability occurs.

Even active duty military who continue to receive pay while in a hospital or on medical leave should consider applying for disability benefits if they are unable to work due to a disabling condition. Active duty status and receipt of military pay does not necessarily prevent payment of Social Security disability benefits. Receipt of military payments should never stop someone from applying for disability benefits from Social Security.

A person cannot receive Social Security disability benefits while engaging in substantial work for pay or profit. However, the work activity is the controlling factor and not the amount of pay the person receives or military duty status.

## Fall Beautiful Fall -Time To Prepare For Winter

The chill of the first cool nights of fall serves as a warning that the growing season is coming to an end. By all means, enjoy your

flowers for as long as the weather permits. We can even stubbornly GREENHOUSES since 1922 try to protect and cover animals from the onset of cooler temperatures. However, hard frosts will eventually take their toll. At this time I strongly urge gardeners to clean up all dead flowers and vegetable plants. This is the first step towards having a great garden next year.

Then I would suggest adding a two to three inch layer of an organic material to the soil. If you have a compost pile, this would be a good time to work in this material.

Another option is to work the leaves from your yard into the soil. Adding these materials will have several benefits. First, the organic matter will have a chance to further decompose during the long, wet fall and winter. As the organic material naturally breaks down, this will add nutrients to the soil for next years plants.

Second, really digging and working up the soil in the fall aerates and loosens it and prevents the ground from becoming too hard. This is very important because a loose soil allows plants to develop healthy roots systems.

None of this work is very glamourous, however conditioning and preparing soil is one of the most important keys to having success as a gardener. Next spring your flower and vegetable plants will benefit from growing in a nutrient rich, loose soil.

"MPC extends a hearty 'congratulations' to the Altgeld Sawyer Corner Farm, which has captured the hearts and minds of the people of Logan Square, as well as the most public votes on our web site," said Marisa Novara, MPC project manager. "We look forward to celebrating the people who make Altgeld Sawyer Corner Farm the great place it is – and all of the people and community groups that entered our contest, including two to-be-announced winners – at our Nov. 1 awards ceremony.

The Altgeld Sawyer Corner Farm, located in Chicago's Logan Square neighborhood, has been active since 2009 and has a hallmark of cooperating with local business and the nearby Christopher House. The Christopher House helps at-risk children thrive, and the farm provides produce and educational plots to the organization. The farm also grows plants specifically for papermaking and dyeing purposes, provides composting for the neighborhood, and is a "safe, open space [in] one of Chicago's most 'park-poor' communities." Open year-round, day and night, the farm welcomes all visitors. The \$1,500 prize from the Space in Between contest is significant, given that the farm runs on an average of \$1,000 per year. It's a relatively inexpensive, easily replicable, and highly effective temporary use of vacant space.

Altgeld Sawyer Corner Farm is one of 46 projects entered in the contest, including gardens, pop-up galleries and art installations, and children's play areas. View all of the submissions at PlacemakingChicago.com.

Two more entries will be chosen as winners by a panel of judges: a \$1,500 Grand Prize winner, and a \$500 Runner-up. All three winners will receive a coveted campaign from Groupon Grassroots, to earn more financial support for their projects.

MPC will announce the two juried winners and honor all three winners – as well as all of the creative Placemakers who entered the contest – at an awards ceremony on Thursday, Nov. 1, 2012, from 5 to 7 p.m., at the Metropolitan Planning Council, 140 S. Dearborn St., Suite 1400.

MPC encourages community organizations and individuals who want to turn vacant spaces in their neighborhoods into great places to attend the event, to network and trade ideas with these inspiring community leaders. That's what Ted and Emily thought. But, when Ted died, Emily found out how wrong they were. A Trust only controls the assets tilted into it, otherwise known as "funding the Trust." When Ted passed away, it was discovered that the Trust was still unfunded. This meant some assets were held in joint tenancy and passed to the surviving joint tenant, Emily. While other assets passed by beneficiary designation. Ted had still more assets in his own name. Those assets had to go through probate, the public and sometimes difficult process by which title is passed from a person who has died, through intestacy if there is no Will, or, in Ted's case via his Pour Over Will to the Trust.

Funding is the process of transferring title of assets into your Trust. Emily learned that planning is not enough; funding is also critical to an estate plan. An unfunded trust is the equivalent of a treasure chest without any gold in it. As part of your estate plan, a good estate planning attorney will instruct you on what and how assets get transferred into your Trust, or may include funding in the fee. Ownership of most assets should be transferred into your Trust. Exceptions are:

Retirement accounts, such as IRAs, 401(k)s, 403(b)s, etc. Doing so would have negative income tax consequences. In some circumstances you may want to change the beneficiary designation of these accounts to your Trust.

Custodial accounts, such as UTMA and UGMA accounts.

Life insurance. However, sometimes it is advisable to put this in a special irrevocable Trust in order to reduce estate taxes.

Motor vehicles. Depending on the state, it may be better to leave these outside the Trust.

Checking account. Sometimes people want to leave a small amount in a checking account for day-to-day transactions, especially if they want to protect their privacy and not disclose the existence of the Trust.

Most lenders require you to remove your home from your Trust before refinancing. If this becomes necessary, your estate planning attorney can prepare a deed from your Trust to you as an individual. Sometimes this is necessary if the lender plans to bundle and sell your loan. If you remove the home from the Trust, remember you can and should put it back in the Trust immediately after the loan closes. Failure to do so may unnecessarily add probate expenses or may even disrupt the plan you so carefully put together.

As with most things, it's important to see things through to the finish. In Estate Planning, that means making sure your Trust is properly funded. Planning and funding are both necessary for your estate plan to achieve your goals.

### THE HUNT IS AFOOT FOR MEDICARE PART D

By Andrew Salata, Social Security Public Affairs Hunting season is open. But rather than hunting for game, may we recommend setting your sights for the Part D Medicare prescription drug plan that's best for you? You'll have more time than usual this year, because open season is lasting longer than usual.

If you currently are enrolled in Medicare and are considering changes to your Medicare Part D plan, act now. The "open season" runs from October 15 to December 7. The Medicare Part D prescription drug program is available to all Medicare beneficiaries to help with the cost of medications. Joining a Medicare prescription drug plan is voluntary, and participants pay an additional monthly premium for the coverage.

While all Medicare beneficiaries can participate in the prescription drug program, some people with limited income and resources also are eligible for Extra Help to pay for monthly premiums, annual deductibles, and prescription co-payments. The Extra Help is estimated to be worth about \$4,000 per year. Many people qualify for these big savings and don't even know it.

To figure out whether you are eligible for the Extra Help, Social Security needs to know your income and the value of any savings, investments, and real estate (other than the home you live in). To qualify, you must be receiving Medicare and have:

Income limited to \$16,755 for an individual or \$22,695 for a married couple living together. Even if your annual income is higher, you still may be able to get some help with monthly premiums, annual deductibles, and prescription co-payments. Some examples where your income may be higher include if you or your spouse:

—Support other family members who live with you;

- -Have earnings from work; or
- -Live in Alaska or Hawaii; and

Resources limited to \$13,070 for an individual or \$26,120 for a married couple living together. Resources include such things as bank accounts, stocks, and bonds. We do not count your house or car as resources.

You can complete an easy-to-use online application for Extra Help at www.socialsecurity.gov. Click on Medicare on the top right side of the page. Then click on "Get Extra Help with Medicare Prescription Drug Plan Costs." To apply by phone or have an application mailed to you, call Social Security at 1-800-772-1213 (TTY 1-800-325-0778) and ask for the Application for Extra Help with Medicare Prescription Drug Plan Costs (SSA-1020). Or go to your nearest Social Security office.

And if you would like more information about the Medicare Part D prescription drug program, visit www.medicare.gov or call 1-800-MEDICARE (1-800-633-4227; TTY 1-877-486-2048). So this open season, hunt for something that could put an extra \$4,000 in your pocket — bag the best Medicare prescription drug plan for you and see if you qualify for the Extra Help through Social Security. That's a tro-phy worth displaying in your den.

#### LOCAL HIGH SCHOOL STUDENT COULD WIN A TRIP TO WASHINGTON, D.C. AND A \$30,000 SCHOLARSHIP

Commander Joseph Stachon of the Veterans of Foreign Wars (VFW) Department of Illinois, today announced the kick-off of the 66th year of the VFW and its Ladies Auxiliary Voice of Democracy Scholarship Competition. Local high school students have the opportunity to compete for thousands of dollars in scholarships and a trip to Washington, D.C.

Students begin by competing at the local Post level with a deadline of November 1st. Post winners advance to District and then the first place District winner advances to the State competition. All state winners receive a four day trip to Washington, D.C. A total of \$152,000 is awarded to national finalists. First place is \$30,000. Annually the VFW provides more than \$2.3 million in scholarships. Each year, around 50,000 students participate in the competition.

Students must write and record a three-to-five minute essay on this theme for 2012-2013, "Is Our Constitution Still Relevant?" on an audio cassette tape or audio CD and present their recording, typed essay, and entry form at their local VFW Post.
