70th Anniversary of Pearl Harbor

Honor the memory of the more than 2,400 Americans who died during the Japanese attack on the Pearl Harbor Naval Base in Hawaii on December 7, 1941, at a special ceremony at Oakton on Wednesday, December 7.

Sponsored by the Department of Historical and Policy Studies and Office of Veterans Coordinator, the event will feature Betsy Tolstedt, Ph.D., team leader of the Evanston Veterans Center representatives, who will speak on “Pearl Harbor: Life Changing - World Changing: The Impact of the Pearl Harbor Attacks in December 1941 and Beyond.”

The remembrance will take place at 12:30 - 2 p.m., at Oakton’s Skokie campus, 7701 North Lincoln Avenue (Room C120), and 5 - 7 p.m., at the College’s Des Plaines campus, 1600 East Golf Road (Room 1625). At the forums, Oakton students will read eyewitness accounts of the attack. The commemorations also will feature Oakton commentators Wendy Maier-Sarti, professor of history (Skokie), Jim Hold-erfield, history and political science instructor (Des Plaines), and Veteran and Work-force Specialist Vince Donahue Jr. (Des Plaines and Skokie).

LINCOLNWOOD APPROVES DONATION COLLECTION BIN REGULATIONS

The Lincolnwood Village Board adopted an Ordinance on September 20, 2011 to regulate the use of donation collection bins within the Village. Collection bins are metallic containers that are used to receive donations of a variety of used items including clothing, shoes, books, and other items. The items are then sold, donated, or recycled. Collection bins are operated by both non-profit and for-profit organizations. There are currently 22 collection bins at various sites throughout the Village.

The Village Board discussed regulating collection bins at the June 2, 2011 Committee of the Whole, as residents have expressed that there are too many collection bins within the village and that they are becoming an eyesore. At that time, the Village Board directed staff to research other municipalities that have adopted collection bin regulations. Staff presented the Village Board with the findings of their research at the August 18, 2011 Committee of the Whole. After reviewing the research, the Village Board directed the Village Attorney to prepare an Ordinance regulating collection bins.

The newly adopted Ordinance states that a limit of two collection bins per property are allowed in business districts and properties belonging to religious and public institutions. All bins must exhibit the name and phone number of the bin owner, and must be annually licensed by the Village. Bins are prohibited on required parking spaces, as well as sites with no operational and/or conforming use. Collection bins are not allowed to be placed against the front façade of any building. Collection bin owners that do not comply with the newly adopted ordinance, will be required to remove their bins.

CELL PHONES FOR SOLDIERS

Cell Phones for Soldiers was founded by teenagers Robbie and Brittany Berquist from Nowell, Massachusetts with \$21.00 of their own money. Since then, the registered 501c3 non profit organization has raised almost \$1 million dollars and distributed more than 500,000 prepaid calling cards to soldiers serving overseas. The donated phones are sent to ReCellular, which pays Cell Phones for Soldiers for each donated phone, enough to provide an hour of talk time to soldiers abroad with prepaid calling cards.

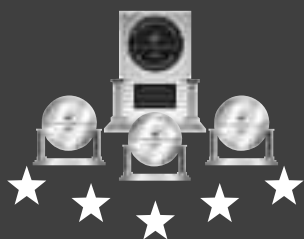

Quigley Launches Online Survey to Help Local Small Businesses

Congressman Mike Quigley (IL-05) launched a new online survey aimed at providing local entrepreneurs with the support and resources they need to successfully operate and expand their businesses.

“This survey is an opportunity for small business owners in Illinois’ Fifth District to offer firsthand insight on how the government can make running a small business easier,” said Congressman Quigley. “It’s important that the government do all it can to support small businesses, which are putting our friends and family back to work, revitalizing our neighborhoods, and providing the goods and services that keep America’s economy running.”

The survey asks small business owners to identify regulations that need reforming or streamlining, as well as any issues they face that impede operations and hinder success. It is accessible online at www.quigley.house.gov/smallbizsupport.

Protecting the interests of small businesses and local entrepreneurs has been a top priority for Rep. Quigley, who cosponsored the Private Company Flexibility and Growth Act (H.R.2167) introduced by Rep. Schweikert (R-AZ) in June. This bipartisan bill makes it easier for small businesses to grow and create jobs by easing SEC regulations that require companies with 500 or more employees to publicly disclose finances, often prompting them to go public before they are ready. Under H.R. 2167, the threshold would increase to 1,000 employees.

“Small businesses are the backbone of our economy, and the government should encourage their growth and success, not hinder it. I look forward to hearing ideas from those in my district on what I can do to make that happen,” said Rep. Quigley.

Winter Overnight Parking Ban Returns Thursday, December 1st

Watch For & Obey Posted Snow Restrictions

Chicago’s Winter Overnight Parking Ban, the seasonal parking restriction for 107 miles of the city’s most critical arterial streets, will resume on Thursday, December 1, 2011, at 3 a.m. The ban will be enforced from December 1, 2011 through April 1, 2012, between the hours of 3 a.m. and 7 a.m., regardless of snow.

Drivers who ignore the overnight ban prevent these critical routes from being fully plowed and salted when it snows. During a heavy snowfall, build-ups of snow next to parked vehicles on these routes further reduces the streets capacity to handle critical traffic.

“The overnight parking ban is in place during the winter to make sure that critical routes are up and running at all hours so that emergency vehicles, buses and other traffic can get through,” said Streets & Sanitation Commissioner Thomas G. Byrne.

Violators who ignore the ban face a \$150 towing fee (minimum), a \$50 ticket and a storage fee of \$10 per day that increases over time. 215 motorists were towed for violating the first day of the ban last winter. And despite heavy news coverage of enforcement efforts, 127 motorists ignored the posted restrictions and were towed on the second day.

The permanent signage that marks the Winter Overnight Parking Ban route is posted next to signs for the 2-inch Snow Parking Ban along 107 miles of the broader 500 mile long Snow Route System. The Snow Route System was created as a result of lessons learned from massive snow storms, including the Great Blizzard of ‘67.

While the 2” Inch Snow Ban can technically be activated at any time of the year, this restriction is not activated often and is only a factor during the winter months. Motorists who violate it face ticketing and relocation to a nearby site. Motorists need to watch for and obey both restrictions.

The input gained through the Dempster Area Plan web page will be used to prioritize the issues that are most important for the Village to address in the near term and in the future.

WAITING or PREPARING FOR CHRISTMAS

Catholics – and most Christians – begin the season of Advent (four weeks before Christmas). At the same time most people are WAITING for Christmas from Black Friday: see the great number of newspaper pages filled with pre-Christmas sales – sales for anything and everything. Some stores were opened from midnight or 3 a.m. ... and people were WAITING.

This followed with cyber Monday sales.

Is this the season to SHOP for CHRISTMAS?

Some wait to see the Nativity scene erected in the church or at its front lawn ... the Christ in the stable ... in the straw ... in a feeding trough.

But this is a reminder of that first Christmas Day ... yet Christ is present with us today!

How did Christmas Day become a day to exchange presents? Perhaps the custom of St. Nicholas (Santa Claus ... December 6th) and his generosity brought about the hanging of a "Christmas" sock and the children WAITING with joy for a sock full of candies and other "goodies." (Some might remember that some parents jokingly threatened: "If you didn't behave your sock might be filled with coal.")

But to PREPARE for Christmas is not the purchase of presents ... but rather a realization of how we as individuals COMPROMISED this Christ in us! How we have HALF-HEARTEDLY seen Christ in the "least of our brothers and sisters."

Remember the words of Sacred Scripture: "I was hungry ... thirsty ... naked ... homeless ... sick ... in prison ... and you cared for me." "What you did to the least of my brothers and sisters you did to me."

Advent – PREPARING for Christ's coming – is a time to remove the obstacles that keep us from being ENTHUSIASTIC in our faith, from being SELF-CENTERED ... omitting our love for others of family and neighbors.

Advent is a good time to consider how MATERIALISTIC we are – tying ourselves to possessions (more and bigger).

While we might "give up" candy, movies and the Internet, smoking, alcohol, not eating to loss weight, vulgarity, we might add St. Paul's admonition regarding immorality ... impurity ... enmity ... jealousy ... hostility ... greed ... laziness ... thoughtlessness ... compromise faith and love.

And perhaps for many of us ... the life of being "TOO BUSY."

But that leaves us empty – unless we consider the positive Pauline words: generosity ... zeal ... courage ... gentleness ... support to the suffering ... the sick ... the poor ... the lonely ... the rejected ... even the confused ... and the proud.

Simply the courage to burn and be thoroughly spent in love as we consider God's gift to us: He touched you and me that we might touch others ... even when it hurts ... to enter the place of another's pains ... to share in others' brokenness ... confusion ... fear ... anguish.

Gods' gift to each of us is to Heal ... TO BRING peace ... AND IN humility TO ACCEPT God's gift of our lives and talents, as we can reach out to others.

We bring HOPE through our talents ... time ... treasure. And so we are not better when someone is not grateful ... not jealous that someone is better off ... not to revenge a wrong ... not to feel undue disappointment.

Our gift of welcome: not only to our own relatives ... but to consider the needy ... the loveless ... the marginalized.

Our gift of availability ... to the elderly ... to the young ... to walk with someone who physically, mentally, or spiritually needs you.

Our gift of listening ... with compassion ... respect ... in a sense to suffer with another.

Our gift of fidelity ... understanding ... tolerance ... forgiveness.

Advent is a fresh turning to Christ ... not waiting to see the nativity crib ... but to see Christ in the downtrodden.

So to have a richer fullness of our Christian existence ... an exuberant joy in what we believe.

Let Christ be in you and me ... it will be a MERRIER Christmas.

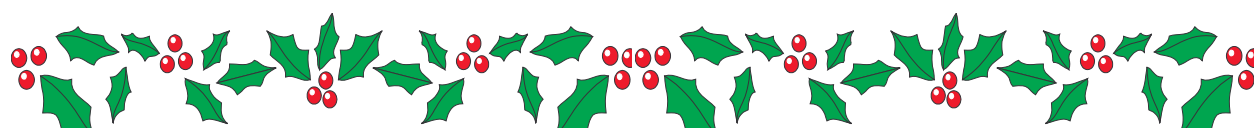

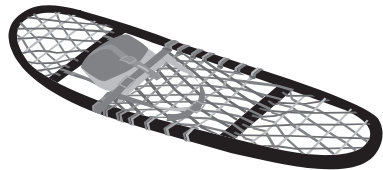

Mitchell Museum to Offer Holiday Craft Workshops For Kids

The Mitchell Museum of the American Indian in Evanston will offer its popular Kids Craft Morning weekend workshops with a new twist in December. Kids can make holiday- and winter-themed projects suitable as decorations and gifts -- a first for the program.

The seasonal projects will include making God's eyes of festive, holiday-colored yarns, ornamented with pompoms. Kids can make beaded key chains in a variety of designs including a winter snowflake. They can choose beads of Christmas red and green, or winter white and blue, or any combination. To usher in winter's arrival, participants can build small-scale models of Arctic inuksuit, sculptural stone monuments and landmarks erected by Inuit people of the Far North. Decisions, Decisions, Decisions . . .

When asked how people want their assets divided after they are gone, some people have definite opinions, while others are less certain. Not only do people differ in the level of their uncertainty concerning how to divvy up their assets, they even differ in what factors are important in making the decision.

In June 2007, *Money* magazine released a reader poll concerning various financial issues. The following percentages of respondents ranked each factor as very important:

Dividing the estate equally among your children: 69%

How responsible each child is about money: 37%

How helpful each child has been to you: 29%

How close you are to each child: 22%

How much money each child has: 22%

How many children of their own each child has: 19%

How much you like each child's spouse: 10%

37% said it can be reasonable to disinherit a child.

Another item of indecision for many people is the choice of decision makers: Trustee, Personal Representative, Guardian, and Agents under powers of attorney. For each of these positions, it is important to name people whose decision-making ability you trust. You may be tempted to name all your children or siblings to avoid hurting anyone's feelings. However, naming a large number of people to serve together in the same role invites family disharmony and chaos. For example, if property in the Trust is to be sold and you have seven Trustees, many of whom may be out of town, it would be a logistical nightmare to route paperwork all around the country. Typically, things work more smoothly if you limit the number of people in any given role. Besides, having a job thrust upon them may be something many would just as soon avoid.

Social Security Expands Compassionate Allowances Conditions

Michael J. Astrue, Commissioner of Social Security, announced 13 new Compassionate Allowances conditions involving the immune system and neurological disorders. The Compassionate Allowances program fast-tracks disability decisions to ensure that Americans with the most serious disabilities receive their benefit decisions within days instead of months or years. Commissioner Astrue made the announcement during his remarks at the U.S. Conference on Rare Diseases and Orphan Products in Washington, D.C.

"Social Security handles more than three million disability applications each year and we need to keep innovating and making our work more efficient," Commissioner Astrue said. "With our Compassionate Allowances program, we quickly approved disability benefits for more than 60,000 people with severe disabilities in the past fiscal year. We have made significant improvements, but we can always do more."

The Compassionate Allowances initiative identifies claims where the nature of the applicant's disease or condition clearly meets the statutory standard for disability. With the help of sophisticated new information technology, the agency can quickly identify potential Compassionate Allowances and then quickly make decisions.

Social Security launched the Compassionate Allowances program in 2008 with a list of 50 diseases and conditions. The announcement of 13 new conditions, effective in December, will increase the total number of Compassionate Allowances conditions to 113. The conditions include certain cancers, adult brain disorders, a number of rare genetic disorders of children, early-onset Alzheimer's disease, idiopathic pulmonary fibrosis, and other disorders.

The agency announced a small grant program for graduate students that will help Social Security improve its list and has recently awarded an approximately \$1.8 million grant over a five-year period to Policy Research, Incorporated (PRI) through the Disability Determination Process Small Grant Program. This new program aims to improve the disability process through innovative research by graduate students who will receive small stipends for their work. In addition, the agency recently streamlined its online disability application for people who have a condition on the Compassionate Allowances list.

The show has many outstanding performers like Anne Gunn, Bernie Yvon, Matt Raffery, Michael Aaron Lindner, Ericka Mac, Johanna McKenzie Miller and Buddy Reeder to name a few.

CHRISTMAS WITH A GREEK FLAVOR

While Easter is the most important holiday of Greek Orthodox throughout the world, Christmas is certainly a close second. Both are celebrated with much religious service attendance and with the flavor of favorite Greek foods laden on festive holiday tables which includes an assortment of pastries to enhance the meal of family and friends.

Of course, Roasted Lamb and Potatoes is a favorite on most Greek holiday tables, but Pastitsio is a close second to appear on that same table. It is certainly one of our family favorites. While it is a labor of love, it will certainly get you many rave reviews. Kali Orexi! Bon Appetit!

PASTITSIO

2 lbs., Ground Beef (use Sirloin)
1 onion, chopped
1 tablespoon, chopped Italian Parsley
2 cloves, Garlic, minced
1 tsp., Cinnamon
½ tsp., Nutmeg
1 8 ounce can, Tomato Sauce (I use No Salt Added)
½ cup of White Wine
butter (I use unsalted butter)
olive oil
salt and pepper to taste
1 lb of MISKOS Macaroni #3 *
3 eggs, beaten
Grated Cheese (I use Mitzithra * - if not available use Parmesan)
6 cups of Bechamel Sauce - which follows Pastitsio Recipe

Bechamel Sauce

Although this basic White Sauce is attributed to the French it can be traced to Ancient Greek cookery.

4 to 5 cups of hot milk
3 tbsp. All Purpose Flour
½ cup of Butter
Salt and White Pepper

Melt the butter in a pan, add flour and stir until smooth. Lower heat and then gradually add the hot milk, stirring constantly until it thickens. Season with salt and white pepper and add ½ tsp. Cinnamon.

Preheat oven to 350 degrees. In 4 tbsp. butter and 1 tbsp. Olive Oil saute ground meat along with the chopped onion, minced garlic and parsley. Crumble meat as you go along with a fork When no more pink is visible add cinnamon, nutmeg, salt and pepper and tomato sauce. Simmer for 30 minutes; remove from fire. In large pot of boiling water cook the macaroni as directed on the package. When cooked drain and rinse macaroni and place in a bowl. Add 1/4 lb of melted butter, beaten eggs and a generous sprinkling of grated cheese to the macaroni and mix well. Spread half of the macaroni mixture in a 9x13x2 pan which has been greased with olive oil. Spread the meat sauce over the first layer of macaroni and sprinkle with grated cheese; top with the balance of the macaroni. Pour prepared Bechamel Sauce over the top layer of macaroni and sprinkle lavishly with grated cheese; dot with butter and sprinkle delicately across the entire top with a little cinnamon. Bake 1 hour in preheated 350 degree oven. Cool and cut into 3 inch pieces. Arrange on a platter and serve!
