### Adler Planetarium Launches "Letters To Lovell" Campaign In Honor Of Astronaut Jim Lovell's 90th Birthday

On March 25, 2018, American hero and former NASA astronaut Captain Jim Lovell will celebrate his 90th birthday. As a veteran of four spaceflights, he inspires generations to look up, explore, and achieve the impossible. The Adler Planetarium is asking the public to write notes to share how his story has encouraged them to pursue their dreams and say thank you for everything Captain Lovell has done.



Throughout the year, guests visiting the Adler can write their inspirational stories on notecards and place them in the Letters to Lovell mailbox located in the Mission Moon gallery. The letters will be shared with Captain Lovell and his family.

Captain Lovell is a lifetime trustee of the planetarium, and has been part of the Adler family for many years. In 2005, he generously donated many of his personal effects from his storied career to the Adler's collection, enabling guests a unique glimpse into the lives of those that took America's first steps into space. The Adler's Mission Moon exhibition tells the story of the early days of American spaceflight and features many of the artifacts Captain Lovell so graciously donated.

Captain Lovell is best known for his courageous role as commander of the Apollo 13 mission, upon which the award winning movie is based. He also piloted Apollo 8, man's maiden voyage to the moon, where he and fellow crewmen were the first humans to leave Earth's gravitational influence- a mission that is celebrating its 50th anniversary this year. Lovell is one of only 24 people to have flown to the Moon, and is the only one to have flown there twice without making a landing. He is the recipient of the Presidential Medal of Freedom.

On September 8, 2018, The Women's Board of the Adler Planetarium will honor Captain Lovell at Celestial Ball, their biggest fundraising event of the year. The annual black-tie gala raises \$1.7 million for educational programming that engages people in doing science and inspires young people to pursue careers in science, technology, engineering, and math (STEM). The Adler will use the public's inspirational stories as part of its tribute to Captain Lovell at Celestial Ball.

## Why Custom Hearing Protection Is the Best Investment You Can Make for Your Hearing Health

New research is uncovering that hearing loss is much more widespread than we had previously thought. In addition to genetics and old age, which are facts of life, hearing loss is frequently caused when a person's occupation or hobby involves noisy environments.

However, if the loud environment is your hobby, there's no good way to establish whether it's regularly loud enough to cause hearing loss.

We are all familiar with the standard foam hearing plugs. They're cheap, disposable, easy

to find, and relatively comfortable. However they're also not customized to the task at hand, easy to lose or damage, and not custom fitted for all-day wearing comfort.

Many people who are regularly exposed to loud environments in their occupation or recreation and have been informed about the risks of hearing loss opt for custom hearing protection that is comfortable, effective, and calibrated to provide maximum protection for that particular activity.



How would you cope with the news that your wife has a life-threatening disease? If you were comedian Marc Jaffe, you'd learn to laugh about it. That's exactly what he did in his play SIDE EFFECTS MAY INCLUDE...

SIDE EFFECTS MAY INCLUDE... is a daringly funny, poignant and provocative one-man show about early onset Parkinson's disease and the effects this can have on both the patient and their caregivers.

Jaffe co-wrote the play along with Emmy nominated Broadway playwright Eric Coble in an attempt to help him cope with the pressures of his wife's diagnosis. Karen Jaffe is a prominent physician in their home town of Cleveland, OH and was diagnosed with Parkinson's several years ago. In a situation similar to that in the play, their attempts to deal with the disease privately were made more difficult by the side effects of the countless medications she was required to take.

Jaffe's fictional alter-ego is Phil Rosen, a stand-up comedian who can find nothing to laugh about due to his wife's early-onset Parkinson's diagnosis. Suddenly, an increase in her medications brings on unusual and hilarious side effects. SIDE EFFECTS MAY INCLUDE... is the story of a couple's love and devotion in the midst of coping with the heartache of an escalating mountain of pills, dangerous (yet faithful) liaisons, marital secrets revealed, questions of manhood and womanhood, age, and desire.

"Comedy is pain plus time," said Jaffe, a stand-up comedian himself who is best known for his work writing for Seinfeld and for material he created for Mad About You star Paul Reiser. "For comedy writers, the window is much narrower than for the general public. I was pretty quickly able to look at painful events and find the funny things." He says there is universal humor in how we care for our spouses.

Parkinson's disease is a chronic, degenerative neurological disorder with symptoms that can progress from mild tremors to complete physical incapacitation. In the United States, 60,000 new cases of will be diagnosed this year alone. While the average age of onset is 60, an estimated five to 10 percent of people with Parkinson's experience onset at age 40 or younger.

10% of the proceeds from SIDE EFFECTS MAY INCLUDE... benefit Shaking with Laughter, a not-for-profit organization that was established by the Jaffes in support of the Michael J. Fox Foundation. "We've had Parkinson's sufferers thank us for letting them laugh for an hour." The show isn't just for people afflicted with Parkinson's Disease. Kaplan's own mother suffered from early-onset Alzheimer's. "Every day that goes by that my brain works well and I remember not only my name, but the names of my associates ... is a good day."

Pond, Chairman at Ecclectic Full-contact Theatre who appears frequently in productions at the Metropolis Performing Arts Center, Citadel Theatre, Redtwist Theatre, and the Circle Theatre. Pond not only plays Phil, but a host of other characters including Phil's wife Maggie, their daughter, her doctor, his doctor, their neighbor, a rabbi, and even a check-out girl. ## 2018 Estate Planning Considerations

As you may know, on December 22, 2017, the President signed into law one of the most reformatory tax bills that will affect many estate planning considerations.

The new law increases the estate tax exclusion amount from \$5 million per person (adjusted for inflation), to \$10 million per person (adjusted for inflation). For 2018, the inflation adjusted exclusion amount is about \$11.18 million (or \$22.36 million per married couple). This is also the lifetime exclusion amount for gift tax and generation-skipping transfer tax.

Under this current law, you can transfer property to your loved ones at death or during life and avoid paying the 40% tax rate on the transfer, as long as the

transferred amount does not exceed the exclusion amount. In the event that Congress takes no further action, in 2026 the estate tax exclusion amount will revert to \$5 million per person, indexed for inflation.

With the current estate tax exclusion being so high, estate taxes may not be the main consideration for most of us. However, there are other critical considerations to review with your attorney in order to make sure your estate plan is working for you.

One of these considerations is to determine whether your trusts are overly complicated. Wills and trusts can now be drafted in a simpler format to implement estate tax planning as well as income tax planning. For example, assuring that assets can get a "step up" in income tax basis will help minimize capital gain taxes when beneficiaries receive your property on your death.

Another consideration is asset ownership. It is easy to forget that assets owned in joint tenancy and assets that have designated beneficiaries will go to the joint tenant or the beneficiary, respectively, upon death. Think about bank accounts where you added a child's name for convenience purposes. If the child is a co-owner on the account, all of the funds in that account will belong to that child upon your death. Similarly, if only one child is named as a beneficiary on the account, the child will receive the entire balance. This may or may not comply with your overall estate plan.

Gov. Rauner applauded the growing craft beer industry in Illinois. There are over 240 craft brewers in the state. The Illinois Craft Beer industry has seen a 350 percent increase in the number of craft breweries over the last five years.

The beer features staple Illinois crops including corn, wheat and oats. The crystal hops are grown by Hallowed Hops of Lewistown, and fermented with a hybrid saison yeast developed by Omega Yeast Labs of Chicago.

Retail outlets, restaurants and bars featuring craft beer will offer '1818' throughout Illinois both on tap and in cans.

### Ranchero Corn

On December 28, 2017, an announcement was made on TV that corn has been officially designated as the "Illinois State Grain."

Our family was invited to my brother and sister-in-law's house for Thanksgiving, and this was one of the side dishes which was served with the roast turkey, etc.

Ingredients: 6 slices bacon, fried and placed on paper towel to drain and then chopped into small pieces (save the bacon fat). 4 oz. sliced mushrooms, one medium or large onion, finely diced, plus half of a red pepper, with seeds removed and cut into small pieces. Sauté the mushrooms, onion and red pepper in the bacon fat; add two 12 oz. cans of corn. Heat it up and pour into a shallow serving dish, top with 1/2 cup grated yellow cheddar cheese and bring it to the table. Serves 8. Enjoy!
