Armed Forces Day honors all branches of the armed forces of the United States. It is celebrated on the third Saturday of May with military exercises on land, at sea, and in the air. Military installations are usually open to the public on Armed Forces Day.

President Harry S. Truman proclaimed Armed Forces Day, and it was first celebrated in May, 1950. It replaced three separate celebrations for the Air Force, Army, and Navy. James V. Forestal, the first secretary of defense, helped unite the armed services under the Department of Defense after World War II ended in 1945. (Taken from World

The City of Chicago and the Department of Cultural Affairs and Special Events are honored to announce the Grand Marshal for Chicago's Memorial Day Parade and Wreath Laying Ceremony on Saturday, May 27. The Wreath Laying Ceremony will begin at 11 a.m. on Daley Plaza (Dearborn and Washington Streets). The parade will then step off at noon and proceed south on State Street from Lake Street to Van Buren Street. Lieutenant General Robert S. Walsh, Commanding General, Marine Corps Combat Development Command and Deputy Commandant, Combat Development and Integration, will serve as the parade's Grand Marshal.

During the Wreath Laying Ceremony and Parade, the City of Chicago honors fallen heroes and Gold Star family members who have lost a loved one in the United States Armed Forces to combat operations or while on active duty. Approved by Congress beginning in 1947, Gold Star Lapel Pins and the Next of Kin Lapel Pins are presented to families not as an award, but as symbols of honor worn by family members in remembrance of their fallen loved ones and their ultimate sacrifice.

Parade Grand Marshal

United States Marine Corps, Lieutenant General Robert S. Walsh, Commanding General, Marine Corps Combat Development Command and Deputy Commandant, Combat Development and Integration, will serve as the Grand Marshal. Lieutenant General Walsh attended the U.S. Naval Academy and went on to become a Naval Aviator in 1981. After attending the U.S. Navy Fighter Weapons School and serving on two deployments, he assumed the duties as a flight instructor at TOPGUN in 1987. In 2002, he graduated from the National War College in Washington D.C. with a Masters in Science in National Security Strategy. He has served in countless command posts to include as the Commanding General of the 2nd Marine Aircraft Wing deploying the wing to Operation Iraqi Freedom in 2009. He assumed his current command in August 2015. For the Wreath Laying Ceremony and Parade, he will join Mayor Rahm Emanuel along with service members, veterans and Gold Star families in remembering those who gave the ultimate sacrifice for our country.

Major General John A. Logan Patriot Award

John Schwan is this year's recipient of the Major General John A. Logan Patriot Award for his leadership, patriotism and selfless devotion to serving veterans and active duty military through Operation Support Our Troops America, a foundation dedicated to improving the lives of soldiers currently serving and aiding returning veterans in finding employment and other services. Mr. Schwan is active in the Sheridan First Cavalry Chapter, and serves as a board member for Leave No Veteran Behind as well as for the Pritzker Military Museum and Library. He is also the chairman of the Armed Forces Council at the Union League Club of Chicago. Mr. Schwan is a Vietnam era veteran, having served 1966-1971 and was in country during parts of 1967 and 1968. He attended OCS at Fort Benning with active duty in the First Air Cavalry Division. He is a service-related disabled veteran; awarded the Combat Infantry Badge, Air Medal, two Bronze Stars with V for Valor device and a Purple Heart. He has been an entrepreneur for over 40 years and is currently the CEO of CTI Industries in Barrington, IL.

Memorial Day has a rich history. It began shortly after the Civil War ended when General John Logan proclaimed that the 30th day of May be designated for the purpose of decorating the graves of soldiers who died. The day, first observed on May 30, 1868, was called Decoration Day. The modern day event is similar, but the original idea has been expanded and now honors all fallen soldiers.

The Chicago parade is considered one of the largest Memorial Day parades in the nation. Participants in the parade include area high school marching bands, drum and bugle corps as well as many veterans' groups, 6,000 JROTC cadets and the military. Parade participants will also include the singing of the National Anthem by Aleece Baker on behalf of the USO of Illinois as well as a procession of antique military vehicles provided by the USO.

Resurrection Honors Alumnae At Wall Of Honor Inductions

Resurrection alumnae were inducted into the Resurrection Wall of Honor on Saturday, April 22, 2017. Notable alumnae were honored with the Blessed Celine Award, which is awarded to Resurrection alumnae who exemplify the life values of Blessed Celine, the foundress of the Sisters of the Resurrection. The recipients are accomplished in their fields of endeavor and, like Blessed Celine, work toward the advancement of women in society and act as positive Christian role models for young women. The 2017 Blessed Celine recipients were Resurrection alumnae Gina Lavorata O'Hehir '86, Kathleen Walsh Hopkinson '83, Ramina Oraha '03, and Barbara Gembala Nakaniski '72.

Gina Lavorata O'Hehir is an alumna from the Class of 1986 and is an attorney in private practice who attended law school at IIT-Kent College of Law. Since graduating from Marquette University as an Evans Scholar, Gina has been actively involved in the Evans Scholar Foundation. She has mentored young Evans scholars, on various fundraising committees and has become a director of the Western Golf Association. Gina is also an active volunteer in her parish community and at Resurrection. As an alumna she has participated in numerous events. While her three daughters have been students at Resurrection Gina has been a dedicated parent volunteer, including initiating and chairing the Athletic Booster Club Trivia Night fundraiser, and chairing the 2016 Resurrection Charity and Truth Gala with her husband.

Kathleen Walsh Hopkinson is an alumna from the Class of 1983 and is working in finance for the Kane County Transportation Department. She earned a BS in Commerce from DePaul University Strobel Scholars Honors Accounting Program and a Master in Public Administration from Harvard University's Kennedy School of Government. Kathleen worked as an auditor with the Cook County Auditor's Office and for KPMG, as the Chief Financial Officer of Heartland Alliance for Human Needs and Human Rights and then Neighborhood Housing Services of Chicago. As an alumna, she served as a Board Member of Resurrection's Corporate Board, as well as Chair of its Finance Committee and Audit Committee.

Ramina Oraha is an alumna from the Class of 2003 and is a veteran of the U.S. Air Force. She was stationed at Ellsworth Air Force Base in Rapid City, SD and deployed to Iraq. At the age of 23, Ramina suffered a stroke which affected her speech and mobility. In 2014 she participated in a Veterans Day program at Resurrection and has been a volunteer at the school since that time. In 2015 she was named Grand Marshall of the Norwood Park Memorial Day Parade. She comes back to Resurrection from time to time, and she shared a special message of hope with the students of Resurrection. She lives with her family, and continues to have a positive attitude on life.

Barbara Gembala Nakaniski is an alumna from the Class of 1972 and is licensed architect in Illinois and also in the State of Hawaii. sion II basketball at Lewis University where she received a BS in Sports Management with a minor in Physical Education/Coaching.

Katie McGrath Guinane is an alumna from the Class of 1997 and has spent several years as a Registered Fixed Income Sales Assistant at the RBC Capital Markets and Cantor Fitzgerald & Co. Katie was a four-year two-sport athlete, playing basketball and softball at Resurrection. In both her junior and senior years, the Bandits won Regional Championships. ASK THE EXPERT

Dear Dr. Vetter:

My family has started complaining that I am not hearing well. At times, I also am curious if I also have trouble hearing. What are some signs of hearing loss? When do I know if I should make an appointment?

Dear Mr. Curious

Because hearing loss usually occurs gradually and over time, it's difficult for many people affected by it to realize that their hearing has changed and that they may benefit from using a hearing aid. However, knowing some of the common signs can help to diagnose hearing loss in yourself or in loved ones.

ing children, this could point to a possible loss of high frequencies in your hearing range. You may also notice that people sound like they are mumbling. This is because those high frequency sounds may be missing.

You avoid talking on the phone because you find it challenging to hear others - it may not just be your particular device, but instead your hearing that's the problem.

You have trouble hearing people in restaurants or hearing at church - if you find that it's becoming harder for you to hear others when there's other background noise (within reason) or in large venues, this could point to hearing loss as well.

A beach token, also known as a season pass, is valid from the time of purchase through Labor Day, Monday, September 4, 2017. Tokens will be sold at a discounted rate of \$26 for Evanston and Skokie residents and \$42 for nonresidents through Friday, June 9. On Saturday, June 10, the price for a beach token will increase to \$34 for Evanston and Skokie residents and \$58 for nonresidents.

The Adler Planetarium's Newest Sky Show Planet Nine Winner of 2017 People's Choice Vizzie Award

The Adler Planetarium is pleased to announce that its newest sky show, Planet Nine, and its creators Patrick McPike and Mark SubbaRao from the Adler and Michael Brown from CalTech, have won a Vizzie award for People's Choice in the Video Category at the 15th Annual Vizzies Challenge presented by Popular Science magazine and the National Science Foundation (NSF).

The Vizzies, formerly known as the International Science and Engineering Visualization Challenge, honor the most illustrative and impactful visualizations from the worlds of science and engineering. Celebrating their 15th anniversary, the Vizzies blur the line between science and art, and recognize visualizations of scientific phenomena in the form of photography, illustration, posters and graphics, video, and interactive.

A team of experts at NSF and Popular Science pared hundreds of submissions down to 50 finalists. From those 50, a panel of outside experts picked five Expert's Choice winners, and Popular Science readers chose five People's Choice winners.

"Planet Nine had all the elements of a great story, and had already captured the public's imagination," said Mark SubbaRao, Adler Planetarium Space Visualization Laboratory Director. "Because the data behind the potential discovery of a new planet is so complex, Planet Nine lent itself very well to data visualization-driven storytelling."

Planet Nine opened at the Adler Planetarium in May 2016, and explores the largest of Pluto's neighbors in the Kuiper belt, inviting visitors to join in the search for a new ninth planet. Viewers follow "Pluto Killer" Dr. Michael Brown and his team of scientists at CalTech as they hunt for a planet that may be hiding deep in the outer Solar System. If you have been to the Adler Planetarium and have seen this spectacular sky show, you know that it is the breathtaking visualizations that help tell this fascinating story.

"Visual representations are a crucial way to communicate scientific ideas to the public," said Popular Science online director Amy Schellenbaum. "They are a great way to help a larger group of people understand the amazing occurrences taking place right under our noses every day.'

The Creed was written in 1918 by William Tyler Page of Friendship Heights, Maryland in the course of a nation wide contest on the subject. Page was a descendent of President Tyler, and Representative John Page, who served in the Congress fro 1789-97. William Tyler Page began his government career as a Congressional page in December of 1881. In 1919 he was elected Clerk of the House of Representatives, and held that position until December of 1931. A new post, Emeritus Minority Clerk, was then created for him which he occupied until his death on October 20, 1942.

Opening May 19th, 2017: Vietnam Transformed: The Art of Richard J. Olsen as Symbolic Reality at the National Veterans Art Museum

The National Veterans Art Museum (NVAM) presents its newest exhibition–Vietnam Transformed: The Art of Richard J. Olsen as Symbolic Reality. The exhibition features work spanning the artist's career, and will be on view from May 19th to August 12th, 2017.

In collaboration with curators Andrew and Hathia Hayes, and with the curatorial assistance of Anthony F. Janssen, the National Veterans Art Museum is proud to feature an exhibition of work from throughout the career of longtime NVAMartist and veteran, Richard J. Olsen. In his work, Richard Olsen conveys underlying themes such as the tension between good and evil, the experience of war, and his immediate environment-his studio-by embedding images that are symbolic and allegorical without relying on representation. Olsen began using symbolism early in his career, but this approach for conveying meaning came to the forefront during his mature period during which he creating paintings based on his wartime experiences as a transport helicopter pilot in the Vietnam War. The exhibition will showcase work spanning the artist's career, but will highlight his "Wall" series, for which he is probably bestknown.

During his graduate studies at the University of Wisconsin, Olsen's artistic approach was to represent the likeness of people, places and events from his life. After accepting a faculty position at the University of Georgia in 1969, he felt pressure to move toward pure abstraction and leave behind his representations of the Vietnam War. He spent time experimenting with a variety of painting techniques, and once again began adding abstracted images pulled from his experience in Vietnam.

Despite mastering these methods of painting, Olsen struggled to find his voice and legitimacy and continued to ask himself "What do I paint"? In 1977, he took the advice of an artist's cliché, "If you don't know what to paint, paint your studio wall" and covered the walls of his studio with canvas and let them depict different aspects of his artistic life. These early canvases were the beginning of his "Wall" series.

By the mid-1980s, Olsen's approach to both painting and subject matter became clear. He constructed collages, which he called "Calculations," on grid paper as blueprints for his larger canvases. He depicted his previous works in these collages, and continued this method, adding images of previous paintings and objects in his studio.

Olsen's "Wall" designs are intended to be allegorical by linking the pictoral artifacts of his Vietnam wartime experiences to systems of meaning – the balance of good/evil, and the legends traditions of culture. Olsen's war experiences are made real to viewers by the collection of pictoral symbols within each painting and linking the imagery to higherlevel meanings.

Olsen's work aims to surpass an automatic response in viewers by using multiple symbols in compositions that invite, even demand, close inspection and stimulate further thought by providing a context from which the underlying meaning

can emerge. Olsen links the visual, emotional, psychological, cultural, and social elements of his Vietnam wartime experiences to much larger primary issues concerning the continued tension between good and evil found in all societies. Through his art, Olsen has elevated the Vietnam War to a universal plane to create an allegory of human existence. His paintings are allegories that rely upon historical and philisophical systems, but they also add new layers to the fundamental meanings of war that are essentially without precedent in art and art history.

Combat Pay, Taxes, and Retirement – What Veterans Need to Know

If you are a member of the United States military, you likely have more important things on your mind than taxes and retirement planning. You should, however, take a moment to learn how your combat pay is treated by Uncle Sam to ensure you receive the benefits to which you are entitled for your service to your country.

Military Compensation As a member of the military, your compensation is

more complicated than the average civilian. The reason for this is that your pay is composed of several different components, including base pay, a housing and food allowance, bonuses, and special pay, if you qualify. To ensure your taxes are computed correctly, it is important to understand how your compensation is treated by the Internal Revenue Service (IRS), particularly your combat pay.

Is Combat Pay Taxable?

Members of the U.S. Armed Forces do not pay taxes on all of the compensation they receive, effectively

increasing their take-home pay amount. Like most members of the military, you are probably aware that your food and housing allowance is not taxed. This portion of your pay likely accounts for 20-30 percent of your total compensation, meaning a quarter to a third of your compensation may be tax-free. If you served in a combat zone during the pay period in question, you may be entitled to additional tax-free income of which you may be unaware.

The IRS rules state that if a member of the military served in an area designated by the Department of Defense as a combat zone or served in direct support of military operations in the combat zone, the portion of his/her compensation that was earned while in a combat zone is excluded from income tax. Moreover, the exclusion from taxation applies to the entire month as long as you spent at least one day serving in a combat zone that month.

The amount of income you may exclude for purposes of calculating your taxable income is unlimited for enlisted personnel. If you are an officer, you may still make use of the exclusion. However, an officer's exclusion is capped at the maximum of the corresponding enlisted pay for the time period in question.

Other Potential Exclusions from Your Taxable Income

Along with exclusions for combat pay and your food and clothing allowance, you may also be entitled to a number of other exclusions when calculating your taxable income, including, but not limited to:

• Imminent danger/hostile fire pay

• A reenlistment bonus if the voluntary extension or reenlistment occurs in a month you served in a combat zone

• Pay for accrued leave earned in any month you served in a combat zone

• Pay received for duties as a member of the Armed Forces in clubs, messes, post and station theaters, and other related activities, as long as earned in a month you served in a combat zone

• Awards for suggestions, inventions, or scientific achievements you are entitled to because of a submission you made in a month you served in a combat zone

Combat Pay and Retirement Planning

While it is clearly advantageous to be able to exclude combat pay from your taxable income, you also need to understand how excluding combat pay could impact your retirement planning.

One of the most popular retirement planning tools is an Individual Retirement Account (IRA). Contributions to an IRA, however, must be made using "earned income," meaning income from working. Since combat zone pay is excluded from your gross income, it does not qualify as earned income. Without anything further, it would appear as though the combat pay exclusion puts members of the military at a significant disadvantage when it comes to retirement planning.

Fortunately, Congress recognized this unintended consequence of excluding combat pay from taxable income, and passed the Heroes Earned Retirement Opportunities ("HEROs") Act to rectify the situation. The HERO Act allows combat-zone pay to be considered part of earned income, for purposes of figuring eligibility for contributing to an IRA (or Roth IRA).

Social Security Honors All Who Serve

Every day of the year, Americans across the nation remember friends and family members who have served and sacrificed for their country. Memorial Day is a day when we all come together to honor those who have given their lives in the defense of freedom and the principles we hold dear in this country.

May is also National Military Appreciation Month. As we observe Memorial Day and Military Appreciation Month, we would like to let members of our military know how much we value what they do for our nation.

At Social Security, we offer a wide range of services for our service members. Families of fallen military heroes may be eligible for Social Security survivors

benefits. Learn more about Social Security survivors benefits at www.socialsecurity. gov/pgm/survivors.htm.

For service members who return home with injuries, Social Security is here to help. Visit our Wounded Warriors website. You can find it at www.socialsecurity. gov/woundedwarriors. We use an expedited process for military service members who become disabled while on active military service, regardless of where the disability occurs.

The Wounded Warriors website answers a number of commonly asked questions, and shares other useful information about disability benefits, including how veterans can receive expedited processing of disability claims. It is important to note that benefits available through Social Security are different than those from the Department of Veterans Affairs and require a separate application.

Even active duty military who continue to receive pay while in a hospital or on medical leave should consider applying for disability benefits if they are unable to work due to a disabling condition. Active duty status and receipt of military pay does not necessarily prevent payment of Social Security disability benefits. Receipt of military payments should never stop someone from applying for disability benefits from Social Security.

Roadside History of Illinois

This is the fifth in a series of monthly short articles about places in Chicago, nearby suburbs and elsewhere in the state that can be visited by those who seek to learn more about local history. The articles are partial excerpts from the book, Roadside History of Illinois (Mountain Press, 2013), by Chicago author and Illinois native Stan Banash.

North Loop Theater District in Chicago

Chicago's main theater district, in the northern part of the Loop, contains four historic theaters—the Cadillac Palace Theatre, the Goodman Theatre, the Ford Center for the Performing Arts (formerly the Oriental Theatre), and the world renowned Chicago Theatre. A few blocks south is the Bank of America Theatre, better known by its former name, the Shubert Theatre. The other major historic downtown theater, the Auditorium Theatre, stands in the far south east corner of the Loop. Five of these six structures were restored in the 1980s, 1990s and early 2000s.

The Chicago Theatre, 175 N. State Street, with its iconic vertical lighted sign, is among the best known of Chicago's historic theaters. Opened as a movie house and live theater in 1921, it still contains its original Wurlitzer pipe organ. The building deteriorated over the years and the theater closed briefly in 1985, but volunteers restored it, and it reopened less than a year later. One-hour tours (per person fee is charged) are offered at noon daily. Just southwest of the Chicago Theatre is the Oriental Theatre, 24 W. Randolph Street, named for its Far East design, which opened as a move house in 1926. The venue also held live shows, including performances by major stars such as Al Jolson, Fanny Brice, Judy Garland, and later. Little Richard and Stevie Wonder. The Oriental was built at the site of the Iroquois Theatre, which burned down on December 30, 1903. This devastating fire occurred during a matinee performance of Mr. Blue Beard, starring Eddie Foy, and claimed 602 lives. The alley behind the theater is believed to be haunted as some patrons attempted to escape via ladders stretched across the



alley to another building. During the late 20th century, the Oriental building fell into disrepair and was threatened with demolition but with public and private funding, it was finally restored in 1998, reopening as the Ford Center for the Performing Arts.

Nearby, the Goodman Theatre, 170 N. Dearborn Street, was founded in 1922. The original Goodman, which included a drama school, opened its doors in 1925 at Monroe Street and Columbus Drive. It was moved to its current spot in 2000. Two blocks west is the Cadillac Palace Theatre, which opened as the Palace Theatre in 1926. Elegantly designed and lushly furnished, it was the main venue for the big vaudeville acts, including

Jimmy Durante, Mae West and Jack Benny. Renovated in 1999, it reopened as the Cadillac Palace Theatre.

A few blocks south of the main theater district is the oldest of these historic venues. the PrivateBank Theatre, formally known as the Bank of America Theatre, originally called the Majestic Theatre and best known as the Shubert Theatre. The Majestic opened in 1906 as a vaudeville house. At the time, it was the tallest building in the city. Closed down during the Great Depression, it reopened as the Sam Shubert Theatre in 1945. It was restored and became the LaSalle Bank Theatre in 2006. It was renamed for the Bank of America in 2008, after the latter bank bought out the former. In 2015, a partnership between Broadway in Chicago and Private-Bank resulted in the theater being renamed the PrivateBank Theatre.

All four locations are within walking distance
