## Burn Awareness Week (February 1-7): Fire Safety Group Offers Scald Injury Prevention Tips

As the Illinois Fire Safety Alliance (IFSA) observes Burn Awareness Week, which runs February 1-7, 2016, the nonprofit organization encourages Illinois residents to follow burn prevention guidelines to put an end to costly burn injuries and deaths.

For 2016, the theme for Burn Awareness Week is scald injury prevention. The weeklong national advocacy campaign provides an opportunity for burn, fire and life safety educators to unite in sharing a common burn awareness and prevention message in their communities.

"Over 450,000 burn injuries requiring medical attention occur in the United States each year. That's equal to one burn injury every 70 seconds," says Philip Zaleski, Executive Director of the IFSA. "Children and older adults are at a higher risk for burn injuries due to their cognitive and motor skills, dependence on others, and inability to easily escape danger."

"In particular, scald burns account for nearly 34 percent of all burn center admissions. Sixty-two percent of those scald burn admissions were for children five years old and younger."

The American Burn Association's (ABA) National Scald Injury Prevention Campaign website, [www.FlashSplash.org](http://www.FlashSplash.org), promotes the scald prevention message, "It can happen in a flash with a splash: Liquid and steam burn like fire." Below are a few of ABA's safety tips to prevent scald burns and injuries:

- Set water heater temperatures no higher than 120°F and test temperatures before bathing.
- Do not leave children unattended in bathtubs or allow them to sit near faucet handles.
- Create a "no kid zone" in the kitchen around stoves and ovens; place pots and pans on

back burners with handles turned away from edges.

- Stir, test food in microwave before serving; open heated containers away from you, back to front.
- Use travel mugs with tight-fitting lids for hot drinks; keep hot drinks away from edges of tables and counters.
- Do not allow appliance cords (slow cookers, deep fryers, coffeemakers) to dangle over counters.

The IFSA also stresses the importance of fire safety, cooking safety, and other measures that prevent burns to infants, children and adults.

"The annual cost of burn injuries and deaths in the United States equates to hundreds of millions of dollars. However, we as a society have the tools and resources to make a difference in preventing burn injuries and deaths, as well as the staggering property damage and medical costs associated with them. We must spread the prevention message, use the knowledge, and practice it in our daily lives," adds Zaleski.

Since 1982, the IFSA has promoted programs and distributed information related to fire safety and burn prevention, while also providing free support programs for burn survivors. Some of those annual no-cost programs include "Camp I Am Me" burn camp for Illinois children ages eight to 16, a Young Adult Summit for burn-injured persons between the ages of 18 and 25, and a Family Day event for families with burn-injured children up to 12 years old.

## Do You Know About the Skokie TeenLink Program?

The Skokie TeenLink program is a database collection of Skokie teens who are available to do outside yard work, including snow shoveling, which is provided to Skokie residents upon request. Many residents who request the TeenLink list are unable to do physical work themselves, unable to afford the cost of a professional contractor on a regular basis or only need assistance during one season. The TeenLink list provides contact information for Skokie teens including the name and address of the teen, days of availability, type of work they are willing to do and their expected rate of pay. Residents can receive the list by mail or email.

This program becomes very popular and sought after during the snow season. It's always best to receive the TeenLink list early in the year and contact the teen before needing assistance.

The resident is responsible for contacting the teen and for making financial and scheduling arrangements.

## Debt of Governments Listed on Property Tax Bills, Treasurer Maria Pappas Says

The financial data and pension debt of every local government, school district or other taxing agency that taxes a home or other property in Cook County is listed on nearly 1.8 million bills mailed to property owners, County Treasurer Maria Pappas said today.

From seven to 20 taxing bodies levy taxes on a given property, and the bill for each property has a section called "Taxing District Debt and Financial Data." In that section are four categories:

- Money Owed by Your Taxing Districts
- Pension and Healthcare Amounts Promised by Your Taxing Districts
- Amount of Pension and Healthcare Shortage
- Percentage of Pension and Healthcare Costs Taxing Districts Can Pay

Owners of taxable homes, businesses and land in the nation's second-largest county can see the information on First Installment bills for Tax Year 2015 mailed by the Treasurer's Office. The bills have a due date of March 1, 2016.

Pappas noted that even more financial information about local governments can

be found by visiting her website, [cookcountytreasurer.com](http://cookcountytreasurer.com), selecting "Want to see your local government debt?" and entering either the 14-digit Property Index Number for a piece of real estate or the name of a taxing district.

"Taxpayers have a right to know about the spending and debt incurred by those who tax them," Pappas said. "We have designed a bill and website that do just that."

The information comes from the county's Debt Disclosure Ordinance (DDO), written by Pappas, which requires all primary local governments across Cook County to report their financial data yearly to the Treasurer's Office.

To avoid late penalties of 1.5 percent monthly, Pappas said, taxpayers can pay on time before March 1 in four ways:

- Online at [cookcountytreasurer.com](http://cookcountytreasurer.com), from checking or savings accounts.
- At 400 Chase Bank installations across Illinois.
- By mail, in enclosed return envelopes postmarked no later than March 1.
- Mortgage escrow (taxpayers should confirm payment with their mortgage-paying firm).

## Expanded Property Tax Exemptions Available for Disabled Veterans

The City of Evanston encourages residents to contact its Property Tax Assessment Review Office with any questions related to a new Illinois law that expands property tax exemptions for disabled veterans. Residents should call Mitzi Gibbs, Tax Assessment Reviewer, at 847-448-8168.

Under the new law, veterans with a 30-49 percent disability (as certified by the U.S. Department of Veterans Affairs) will receive a \$2,500 annual property tax exemption; veterans with disabilities of 50-69 percent will qualify for a \$5,000 yearly exemption; and veterans with a service-connected disability of 70 percent and greater are exempted from all property tax payments.

The new property tax exemption forms will be available on January 1, 2016 on the Cook County Assessor's website, [cookcountyassessor.com](http://cookcountyassessor.com). Applications for the property tax exemptions will be due March 1, 2016, and the exemptions would first appear on property owners' second installment 2015 property tax bills mailed out late next year.

The City of Evanston's Property Tax Assessment Review Office acts as a taxpayer advocate for Evanston residents. The Office does not assess property, but answers residents' questions and aids in exemption and appeal applications. Property assessment is done by the Cook County Assessor's Office for all of Cook County.

## Chicago Winter Parking Ban Now In Effect, 3AM to 7AM, Until April 1, 2016

Chicago's Winter Overnight Parking Ban for 107 miles of the city's most critical arterial streets resumed December 1 at 3AM. This seasonal ban in effect every year between December 1st and April 1st, and between the hours of 3 a.m. to 7 a.m. Yet in spite of permanent signage with posted calendar dates along the impacted streets, two related press conferences and heavy media coverage for the past two weeks warning of the resumption of the ban and the leafleting last weekend of vehicles parked along the ban route, some 215 vehicles still parked in violation of this seasonal ban and were ticketed, towed and impounded.

When motorists violate this ban and leave their cars parked on these routes they prevent the street from getting fully plowed and salted when it snows. This reduces the streets capacity during a storm to handle critical traffic. As heavy snow falls it gets pushed against these vehicles by passing plows causing a buildup that further restricts the street lanes.

The permanent signage that marks the 107 miles of the Winter Overnight Parking Ban is often posted next to signs for the 2-inch snow parking ban which can be activated along 500 miles of arterial streets. Both posted restrictions mark Chicago's "Snow Route System," which was created as a result of response to massive snow storms, including the Great Blizzard of '67, which halted traffic citywide."

Ignoring the Winter Overnight Parking Ban can result in a \$150 towing fee (minimum), a ticket and a daily storage fee that increases over time.

The other pertinent ban that can be activated during a heavy snow at any time of the year is the 2" Inch Snow Ban. This restriction is technically in effect all year round, but realistically only a factor in the winter months. The 2" Inch Snow Ban is not activated often, but motorists that violate it when it is active face ticketing and relocation to a nearby site. Motorists need to watch for and obey both restrictions.

## Call for Entries: Urban Land Institute Urban Open Space Award

The Urban Land Institute (ULI) today announced that it's now accepting entries for its Urban Open Space Award, an annual program that recognizes outstanding examples of successful large- and small-scale public spaces that have socially enriched and revitalized the economy of their surrounding communities. To be eligible for the competition, an open space project must have been opened to the public for at least one year and no more than 15 years; be predominantly outdoors and inviting to the public; provide abundant and varied seating, sun and shade, trees and plantings with attractions; be used intensively on a daily basis by a broad spectrum of users throughout the year; have a positive economic impact on its surroundings; promote physical, social, and economic health of the larger community; and provide lessons, strategies, and techniques that can be used or adapted in other communities.

The award was created through the generosity of Amanda M. Burden, former

New York City planning commissioner and 2009 laureate of the ULI J.C. Nichols Prize for Visionaries in Urban Development. In 2011, the Kresge Foundation, MetLife Foundation, and the ULI Foundation joined forces to continue the award. Last year, ULI reaffirmed its commitment to the award and announced it would expand the program to include global submissions.

Juries of ULI Full Members, chaired by ULI Trustees, choose finalists and winner. Jury members represent many fields of real estate development expertise, including finance, land planning, development, public affairs, design, and other professional services. They also represent a broad geographic diversity.

## Forest Claypool Statement on Teacher Layoffs

"Despite unprecedented financial problems that threaten our classrooms, CPS reached a tentative agreement with CTU leadership after 14 months of negotiations – including 18 straight days at the end of talks. This agreement provided pay raises, guaranteed job security and met the union's key demands, including restrictions on charter school expansion, raises for seniority in addition to cost-of-living increases, and more classroom autonomy for teachers.

"While we are disappointed by today's result, CPS remains committed to reaching an agreement with our partners at the CTU that is in the best interest of our students, parents, teachers and city. We are committed to returning to the bargaining table and working around the clock to reach an agreement. As we continue to bargain, we must move forward with plans that restore fiscal stability to the District."

### Background

The tentative agreement reached with CTU leadership included the following:

- Raising at least \$200 million in revenue. The Board committed to restoring a dedicated 0.26 percent property tax levy for teachers' pensions. In addition, the Board agreed to seek progressive revenue solutions.
- Raises for seniority and experience. The Board continued the practice of steps and lanes, in addition to cost of living increases.
- TIF surpluses. In this budget year, CPS is receiving TIF surplus of \$87.2 million. CPS has received over \$300 million in TIF surplus since 2011. In addition, more than \$1 billion in TIF has been invested in capital improvements in CPS. Finally, a TIF surplus is one-time revenue that will not solve the District's structural budget problems into the years ahead.
- Pensions. The Board made the same offer on pensions that the City made to the Police and Fire departments.
- Charters. CPS included a commitment to push for alterations and revisions to the legislation that authorizes the Illinois Charter Commission.

# Presidents' Day

# FEBRUARY 15, 2016

Washington's Birthday is a United States federal holiday celebrated on the third Monday of February in honor of George Washington, the first President of the United States. Colloquially, it is widely known as Presidents Day and is often an occasion to remember all the presidents, not just George Washington or Abraham Lincoln, whose birthday is also in February. The term "Presidents Day" was coined in a deliberate attempt to change the holiday into one honoring multiple presidents.

The day is also a state holiday in most states with official names including Presidents' Day, President's Day and Washington's and Lincoln's Birthday. Depending upon the specific law, the state holiday might celebrate officially Washington alone, Washington and Lincoln, or some other combination of U.S. presidents. Some states

celebrate Washington and the third president Thomas Jefferson but not Lincoln.

### History

The federal holiday honoring George Washington was originally implemented by an Act of Congress in 1879 for government offices in Washington (20 Stat. 277) and expanded in 1885 to include all federal offices (23 Stat. 516). As the first federal holiday to honor an American president, the holiday was celebrated on Washington's actual birthday, February 22. On January 1, 1971, the federal holiday was shifted to the third Monday in February by the Uniform Monday Holiday Act. This date places it between February 15 and 21, which makes the name "Washington's Birthday" in some sense a misnomer, since it never occurs

on Washington's actual birthday, February 22.

The first attempt to create a Presidents Day occurred in 1951 when the "President's Day National Committee" was formed by Harold Stone Bridge Fischer of Compton, California, who became its National Executive Director for the next two decades. The purpose was not to honor any particular President but to honor the office of the Presidency. It was first thought that March 4, the original inauguration day, should be deemed Presidents Day. However, the bill recognizing the March 4 date was stalled in the Senate Judiciary Committee (which had authority over federal holidays). That committee felt that, because of its proximity to Lincoln's and Washington's Birthdays, three holidays so close together would be unduly burdensome. During this

time, however, the Governors of a majority of the individual states issued proclamations declaring March 4 to be Presidents' Day in their respective jurisdictions.

An early draft of the Uniform Monday Holiday Act would have renamed the holiday to "Presidents' Day" to honor the birthdays of both Washington and Lincoln, which would explain why the chosen date falls between the two, but this proposal failed in committee, and the bill was voted on and signed into law on June 28, 1968, keeping the name as Washington's Birthday.

By the mid-1980s, with a push from advertisers, the term "Presidents' Day" began its public appearance.

In Washington's adopted hometown of Alexandria, Virginia, celebrations are held throughout the month of February.

## “Beautiful – The Carole King Musical”

The Tony Award-winning musical “Beautiful – The Carole King Musical” has opened at the Oriental Theatre for the holidays and will run through the end of February. I’m sure it will be extended. After the dismal week long run of “Sherlock Holmes,” this play is a treat to see. The playwright for the show is Doug McGrath and is under the direction of Marc Bruni. Choreography is by Josh Prince.

Songs like “Some Kind of Wonderful,” “Happy Days Are Here Again,” “One Fine Day,” “Uptown,” “You’ve Got a Friend,” “Will You Love Me Tomorrow,” and “Natural Woman,” besides the title tune and others, are mostly written by Carole King and Gerry Goffin and two others in this musical that runs two and a half hours with an intermission.

When the show opened on Broadway, Chicagoan Jessie Mueller won a Tony Award for the role of Ms. King. After more than a year run she is now in a new musical, “Waitress,” headed for Broadway in March. She has had four marriages and currently is single.

President Obama gave her the Gershwin Prize for Popular Song in a special ceremony at the White House.

When she breaks up with her dominating husband she tells him, “The girls deserve something better, and you know what? So do I.”

She has won several Grammys and appeared at Carnegie Hall. Her mother Gertie, is Suzanne Grodner who has great timing in that role. ## The Legend of St. Valentine

The history of Valentine's Day--and the story of its patron saint--is shrouded in mystery. We do know that February has long been celebrated as a month of romance, and that St. Valentine's Day, as we know it today, contains vestiges of both Christian and ancient Roman tradition. But who was Saint Valentine, and how did he become associated with this ancient rite?

The Catholic Church recognizes at least three different saints named Valentine or Valentinus, all of whom were martyred. One legend contends that Valentine was a priest who served during the third century in Rome. When Emperor Claudius II decided that single men made better soldiers than those with wives and families, he outlawed marriage for young men. Valentine, realizing the injustice of the decree, defied Claudius and continued to perform marriages for young lovers in secret. When Valentine's actions were discovered, Claudius ordered that he be put to death.

Other stories suggest that Valentine may have been killed for attempting to help Christians escape harsh Roman prisons, where they were often beaten and tortured. According to one legend, an imprisoned Valentine actually sent the first "valentine" greeting himself after he fell in love with a young girl – possibly his jailor's daughter—who visited him during his confinement. Before his death, it is alleged that he wrote her a letter signed "From your Valentine," an expression that is still in use today. Although the truth behind the Valentine

legends is murky, the stories all emphasize his appeal as a sympathetic, heroic and – most importantly – romantic figure. By the Middle Ages, perhaps thanks to this reputation, Valentine would become one of the most popular saints in England and France.

After viewing the finalists' spots on the Chicago Auto Show's Facebook page, people can cast a vote for their favorite public service announcement. The winner will be announced Friday, Feb. 12 at the Chicago Auto Show and it will be shown on the show's social media video wall throughout the show, which is open to the public from Feb. 13-21. It also will be broadcast later this year on more than 220 TV stations nationwide.

"Distracted driving is a serious risk that needs to be addressed at all levels," said Colin Wickstrom, 2016 Chicago Auto Show chairman. "Today's cars are safer than ever, with many innovations that help avoid crashes and protect occupants in the event of one. However, driver inattention - distraction - continues to be a major factor in crashes. We hope the Drive Safe Chicago campaign engages teens to be messengers, both to their peers and to all drivers that distracted driving is dangerous driving."

The National Highway Traffic Safety Administration estimates more than 3,300 people are killed every year due to distracted driving, and tens of thousands more are injured. The most talked-about causes of distraction are texting and cell phone use, but drivers also can be distracted by use of other mobile devices like GPS, as well as adjusting sound system controls, talking with passengers or even eating.

Last year's winner was Rachel Diaz, a junior at Porter County Career Center in Valparaiso, Ind.

# Planning for Role Reversals with Your Parents

It seems almost every day we read about another medical breakthrough that promises to help people live longer and in some cases healthier lives. Baby Boomers are reaching the ages that their grandparents were when they passed on. Back then it was not all that unusual for an individual to die in their mid-sixties of a sudden heart attack, or complications of diabetes.

Today, with proper medical care a heart condition or diabetes can be managed for years. But the inevitable still happens. And now we see a more gradual deterioration.

It is difficult to see one's parents having a harder and harder time keeping up. Sometimes the changes happen slowly, almost imperceptibly. Other times changes seem to happen overnight.

As caring individuals, children often pitch in to make their parents' lives easier—driving to doctor's appointments, helping to balance a checkbook, etc. It is hard to accept that the parent who took care of you now needs you to take care of them. As time progresses, they may require more help than you can give them. It might be in-home care or a long-term care facility.

None of this is easy, but there are steps that can be taken to make these transitions easier. A well thought out estate plan can anticipate many of the challenges of aging and possible incapacity. If a parent meets with an experienced estate planning attorney they will be offered a number of tools and strategies such as:

**A Revocable Living Trust**—While a parent is capable, they would act as trustee. The child could be named as the successor trustee. If the parent becomes incapacitated the child would then take over as trustee of the trust without any need of involving an expensive and intrusive court procedure. Many a well-meaning child has spent years keeping records of all their parents' expenses for the court. All this aggravation could have been avoided with a well-crafted revocable living trust.

**Advanced Directives**—these allow an individual to make end-of-life decisions in advance. A child or other individual can be appointed as the "agent" who can make healthcare decisions for the "principal" (who in this case is a parent) should the principal become unable to make their own healthcare decisions. After years of practicing law I firmly believe that when a parent tells their child or children what they want at end of life it is a true gift. The soul-searching, second-guessing and guilt are taken out of the decision for the child.

**"HIPAA" Authorization Form**—Refers to the Health Insurance Portability and Accountability Act. This form allows your parents to grant you (and/or others) access to their protected healthcare information. As an attorney I have seen cases where a child is denied information about a parent's condition because of a lack of a properly executed HIPAA form. This can be especially critical if the family wants to have the patient transferred to another facility where care may be better, or if the family suspects malpractice on the part of the health care professional and wants to pursue a second opinion.

**Medicaid Planning**—Unfortunately, the price of long-term nursing home care can be enormous, essentially wiping out the hard earned savings of an individual. While this piece of estate planning may not be appropriate for all, when it is appropriate and is properly drafted and executed, it can protect estate assets while ensuring eligibility for Medicaid when the time comes.

If you take the time now to encourage your parents to consult with an experienced estate planning attorney, I think both you and your parents will enjoy a sense of peace of mind.

Mix: beans and taco seasoning mix. Spread onto bottom of 9-inch pie plate or quiche dish.


