Thinking about joint replacement? Community First Medical Center will offer free joint replacement information sessions Thursdays, March 10th and 24th, from 3:30-4:30 pm in the Community Education room. These free sessions will be conducted by Carleen Nunez, R.N., B.S., N., O.N.C., along with staff from rehabilitation services. Attendees will receive educational materials, get questions answered, learn what to expect from surgery and meet some professional staff. Registration not required.

Spring Forward and Test Your Batteries

Daylight savings time begins on Sunday, March 13, 2016 at 2 a.m. when clocks need to be set forward one hour.

The Skokie Fire Department reminds residents to check and change batteries once a year in all smoke alarms, carbon monoxide detectors and all emergency accessory kits to make sure they are in working condition. Be sure to replace smoke alarms every 10 years for optimal effectiveness and follow the manufacturer's recommendation regarding carbon monoxide detector replacement, as all models vary.

Additionally, all Illinois homeowners and landlords must have carbon monoxide detectors in buildings containing bedrooms and sleeping facilities. All residential units are required to have at least one carbon monoxide alarm within 15 feet of every room used for sleeping purposes.

Mayor Emanuel Expands Resources To Serve Chicago's Veterans

Mayor Rahm Emanuel today launched a new resource website designed to meet the needs of Chicago's military Veterans, and has appointed a new Director to the Chicago Veteran Affairs Office to lead efforts and continue to grow programs and services to help the City's Veterans. In addition, Mayor Emanuel has directed the City's 311 service call center operators to ask callers up front if they are Veterans in order to better direct resources to meet their specialized needs. These investments build on earlier efforts by the City to invest in services to support the needs and employment of Chicago's Veterans.

"We as a City have a responsibility to help our Veterans build a future that is worthy of their sacrifice," said Mayor Emanuel. "While their service can never be fully repaid, we can honor them by providing specialized resources and support for Veterans and their families."

This new website was specifically created to meet the needs of Veterans and active duty members of the Armed Forces, as well as those of their families, and is designed to provide a centralized point of access for services offered by agencies across all levels of government. The website features guidance and information on several service areas, including: Housing, Service and Benefits, Employment, and Emergency Services. The website will also help residents to locate Veterans Resource Centers, Community Service Centers, and Senior Centers for in-person assistance.

To lead coordination efforts, Mayor Emanuel has appointed Victor LaGroon, an

ARMY Veteran, to serve as Director of the new Chicago Veteran Affairs Office. In this role, he will direct City efforts to grow programs and services to help Chicago's Veterans. LaGroon's military career began in 2003 with his enlistment. After completing his Advanced Individual Training at Ft. Huachuca in Military Intelligence, he was assigned to the U.S. Army 10th Mountain Division, Ft. Drum. Since being medically discharged, for the last 10 years, he has worked diligently to serve and advocate for the health needs, benefits and resources of military personnel, Veterans and their families.

"As a Veteran myself, I know how valuable that Veterans services are in supporting those of us who have served our country as they acclimate to life after military service," said Victor LaGroon, Director of the Chicago Office of Veteran Affairs. "In this role, I look forward to advocating on behalf of Chicago's Veterans to ensure that they have the support and resources that they need to re-integrate into society, gain meaningful employment, and support their families."

To ensure that all Veterans and military Service Members are able to secure housing and to prevent discrimination in the housing application process, the City's Council on Human Relations approved the Mayor's ordinance making Veterans, active military personnel, reservists and National Guard members a protected class. Additionally, as a participant in national call to end Veteran's homeless initiative, the City has placed has 1,500 homeless Veterans in secure housing in the first year alone, and has housed approximately 1,800 to date.

Mayor Emanuel, Chicago Park District Announce Spring Park Program Registration Is Now Open

Mayor Emanuel and Chicago Park District General Superintendent and CEO Michael P. Kelly today announced online registration for spring programs is now open, with in-person registration beginning Saturday, February 27. This year, a new social media campaign has been launched to increase program enrollment among teens and young adults. Swim instruction, volleyball, basketball, softball, boxing, boot camp and theater classes are among many of programs available for the upcoming season.

"The Chicago Park District is offering quality classes and activities in neighborhoods throughout the City," said Mayor Emanuel. "It's the best deal in town, and the Park District offers something for everyone - regardless of your age, zip code or income level."

Online registration for spring programming is now open for parks located west of California Avenue, and online registration for parks located east of California Avenue will open tomorrow, February 23 at 9 am.

"There isn't a better time to get active than in the Spring," said Michael P. Kelly, General Superintendent and

CEO. "The Chicago Park District offers thousands of opportunities for families to get fit, explore a new hobby, or learn a life-saving skill such as swimming at an affordable cost."

In-person registration begins either Saturday, February 27 or Monday, February 29 depending upon the park location. No child will be turned away due to inability to pay and financial assistance is available. Spring programs run from the week of March 28 to the week of May 30.

The Chicago Park District continues to build on record registration numbers. Spring registration reached 94,000 last year, a new benchmark from 87,600 in 2014. Overall program enrollment saw a 35 percent increase from 281,041 in 2012 to 379,908 in 2015.

In addition, the Park District is also launching a brand new social media advertising campaign in order to increase awareness of and participation in park programming among teens and in targeted areas that will include contests, sponsored posts and more.

Comcast Business Expands Fiber Optic Network in Chicago's Peterson Pulaski Business and Industrial Corridor

"Comcast's new fiber allows us to leverage our telephone service across our

four Chicago area sites, which results in a significant cost savings," said Janelle Weyers, vice president of Information Technology for MW Industries, Inc., a manufacturer with a facility in the park. Chicago area-based MW Industries is the largest and most diversified specialty spring and fastener manufacturer in the United States. "We used to have to operate our telephone system independently from each site, which created significant financial and administrative burdens.

The new fiber is a significant upgrade from the existing T1 lines and provides more reliable Internet service, Weyers also noted.

"The addition of fiber in this section of the city is part of a larger effort by Comcast Business to expand its footprint and reach more businesses that could benefit from increased bandwidth," said Jay Dirkmaat, regional vice president of Comcast Business. "Increased bandwidth allows businesses to access more and more applications and services in the cloud, accommodate rapidly increasing numbers of employees using mobile devices and exchange large amounts of data."

Dirkmaat added that in the Chicago area, Comcast has proactively built or expanded its fiber optic network in downtown Chicago, as well as business and industrial corridors adjacent to O'Hare and Midway airports; Interstate 88 in the west suburbs and Interstate 90 in the northwest suburbs; and in Elgin and South Elgin. In total, Comcast has about 11,000 miles of fiber in Illinois.





Adler Planetarium Announces New Sky Show Featuring Evidence of a Real Ninth Planet Opening May 28th

The Adler Planetarium is excited to announce the release of their newest sky show set to open on May 28th. The sky show, still to be titled, will explore the largest of Pluto's neighbors in the Kuiper belt and invites visitors to join in the hunt for a new ninth planet.

The observable Universe is more than 90 billion light-years across, and most of it is empty space. For centuries, astronomers have used math and physics to light the way. Decades before Clyde Tombaugh first observed Pluto, astronomers Percival Lowell and William Henry Pickering had predicted the existence of a mysterious Planet X in the same celestial neighborhood.

While Pluto's planetary status has been hotly debated among the general public since the International Astronomical Union demoted (or "reclassified") it as a dwarf planet in 2006, scientists have been exploring the rich class of worlds to which Pluto now belongs: the objects of the Kuiper belt. Their work has led them to consider a surprising possibility: that a true ninth planet, far beyond the orbit of Neptune, has been out there all along.

"We are excited to be releasing our newest sky show, especially in light of news on a potential ninth planet lurking in our solar system," says Mark SubbaRao, Ph.D., astronomer and Director of the Space Visualization Laboratory at the Adler Planetarium.

"After Mike Brown's lecture at the Adler last spring, we decided to collaborate on a sky show. Already in production for months, we were able to get ahead of the curve and give our visitors a glimpse into the very latest science, including the evidence as to why we think another large planet is out there."

Explore these dwarf planets with Mike Brown and his Caltech team in the Adler's new sky show!

Eris— The discovery of Eris prompted the International Astronomical Union to agree on an official definition of "planet" in 2006. Eris is almost exactly the same size as Pluto, yet it weighs 25 percent more. It is also remarkably bright, reflecting 97 percent of the light it receives from the Sun. To put that in perspective, the moon reflects just 12 percent of the Sun's rays.

Haumea— Shaped like a football, Haumea rotates incredibly fast—once every four hours! This object's fast rotation causes its unusual shape. Were it rotating more slowly, gravity would pull it into a sphere, which is why it qualifies as a dwarf planet even though it isn't round.

Sedna— Sedna's orbit takes it deep into the far reaches of the Solar System, almost 20 times as far as Pluto ever goes. A year on Sedna is 11,400 times as long as a year on Earth! But perhaps the most interesting thing about Sedna is the hints it gives us that there are many more objects yet to be found at the edges of our cosmic backyard.



Singer, songwriter and musician Alan Gerber is “Coming Home.” The former Skokie resident brings his live concert tour to Skokie Theater on Saturday, March 19 at 8:00pm, Gerber is now a resident of Val-David, Quebec, but has fond memories of his time in Skokie. He graduated from Niles East H.S. and went on to study music at Roosevelt University. “Chicago and Skokie were where I developed my love for music and my Midwestern work ethic. Gerber has an extensive musical resume that includes working with Bob Dylan, Leon Russell and the Doors’ legendary producer Paul Rothchild. Governor Signs Executive Order Creating the Governor's Cabinet on Children and Youth

Governor Bruce Rauner today signed an Executive Order creating the Governor's Cabinet on Children and Youth (the "Children's Cabinet") to streamline Illinois' education and youth efforts across the state.

"The single most important thing we do as a society is invest in our children's education," Governor Rauner said. "The Children's Cabinet will create a strategic vision for education and health and human services by bringing together all state entities that interact with children into a central unit. It will ensure Illinois children are getting the resources they need and deserve, while expediting true reforms that will transform our education system to ensure a bright future for our students."

The Children's Cabinet will formulate a strategic vision for the education and well-being of children and families across Illinois. That vision will include ideas to increase the efficiency and effectiveness of the State by reducing bureaucracy and ensuring State agencies are aligned in their programming. The Children's Cabinet will work with health and human service providers, early childhood programs, elementary schools, high schools and post-secondary institutions to drive the best outcomes for our students in Illinois.

"The Governor's Cabinet on Children and Youth is systematically addressing the fragmented system that currently exists in Illinois," Secretary of Education Beth Purvis said. "Governor Rauner's new structure will support and integrate the State's priorities and initiatives more effectively to identify and address any agency collaboration barriers so we can more thoughtfully and aggressively improve the future for our children."

In addition, the Children's Cabinet will facilitate strategic partnerships inside State government, as well as with schools and private organizations. Through these partnerships, the cabinet will promote awareness of important issues facing children. In addition, the Children's Cabinet will provide funding and policy recommendations to the General Assembly.

Illinois is the 18th state in the country to create a cabinet like this in the past 20 years. States utilizing a Children's Cabinet have improved coordination and efficiency across state agencies and local governments by mobilizing resources around priorities for education, facilitating a comprehensive approach to serving children and strengthening partnerships with the non-profit and private sectors.

The Governor will serve as Chairman of the Children's Cabinet.

Local Warnings During Inclement Weather Conditions

1. Parents should know where their children are and especially escort them at afternoon dismissal. Be aware of unexpected school closings. Keep your radio on. Carry a flashlight and have extra batteries.
2. Stay off of all lakefront bike paths and beaches. Make sure bikes and cars have their lights on. Walk your bikes on sidewalks.

Life Safety Progress

Most Sheridan Road Condo Associations have complied with the City of Chicago Life Safety Ordinance and their track record is better than that of the rental buildings. An addition to some projects was a requirement by City Inspectors that a battery operated smoke detector be installed in every water heater closet. Most buildings that are required to do so are doing this at no charge to the unit owners. Some new door configurations are also being required. Those associations who began their compliance in a timely manner received some quick inspections and completed the process before additional requirements were added.

"My goal is to ensure that every resident in every neighborhood of Chicago has an opportunity to participate in the future that we are building in Chicago and by working together we can make that goal a reality."

The reforms will be proposed to the City Council this spring and take effect immediately upon passage.

What Happens in My Initial Estate Planning Consultation?

Your initial consultation with an estate planning attorney should be similar to your initial consultation with your physician.

First, you will be asked to provide information about yourself and your family. Are you married? Do you have any children? Did you have previous marriages? Do you have any grandchildren? What are the ages of you and your family?

You will be asked about your assets and their nature and extent. You will be asked about your goals. Who will take care of all kinds of matters when you are unable to do so?

As many patients try to conceal certain information from physicians, some clients try to conceal certain information from attorneys. It is important for the attorney to know the full answer to all questions asked, just as it is important for

the physician to know. The estate planning attorney asks the questions to help anticipate issues that might arise. For example, you may be reluctant to discuss a child you had fathered out of wedlock years ago. If you do not want that child to benefit from your estate, you should disinherit that child. A child simply omitted may be entitled to what they would have gotten had you died without a Will or Trust.

An estate planning attorney's role is to help you realize your goals and dreams while guarding against life's risks. For example, let's say you want to leave assets to your child with special needs. The estate planning attorney can draft the trust so that those assets will be available for your child's benefit, rather than being taken to pay or reimburse governmental agencies for benefits for which he or she is eligible.

The estate planning attorney will go over your goals with you and plot a course to achieve that goal. After you agree on the strategies involved, the estate planning attorney will draft the documents and directions to effectuate those strategies. For example, the attorney may draft a power of attorney to designate who will be your agent to make financial or health care decisions when you are unable to make them for yourself. The attorney may draft a deed placing title to your home into your revocable living trust so that it will not be subject to probate on the death of the survivor of you and your spouse.

The estate planning attorney and the physician are educated professionals who are there to help you achieve your goals, whatever those might be. When you leave the attorney's office, you should have an understanding of what the general plan is to achieve your goal and what steps will be taken next and by whom.

How do you choose an estate planning attorney? A recent segment on a CNN financial news cable network indicated that one of the most important factors to consider is your comfort level with the attorney and whether the attorney meets stringent continuing education requirements. Organizations such as the American Academy of Estate Planning Attorneys (www.aepa.com) impose stringent continuing education requirements, so you might want to start your search for an attorney at their website.

Once you have chosen an estate planning attorney and have had the initial consultation, you will know you made the right choice by the sigh of relief and satisfaction as you leave the attorney's office..



Growing Summer Savings in the Garden

Have you ever thought about growing your own fruits and vegetables at home? For experienced gardeners, the cold months are when their imaginations get fired up; seed catalogs seem to blow in with the arctic blast, accompanied by companion mailings from gardening accessories and equipment retailers. But where can amateurs start?

To maintain a garden as a legitimate financial alternative to store-bought food, it's important to understand the underlying costs involved. Some gardeners spend substantial bucks on fancy tools, equipment, gardening clothes, deluxe fertilizers or supplies, which sounds counter-intuitive to a money-saving alternative. Investing in home gardening requires frugal spending and a desire to learn – very few people wipe out their entire produce bill without a little preparation, knowledge and most important, trial and error.

There are plenty of studies (<http://www.garden.org/>) on how much people are investing in home- and community-based gardens, but very few reliable guidelines on how much money you can actually save by gardening. That's because it's tough to generalize results based on geography, climate and skill sets.

Nevertheless, if you still want to get your hands dirty, here are some general steps to take before you dig in:

Harvest as much local gardening knowledge as you can. The word "local" is very important. Planning a home-based edible garden in a sunny West Coast backyard is very different than planting a series of clay pots on a Midwestern terrace. Start with a close look at your climate and growing conditions before buying anything.

Plant only what you'll eat. If you want a salad garden, stick to lettuce that can be planted and harvested repeatedly in one season. Maybe you'll also want to plant a tomato plant or two. If you generally buy a lot of a particular vegetable, try and grow that first. The more you want to eat the food you're planting, the more interest you'll take in making it a success.

Keep your first effort as inexpensive as possible. Generally, the cheapest way to grow plants is from seed you start growing indoors. Some people have special lights and shelving for indoor seed starting, but if you're planning on only a few plants, it's best to start modestly. Consult experts about the most effective and frugal way to start your desired plants from seed at home and set a growing schedule that culminates in actual planting outdoor. Sometimes it's better to stick with a few borrowed or garage sale hand tools and recycled containers that will work just fine for seeding and drainage.

Keep learning as you go. When you start gardening, even if it's only a pot or two where you're growing from seed, start an annual garden journal that details what you've purchased (with prices), what's worked well and all questions and answers you've gathered along the way. You might even discover new plants you'd like to grow next year. Re-reading your journal before you start your gardening planning in winter is a great way to shape your growing and cooking priorities for the coming year.

Bottom line: Homegrown food usually tastes better for two reasons – it's fresher than anything you can buy and you have the pride of growing it yourself. However, making an economical home garden takes know-how, knowledge and as minimal initial investment as possible.

Broiled Salmon Fillets (Moroccan style)

3 to 4 salmon fillets	2 tablespoons fresh chopped parsley
4 tablespoons of olive oil	1/2 stick of butter, melted
3 garlic cloves - crushed	2 tsp. paprika
1/4 tsp. of cayenne pepper	1 tablespoon of cumino
juice of 1/2 lemon	

Arrange the fillets in a baking dish and place them under a very hot broiler. Cook, with the broiler door open for 3 to 5 minutes or until golden brown. Melt the butter, add oil and all the remaining ingredients, mix them all well, and pour over the salmon. Continue to broil for additional few minutes till a nice crisp on the top of this dish. Sprinkle with fresh lemon juice. Serve immediately with quartered lemon, if desired.

Baked Scallops

1 quart scallops	1 green pepper, chopped fine
1 1/2 cups fine bread crumbs	1/2 teaspoon dry mustard
1/4 teaspoon black pepper	1 teaspoon Worcestershire
Dash of tabasco	1/4 cup melted butter

Mix the green pepper, bread crumbs, mustard and pepper, Worcestershire and tabasco. Roll the scallops in the melted fat and then in crumb mixture until well coated. Put in greased baking dish large enough so that scallops are not more than three deep. dot with butter and bake in 350 degree oven for 30 minutes. Garnish with thin slices of lemon and little parsley. Serves 6.


